When you receive it, please do your normal AI to put it back in service and advise that particular BTO to mentally notate his movements the next time he uses the Intox, such as whether or not he moves the breath tube, is the instrument coming back on from standby mode, etc. If he receives another Temp Reg Fail, we'll have to investigate further as to why he receives them and no one else seems to.
