REALLY CLOSE! The only thing I would note would be that on the one instrument, the interferent detect test didn't pass (it didn't get a chance to run so that would be a NO) and the Post-Diagnostic didn't run either so it would also be NO). On the one which stopped at the 0.05 - I don't expect you to remember the values so yes, leave those blank, but I would indicate that the Post-Diagnostic did not run so that column would be a NO and the values on the water were 0.00 for all 3 lines (assuming that was in fact the case and since you said all values were within, that would tell me those lines should say 0.00.) The interferent would have run prior to the 0.05 running so that line on the 3347 instrument is correct with the Yes. Make sense?
