Instrument 814 and 5249 were not inspected due to both of them being at CMI for servicing. Per CMI, our instruments were scheduled to be looked at on 5/19/2017. Per CMI on June 6th, they have begun maintenance on 5249 and 814 is scheduled to be repaired at the end of July. As of 09/18, the instruments are still being serviced. Once both instruments have been serviced, they will be sent to FDLE for their annual inspection. Upon receipt of our instruments back in Hernando, 812 will be sent to FDLE for its annual inspection and 228 will be returned to FDLE.

Instrument 228 is an Evidential Loaner instrument that we have received from FDLE while 814 and 5249 are being serviced.

Attached are the March 2017 Agency Inspections for the Hernando County Sheriff's Office.

Instrument 814 and 5249 were not inspected due to both of them being at CMI for servicing.

Instrument 228 is an Evidential Loaner instrument that we have received from FDLE while 814 and 5249 are being serviced.

Instrument 812 and 228 were initially inspected on 03/15/2017. Both instruments passed inspections but were subject to RFI detects. During the month of March, we were having a large sliding door replaced in our Booking department. There were some malfunctions during the installation process that delayed the installation. Once the installation was completed, I ran 20 stability checks through each instruments with a .20% Alcohol Reference Solution. There were no RFI detect errors during the stability checks. Additionally, there have not been any RFI detects since the installation of the sliding door was completed.

Sgt. Stevens has received formal quotes for the installation of panels that will assist in blocking any radio frequency interference from the Breath Test Unit.

I conducted an additional agency inspection this evening and both instruments passed without any discrepancies. I have attached the initial agency inspection from 03/15/2017, the stability checks for both instruments, and the agency inspection from 03/26/2017.

Good Evening,

Attached are the January 2017 Agency Inspections for Hernando County Sheriff's Office Instruments 812, 814 and 5249.

Instrument 812 did have an RFI detect error during the Interferent Detect Test. This was due to a cell phone being in the Booking Department in the area of the instrument while the inspection was being conducted. There were no additional RFI detects during the remaining two instrument inspections and Instrument 812 passed inspection with no issues.

Instrument 814 had an EEPROM failure during the diagnostic while the instrument was coming into "READY" mode. An additional diagnostic was ran and the EEPROM check passed. Arrangements have been made with our Departmental Inspector at FDLE to send this instrument back next week after we receive an Evidentiary Loaner device from FDLE.

Instrument 5249 had an Ambient failure and a Purge failure. Believing that this was caused by an odor in the Breath Test Room, I turned on a fan to circulate the air in the room for approximately one hour. I attempted to conduct a second inspection, at which time, the instrument had an additional Ambient failure. It should be noted that the other two instruments were inspected first and did not have any issues in regards to the ambient air in the room. Per our Departmental Inspector, this instrument is being sent back to FDLE on Friday 1/20/2017 for further diagnosis.
