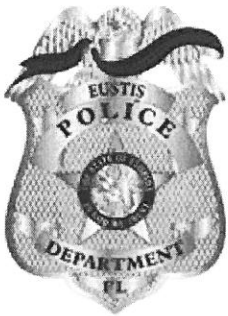

Good morning Danielle,

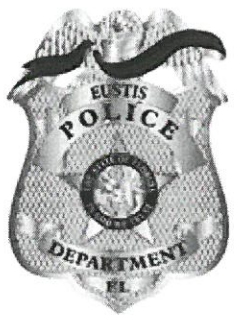
