Good morning,

The comments on the first two inspections (at 0040 and 0116 hours) look good but I do need a remark added to the last inspection since the Alcohol Free/Mouth Alcohol Test appears like it needed to be repeated before passing. Only a small amount of mouth alcohol is needed for that part of the test... just enough to coat the tip of your tongue in my experience. Swish it around, spit it out, and then provide a breath within a few moments afterward.

There are alternate numbers I can provide if needed, but what's currently programmed into the instrument is the best number to use for uploading. Like I mentioned earlier on the phone, try to upload again this morning (other agencies have been successful) and if you still aren't having any success after 15-20 minutes, give me a call and I can try to do a remote-upload.

Good morning Taylor,

We finally received all necessary equipment and I completed the first inspection. Unfortunately I ran into some issues with the mouth alcohol testing, due to human error. Please see attached inspection reports, and explanations below.

For Inspection of 80-001177 on 01/24/22 at 0040 hours I did not use mouth alcohol for the second sample provided. My error in testing, I believed I had to provide 3 samples of alcohol free breath when that instruction was for the alcohol free simulator. I corrected this by only providing one alcohol free sample before using the mouth alcohol for the second sample.

For Inspection of 80-001177 on 01/24/22 at 0116 hours, there was still mouth alcohol present and

provided a result of 0.030 instead of 0.000. I corrected this by allowing more time for the residual mouth alcohol to dissipate before beginning a new inspection test.

For Inspection of 80-001177 on 01/24/22 at 0150 hours, all checked out appropriately.

When attempting to upload the inspection reports the instrument continues state it is busy using the predefined number programmed. Is there another number I can use to submit our reports or a way to circumvent this and get us online. Thank you for your assistance.
