I got to the interferent and nothing happened the first time around (no tone) so I realized what I had done and then put 8mil in the interferent simulator and waited a half house then repeated that section since it was still asking me to repeat.

Now since I then knew what had happened I proceeded without issue and completed the inspection successfully on both instruments,

So 007507 had a repeated interferent test and 007505 was completely started over. I wrote on the instruments 40 form what the issue was. Both form 40s have copies in an envelope for you in 007505 that
