## *Overview*

# History



- No formalized programs in the law enforcement community in Florida that offer enhanced training on techniques and innovations in law enforcement analysis
- Goal of creating the Florida Law Enforcement Analyst Academy was to establish and provide a uniform training curriculum for the field of law enforcement intelligence analysis
- Enhance the field of law enforcement analysis by providing analysts with specialized skills needed to provide law enforcement and other emergency responders with the information and intelligence needed to successfully prevent crime and conduct complex investigations
- Establishment of this analyst academy confirms a career path in investigations for non-sworn personnel in law enforcement

# Where We Are...



- To date, 31 academies have been delivered and over 720 students have graduated to become certified law enforcement analysts in Florida
- The Charter Class began in June 2003 and Class 31 finished September 2020
- About 100 different agencies have been represented since inception – Including 1 in SC, 1 in NJ, and 2 in NC

# Definition



*“Law Enforcement Analyst”* means any person who is employed or contracted by any municipality or the state or any political subdivision thereof; whose primary responsibility is to collect, analyze and disseminate data to support, enhance, and direct law enforcement missions. Their efforts are directed at identifying criminal subjects, organizations, activities, events and/or forecasting future crime occurrences utilizing analytical techniques. This definition includes all law enforcement analysts who provide strategic, operational, investigative, intelligence and crime analysis.

# Academy Curriculum



The curriculum covers a wide range of topics, all inclusive of the many law enforcement analyst functions including crime analysis, intelligence analysis, investigative analysis, and administrative/management/statistical analysis.

The academy is divided into six week-long units delivered over the course of six months.

# Week #6

## Final Exam

*Students will complete a cumulative final exam covering topics from weeks #1 through #5*

## Strategic Assessment Briefings – Practice and Final Presentation

*Students will practice and then deliver a formal briefing before a panel of senior law enforcement analysts and sworn members. Briefings are between 12 and 20 minutes in length and are intended to present the students' findings, recommendations and conclusions of their Strategic Assessment assignment*

## Award of Certificates and Graduation

*Students will be awarded designation as a Florida-Certified Law Enforcement Analyst upon successful completion of all requirements of the Analyst Academy*

# Grading Process



- All grading criteria and processes are based on a scale of 1 to 100
- Students will need 80 points to pass the overall certification process
- Any student who does not achieve 80 points or above overall, will be given an opportunity to re-take the final examination. This opportunity is contingent upon the possibility of an 80% overall grade with the retake.

# Grading Process



- The following is a breakdown of how the final grade will be determined:
  - 20%      *Quizzes*
  - 20%      *Assignments*
  - 25%      *Strategic Assessment*
  - 15%      *Individual Presentation*
  - 20%      *Final Examination*
