# **OPENING REMARKS BY THE CHAIRMAN**

## CJJIS Council Chairman – Daryl McLaughlin – Addressed:

The CJNet Strategic View. CJNet - Major vehicle for exchange of information. The need to articulate CJNet use/goals to the Legislature. CJJIS Council needs to determine the needs of each discipline in the criminal Justice Community (Pawn Broker Example.) At theJune 6<sup>th</sup> CJNet planning session – present ideas in a working group session and incorporate into the CJJIS Council Strategic Plan.

Mr. Jerry Brown – Indicated that Santa Rosa county is still in process of getting CJNet.

Mr. Daryl McLaughlin – Committed to getting them resources needed to get them operational.

Sheriff Lawrence Crow – Very interested in where we are headed and will help define Sheriffs Offices goals/needs.

Mr. Daryl McLaughlin – Reminded CJJIS Council Members that some ideas may be policy issues.

## **DISCUSSION OF CJNet PACKAGE**

CJNet Package – Mailed to each CJJIS Council member and includes a plan of attack, Statement of Need form (with example), questionnaire and current CJNet applications/information.

CJJIS Council Members work with constituencies (prior to June CJNet planning sessions/CJJIS Council meeting) addressing:

Questionnaire: Use as a survey. Beneficial when identifying CJNet needs/priority.

Applications (SON): To ensure consistency by all groups. Statements of Need should be what can be reasonably addressed in the planning window for the strategic plan (the next 2 years).

FDLE will offer staff to help Council members set up video-conferencing, teleconferencing, etc. and provide technical assistance.
