New Professionalism Director Hits the Ground Running

As the new year unfolded, the Professionalism Program welcomed a familiar face as director. In late December 2011, FDLE Commissioner Bailey named Jennifer “Cookie” Pritt to lead the program.

Director Pritt has 20 years of law enforcement experience including assignments to operational, administrative and managerial posts. She began her law enforcement career as a police officer with the University of Florida Police Department, later serving as an investigator with the Office of the State Attorney, 8th Circuit. Her experience with FDLE began in 1999 as a special agent within the Office of Executive Investigations where she conducted public corruption and major fraud investigations. She moved into the field of drug intelligence in 2001, and assisted in the coordination of cases handled by Florida’s Violent Crime and Drug Control Council.

In 2003, Director Pritt became a special agent supervisor coordinating the efforts of the Financial Crimes Analysis Center, Research and Analysis Unit, and a unit of agents working in major drugs, violent crime and economic crime intelligence. In 2007, she was promoted to assistant special agent in charge and served as the director of the Florida Fusion Center.

Director Pritt left FDLE in May 2010 to work as a senior research associate at the Institute for Intergovernmental Research, leading projects and training associated with the Nationwide Suspicious Activity Reporting Initiative, the Fusion Center Technical Assistance Program, and the National Criminal Intelligence Resource Center.



Given her vast and varied experience in law enforcement, it comes as no surprise that Director Pritt was able to hit the ground running as head of the Professionalism Program. The FDLE Criminal Justice Professionalism Program provides staff support to the Criminal Justice Standards and Training Commission (CJSTC), the Florida Medical Examiners Commission (MEC), the Commission for Florida Law Enforcement Accreditation (CFA), and the Florida Corrections Accreditation Commission. During her short tenure, Director Pritt has already participated in quarterly meetings of the CJSTC (January 31-February 2) and the MEC (February 24), and attended the spring conference of the CFA/FCAC (February 20-24).

Director Pritt is a graduate of the University of Florida with a Bachelor of Science in criminology and law, and a Master of Science in political science and public administration. She is a graduate of the FDLE Foundational Leadership Program and will attend the next Chief Executive Seminar training program offered by the Florida Criminal Justice Executive Institute.

Professionalism Program Staff News



Kristi Gordon promoted to chief of Professional Development

FDLE Commissioner Bailey announced the promotion of FDLE spokesperson Kristi Gordon to serve as the new bureau chief of the Bureau of Professional Development in early February.

Chief Gordon began her career with FDLE in 1998 as an intern in the Office of Executive Investigations. Since then, she has served in a variety of analytical positions with the Office of Statewide Intelligence and the Office of Executive Investigations, and as the supervisor over the Counter Terrorism Intelligence Center and the Florida Investigative Support Center.

As bureau chief of Professional Development, Ms. Gordon serves as executive director of the Florida Criminal Justice Executive Institute and oversees the Law Enforcement Analyst Academy and the Commission for Florida Accreditation.

Lori Mizell named executive director of CFA

The Commission for Florida Law Enforcement Accreditation (CFA) welcomed a new executive director on June 30, 2011, when Lori Mizell was formally confirmed at a Commission meeting in Bonita Springs. As the executive director, Ms. Mizell is responsible for the supervision and management of all aspects of the accreditation process, working collaboratively with the Commission and Florida's local law enforcement agencies. Director Mizell reports jointly to the FDLE Bureau of Professional Development and the full CFA.

Director Mizell has been a member of FDLE for almost 12 years. She served as the statewide coordinator of FDLE's Analyst Training Program prior to her promotion to executive director. Since joining FDLE in 1999 as a research and training specialist in the FDLE Leadership Center, she has served in other capacities including leading the agency's Counter Terrorism Intelligence Center, and handling domestic security initiatives and projects.

Director Mizell is a graduate of FDLE's Law Enforcement Analyst Academy and is an instructor certified through the Criminal Justice Standards and Training Commission.

Florida Accreditation Office names new program manager

Danielle Desilet is the newest staff member of the Commission for Florida Law Enforcement Accreditation; she is responsible for assisting agencies in the South Florida Region. Ms. Desilet has been a member of FDLE since 1997, and most recently served as a government analyst in the Florida Criminal Justice Executive Institute (FCJIEI).

As an analyst in the FCJIEI, Ms. Desilet was the program administrator for the Chief Executive Seminar and the Executive Leadership Seminar, and was a research mentor for the Senior Leadership Program and the Executive Future Studies Program. Prior to joining the FCJIEI, she was the communication coordinator for FDLE's Alcohol Testing Program.

Ms. Desilet is an instructor certified through the Criminal Justice Standards and Training Commission.



Basic Abilities Test Update

Over the past 14 months, Exam Section staff has worked on developing a new Basic Abilities Test (BAT). The test development process can be roughly broken down into four phases: planning, writing, validation, and form building.

In the planning phase, staff members outlined applicable standards in the testing industry and developed plans for meeting each standard. During the planning stage, staff also reviewed research in the cognitive abilities field. The research review was guided by the comprehensive job analyses of correctional and law enforcement officers that Section staff undertook previously. As a result of the research review and job analyses, six basic abilities were chosen for the new BAT: written comprehension, written expression, inductive reasoning, deductive reasoning, mathematics, and memory.

During the writing phase, staff developed specifications for writing questions for the different abilities and authored over 900 initial test questions. Once written, test questions were validated using a multi-pronged approach including consulting with subject matter experts as well as administering the questions to basic recruit students. Scores on the different ability measures were then compared with scores on both theoretically related and unrelated tests. The results were as expected, indicating the BAT is an accurate measure of the chosen abilities. The ability scores will also be measured against scores on the State Officer Certification Exam (SOCE). The validation efforts will continue throughout the life of the test.

In the form building phase, the developers will choose questions for inclusion on test forms, or versions of the test. Each ability will have the same number of questions, but the questions are chosen carefully, using mathematical formulas to maximize validity and consistency. During this phase, cut scores - or passing scores - will also be established. The cut scores are set using a combination of subject matter expert judgments and mathematical/statistical principles to ensure fair and equitable cut scores.

The implementation plan for the BAT is dependent on the rollout of computer-based testing (CBT). The SOCE will be the first exam program to go live on the CBT platform, followed by the BAT. Upon implementation, FDLE staff will also seek to make the ability breakdown scores available via ATMS. Although the timelines are not yet clear, the new BAT will not be implemented prior to November, 2012.

Some of the benefits of the new BAT include:

- A single standard for each discipline
- Results will be available in ATMS shortly after test completion
- A paperless process for hiring agencies and training centers
- Ability breakdown scores available in ATMS

Law Enforcement Officer Response to Returning Veterans

Since October 2001, approximately 1.6 million members of the armed services have served in Iraq or Afghanistan. These individuals are currently returning to the U.S. in large numbers, joining veterans from other conflicts such as the Korean Conflict and the Vietnam War. Faced with the difficulty of transitioning back to civilian life, they pose challenges to criminal justice agencies - in the work place and on the streets.

Florida is among six states that account for 36 percent of the total veteran population. The other states are California, Texas, Pennsylvania, New York, and Ohio. Many of our returning veterans continue to be homeless, and female veterans are the fastest growing population of the new homeless. Veterans have advanced training in weapons and military tactics and many return with various physiological and psychological problems. As a law enforcement agency, are you and your officers aware of the challenges and prepared to deal with them?

In May 2012, the Criminal Justice Standards and Training Commission will consider for approval a new post basic course to be used by local agencies and training schools to prepare officers to respond to returning veterans. This course is designed to provide criminal justice officers with an understanding of unique issues when dealing with veterans, active duty military personnel, or reserve members, and develop enhanced skills for de-escalating potentially volatile situations while working toward a successful resolution.

Agencies will be notified once the Commission approves the new specialized course. The course will be available to Commission-certified training schools for instruction as a specialized course and to agencies for in-service training. The subject matter experts who developed this course have recommended that instructors for this course have experience serving or working in the military and have an understanding of military culture and lifestyle. Knowledge about veterans' affairs is also beneficial for persons instructing this course. Agencies and training schools are encouraged to identify their instructors now and prepare to deliver this course when it is made available.

One Hundred and Four Graduate from Executive Institute Training Programs

The Florida Criminal Justice Executive Institute offers several leadership programs to Florida's criminal justice community. Class 17 of the Florida Leadership Academy (FLA) graduated on October 21, 2011, and FLA Class 20 graduated on November 18, 2011. A combined 57 criminal justice first line supervisors representing agencies around the state made up these graduating classes. Additionally, the Florida Law Enforcement Analyst Academy (FLEAA) graduated Class 17 on December 15, 2011. The 17 graduates were state and local law enforcement crime intelligence analysts from across Florida.

The FLA prepares first line supervisors in criminal justice organizations to exemplify the character and integrity expected of criminal justice professionals, and examines the various components necessary to be an effective leader. Participants in the FLA learn skills necessary to support the needs of their agency and needs within the community.

In 2003, FDLE developed the FLEAA. This academy is the first of its kind in the nation. Analysts learn criminal and intelligence analysis skills that are used by law enforcement and other emergency responders to successfully prevent crime and conduct complex investigations, as well as a variety of other complex analytical skills. The academy is a six-week program, delivered during one week each month over a six-month period.

The Florida Criminal Justice Executive Institute, established within the Florida Department of Law Enforcement and affiliated with the State University System, was established in 1990 by the Florida Legislature which recognized the need for an innovative and multifaceted approach to the education and training of criminal justice professionals.

SECURITY REQUIREMENTS

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures have been implemented. Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number. If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency's Criminal Justice Customer Service Specialist for assistance.



MANDATORY RETRAINING FOR 2012

19,413 officers are required to complete mandatory retraining by June 30, 2012. As of January 31, 2012, the number of officers who have met the required training for Fiscal Year 2011-2012 is 8,837.



Officers who do not complete the required mandatory retraining on or before June 30, 2012 will be ineligible to perform the duties of a criminal justice officer until the requirements are met. The officer will be separated in ATMS effective July 1, 2012.

Florida Accreditation Office Holds Spring Conference

The Florida Accreditation spring conference was held February 20 – 24, 2012 at the Mission Inn Resort in Howey-in-the-Hills.

The Florida Corrections Accreditation Commission, Inc. (FCAC) met on February 21, 2012, to review agencies for accredited status and conduct general business. Six agencies were reaccredited by the Commission at this meeting: Brevard County Sheriff's Office, Hillsborough County Sheriff's Office, Lake County Sheriff's Office, Leon County Sheriff's Office, Manatee County Sheriff's Office and St. Lucie County Sheriff's Office.

The Commission for Florida Law Enforcement Accreditation, Inc. (CFA) met on February 23, 2012, to review agencies for accredited status and conduct general business. The main order of business was to acknowledge the professionalism of agencies through granting accreditation. The Palm Beach County Office of the Inspector General and the Walton County Sheriff's Office were awarded initial accreditation.

Thirteen agencies were accredited at this meeting: Alachua County Sheriff's Office, Boca Raton Police Services Department, Brevard County Sheriff's Office, Fish and Wildlife Conservation Commission, Hillsborough County Sheriff's Office, Indian River Shores Public Safety Department, Key Biscayne Police Department, Leon County Sheriff's Office, North Port Police Department, Palatka Police Department, Sarasota Police Department, Sunrise Police Department and Volusia County Division of Beach Safety.

The Florida Accreditation Office offered several opportunities for training at the conference. We continue to serve the training needs of our clients as training is offered across the state. Accreditation Manager training and New Assessor Orientation will be offered in Tallahassee in March and April respectively.
