Guidance regarding Use of the Exemption from Training, form CJSTC-76

Effective July 1, 2021, the Criminal Justice Standards and Training Commission (CJSTC) approved revision of the Florida Law Enforcement Basic Recruit Training Program. Some schools have requested guidance for applying the Exemption from Training, form CJSTC-76, to the new curriculum. The checklist on the bottom of page one on the form is based on topics rather than course titles, so the form will not be updated at this time. Please use the attached table as reference when determining whether an applicant has received equivalent training outside of Florida.
