SUBJECT: Misuse of Electronic Databases

In 2021, the Florida Legislature passed Senate Bill 890, creating s. 943.17191, F.S., which directs the Commission to require by rule that each law enforcement officer receive instruction on the proper use and use limitations of electronic databases in the officer's official capacity and the penalties associated with the misuse of such electronic databases. Each law enforcement officer must complete this training every four years as part of the 40 hours of instruction for continued employment or appointment as an officer. This requirement is effective for mandatory retraining cycles ending June 30, 2022, and all subsequent cycles. The "Mandatory Retraining – Matrix of Requirements" is attached for reference.

The Automated Training Management System (ATMS) has been programmed to allow agency users to document completion of the training when an officer's mandatory retraining is updated. The training is documented under the "Certification" tab for each officer within ATMS. Once an officer has completed all mandatory retraining – including the new "Misuse of Electronic Databases" course – agency users should check the appropriate box in ATMS to attest that the required training has been completed.

At the November 2021 meeting, the Commission approved a 1-hour Misuse of Electronic Databases (course #1414), effective November 4, 2021. Officers are not required to complete the Commission course; however, agencies must ensure that the topic areas outlined in the statute are covered. Officers may access the course through this link:

An LE officer's continuing education in the area of Human Diversity shall include training on high-risk and critical tasks that include stops, use of force and domination, and other areas of interaction between officers and members of diverse populations. CJSTC Rules establish that certified law enforcement officers who instruct Discriminatory Profiling and Professional Traffic Stops training may substitute completion or instruction of this training to satisfy the officer's continuing training requirement.		
8	Misuse of Electronic Databases (LE only)	s. 943.17191, F.S. 11B-27.00212(5)(e), F.A.C. (Rule pending promulgation)	There is no specified curriculum or course hour requirement. An LE officer's continuing education in the use of electronic databases shall include training on the authorized access to and use of personal identification information contained in electronic databases including the proper use and limitations on use of electronic databases and the penalties associated with the misuse of electronic databases.
