SUBJECT: First Aid Instructional Videos

CJSTC staff worked with subject matter experts to film 30 instructional videos designed to help

first aid instructors teach the various patient assessments, maneuvers, drags, and carries; and wound treatment techniques to basic recruit and instructor students. The videos cover all mandatory and some suggested activities from the 2023 basic recruit training (BRT) high liability instructor guide.

First Aid Videos

Effective immediately, first aid instructors will refer to the videos when teaching the First Aid Instructor course, #1114 (version 2023.02) and the First Aid for Criminal Justice Officers course, (version 2023.07). Current instructors who need to take the online First Aid Instructor Update course, #1419, will also need to refer to the videos.
