Governor

Commission

Recently, Governor Ron DeSantis announced the appointment and reappointment of individuals to the Criminal Justice Standards and Training Commission. The Commission is composed of 19 members, representing criminal justice professionals throughout the state, and was created to oversee the certification, employment, training, maintenance of officer records and conduct of Florida law enforcement, correctional and correctional probation officers. The Commission meets quarterly "to ensure that the citizens of the state of Florida are served by the most qualified, well-trained, competent and ethical criminal justice officers in the nation."

Michael Allen is the Chief of Detention for the Polk County Sheriff's Office and a Commission-certified instructor. He is reappointed for a term beginning September 25, 2020, and ending August 1, 2023. He was initially appointed to fill a vacant seat for a partial term beginning July 8, 2015, and ending August 1, 2015; he was reappointed by the Governor to serve a full-term beginning August 21, 2015, and ending August 1, 2019. He served in and received an honorable discharge from

the United States Navy. Over the last five years, Commissioner Allen has been an invaluable member of the Commission and we look forward to working with him for another four-year term.

Michael Adkinson Jr. is the Sheriff of Walton County. He previously served as Chief of Police for the DeFuniak Springs Police Department and as an officer with the Tallahassee Police Department. Commissioner Adkinson currently serves on the Board of Directors for the National Sheriffs' Association. He is appointed for a term beginning September 25, 2020, and ending August 1, 2024. Sheriff Adkinson will succeed St. Johns County Sheriff David B. Shoar.

Melanie Bevan is the Chief of Police for the Bradenton Police Department. Previously, she spent 29 years with the St. Petersburg Police Department, rising to the position of Assistant Chief of Police. Commissioner Bevan fills a seat previously held by Chief Sean Hemingway of the Bay Harbor Islands Police Department. The Governor appointed her to serve a term beginning on September 25, 2020, and ending on August 1, 2023.

LEADERSHIP CHANGES

atFDLE

Over the past few months, there have been several changes within FDLE's leadership structure that have led to promotions for individuals who have worked closely with the Professionalism division over the course of their careers.



On June 24, 2020, Governor DeSantis appointed FDLE General Counsel Jason Jones as a judge in Leon County. Judge Jones had served as FDLE General Counsel since 2015, and had been regional legal advisor for the FDLE Tallahassee and Pensacola Regional Operations Centers.

In September, Assistant Commissioner Jennifer "Cookie" Pritt announced that she will be retiring in February after more than 20 years with FDLE. Upon leaving FDLE, she will become the Deputy Executive Director of the Florida Police Chiefs Association, one of Professionalism's closest partners.

Commissioner Rick Swearingen appointed James Martin as FDLE General Counsel, where he will oversee the duties of the Office of General Counsel, which provides legal assistance and advice to the department. General Counsel Martin began his FDLE career in 1998 as a CJSTC professional compliance attorney, and was named deputy general counsel in 2016.

Commissioner Swearingen also appointed Michelle Pyle as FDLE Assistant Commission of Public Safety Services. In this role, she will provide overall management and policy direction for public safety services, overseeing the Business Support, Criminal Justice Information Services, Information Technology and Professionalism divisions. Assistant Commissioner Pyle has been a strong advocate for the Criminal Justice Standards and Training trust fund and its issues over the years.

Commissioner Swearingen appointed Ron Draa as Chief of Staff (COS). In this new role, COS Draa will continue to provide oversight to the Office of External Affairs, and will assume the management of all FDLE legislative activities and the FDLE strategic planning unit. COS Draa has led many legislative initiatives tied to the Professionalism division in his previous role.

Finally, Commission Swearingen appointed Sharon Wester as the Director of the Business Support Program. Director Wester will have overall policy and management responsibilities for FDLE's business functions, which include the offices of Budget Management and Policy Planning, Criminal Justice Grants, Financial Management, General Services and Human Resources. Director Wester is well versed in the needs of Professionalism and will continue to advocate on behalf of the division and the trust fund.

Decertification Index

Since 2001, the International Association of Directors of Law Enforcement Standards and Training (IADLEST) has maintained the National Decertification Index (NDI). The NDI is a national registry of certification or license revocation actions relating to officer misconduct. The records contained in the NDI are provided by participating agencies and include the name of the subject officer, action against the certification and contact information related to the certifying organization. The NDI currently contains 28,489 actions reported by 45 certifying organizations. FDLE has served as Florida's NDI representative since 2001 and adds each instance of the Commission revoking an officer's certification or accepting an officer's relinquished certification. As of July 2020, 10,204 Florida revocations and relinquishments have been added to the NDI.

The NDI can serve as a valuable tool when assessing the suitability of criminal justice applicants. Agency administrators may be alerted to previous disciplinary issues prior to making a hiring decision. Administrators may also learn if an applicant does not meet the Commission's minimum qualifications for certification. It is important to note that an officer's inclusion in the NDI does not necessarily preclude them from appointment as an officer in Florida.

Access to the database is available at no charge to vetted law enforcement officers, background investigators and support staff. Agencies interested in access must submit a request through the NDI website at https://www.iadlest.org/our-services/ndi/about-ndi. Once on the website, select "Request Access to the NDI" button and provide the requested information. FDLE will be notified automatically to review and approve the request. Please note: approval of the agency administrator must be obtained by the individual making the request for access. Florida has 480 registered NDI users.




Post-basic CJSTC **DE-ESCALATION**Training

Due to recent discussions of police reform and requests received for additional training, Commission staff has started development on a specialized course focused solely on de-escalation.

Staff has reviewed the established literature and current trainings being delivered around the nation to ensure that this course will contain evidence-based instruction on de-escalation techniques, as well as survey data compiled from Florida. Staff is currently drafting content and establishing a timeframe to host workshops. The plan is to incorporate practical scenarios in the course, giving students an opportunity to practice the techniques they learn. The goal is to take the course to the Commission for approval in February 2021, pending the availability of SMEs for required workshops.

Being Flexible – Instructor Techniques

During the second week of March 2020, as news of the coronavirus began to spread widely, the Florida Department of Law Enforcement (FDLE) training center was hosting the first half of a two-week General Instructor Techniques course. The small group of 12 students had just completed week one of the course and were ready to work on their presentations before returning for the last week of instruction and presentations scheduled in late March.

Unfortunately, due to the virus the class would be unable to return to complete the course until mid-July. Through the use of technology, students attended class remotely for two days to receive the remaining instruction. With the help of the FDLE Media Center, the remainder of the course was dedicated to individual presentations where the members instructed in the classroom while video was streamed to the other participants. Through technology, all of the students and the instructor were able to see and hear each other, as well as ask questions and give critiques.

Part of being a good instructor requires one to be flexible and adjust to unexpected circumstances. The students in this class learned that important lesson firsthand while using technology to bridge the gap caused by the virus.

Florida Police Chiefs Association's Use of Force Policy Recommendations

On September 3, 2020, the Florida Police Chiefs Association (FPCA) released a report from its Subcommittee on Accountability and Societal Change. The report makes numerous recommendations on the use of force and other related issues, using the 2020 National Consensus Policy and other nationally recognized talking points as the foundation of discussion, and sets additional guiding principles that Florida law enforcement agencies should follow.

The subcommittee was created to study the intersection between law enforcement and the community to determine how the FPCA members could better serve the community. The subcommittee was comprised of law enforcement executives, members of the community and subject matter experts to promptly address use of force and societal issues impacting law enforcement in the wake of the death of George Floyd.

Below are highlights of the report recommendations:

Ban Chokeholds and Vascular Neck Restraints:

Chokeholds and Vascular Neck Restraints are prohibited unless the use of deadly force is authorized. This is a high bar only crossed when an officer must protect themselves or others from what is reasonably believed to be a threat of death or serious bodily harm.

■ Require De-escalation:

De-escalation techniques are required whenever possible and appropriate before resorting to force and to reduce the need for force

Require Verbal Warning Before Shooting:

Where feasible, the officer shall identify himself or herself as a law enforcement officer and warn of his or her intent to use deadly force.

■ Require a Duty to Intervene:

An officer has a duty to intervene to prevent or stop the use of excessive force by another officer when it is safe and responsible to do so.

Require Comprehensive Reporting:

All uses of force, including reporting when an officer points a firearm at someone even if it is not discharged, shall be documented and investigated pursuant to agency policies.

Communication by Administrators:

Many misperceptions, rumors, misconceptions and innuendo may be eliminated or mitigated by a law enforcement administration's prompt, clear and continuous communication with the community. In the case of a critical incident, law enforcement administrators should release as much information as appropriate under the law as quickly as possible. This will serve the two-fold purpose of educating the community and reducing the dissemination of incorrect or false rumors.

Accountability:

Reaffirming the principle that all officers should be held accountable should they use excessive force or otherwise violate policy. Accountability may include termination or lesser discipline, retraining, or referral to outside agencies for criminal prosecution if warranted. Accountability also includes communicating with the

community about investigative outcomes as allowed by the Officer's Bill of Rights, Florida public records law and other legal requirements.

■ Recruitment:

Applications to serve in law enforcement are at historically low levels. Agencies should actively recruit police officers who reflect the demographics of the community. The use of community outreach and increased communications with the community may result in attracting police recruits with a desire to serve their community.

FDLE's Analyst Academy certifies 17 new graduates

On Sept. 4, 2020, the Florida Department of Law Enforcement (FDLE) designated new analyst academy graduates Florida-certified Law Enforcement Analysts. The academy is a five-week training and certification program delivered over five months covering topics such as critical and creative thinking, analytical techniques, ethics, privacy and civil rights, and it is supplemented with homework assignments, weekly quizzes, a simulated command staff presentation on the students' final project and a comprehensive final exam. This group, Class 31, started their journey together in January 2020 at FDLE's Tampa Bay Regional Operations Center, met in person again in February, and finished their course of study remotely from June through August. The instructors, all working analysts in the field, took on extra responsibilities to convert their course materials from classroom to remote learning delivery. The program has graduated over 700 analysts since its inception in 2003, representing about 100 law enforcement agencies from all over Florida.

C FIREARMS REVISION

The current CJSTC Basic Recruit Firearms curriculum and CJSTC Firearms Instructor course is nearing 20 years old. With the assistance of the Training Center Director's Association, Florida's State Law Enforcement Chiefs Association, the Florida Sheriff's Association and the Florida Police Chiefs Association, Commission staff formed a group of subject matter experts (SMEs) in January 2020 that will help revise these courses. The SMEs will be responsible for developing content and providing feedback throughout the curriculum-development process. This revision is of extreme importance and will likely impact our Criminal Justice Officers for years to come, the process will be thorough and lengthy.

Like many others projects requiring in-person workshops, the pandemic put the curriculum-development portion of this project on hold. However, staff continued to move this project forward as much as possible with the compilation of survey data specific to Florida, as well as nationwide research for firearms basic training in other states and possible best practices.

In mid-September, small group virtual workshops were held with the SMEs for introductions, a project overview, data presentation and plans for moving forward. During the virtual workshop, staff explained that every part of the current course will be reviewed and revised, if necessary. The next workshop is currently being planned for an in-person workshop at an outdoor range in mid-November.

Update

Shamekia Collins joined the Bureau of Training's Distance Learning and Publishing section as an instructional designer in September. Shamekia previously served as a case specialist in the Professional Compliance section within the Bureau of Standards, where she processed disciplinary cases for the Criminal Justice Standards & Training Commission. As an instructional designer, Shamekia is now responsible for designing online courses for Florida's law enforcement officers, correctional officers and correctional probation officers.



Melanie Sheats joined the Bureau of Policy and Special Programs in October as a government analyst I. Prior to her promotion, Melanie had served as the administrative assistant to Director Register since February 2018, providing support for the Director's Office and the Division through a variety of functions. With her promotion, Melanie will be responsible for coordinating the Florida Law Enforcement Officers' Hall of Fame, and for producing Criminal Justice Agency Profile (CJAP) reports, among other duties.



Gary Calhoun is Chief of Police for the Eustis Police Department. He previously served as the Chief of Police for the Madison Police Department and Maitland Police Department. Commissioner Calhoun is no stranger to the inner-workings of the Commission, as he previously served a partial term on the Commission from July 24, 2012, to December 1, 2014, during his tenure as the Madison Police Chief. Commissioner Calhoun fills a seat previously held by Chief Robert Hardwick of the St. Augustine Beach Police Department. He is appointed to serve a term beginning September 25, 2020, and ending August 1, 2024.

Carol Casimir is the Warden of the Florida Women's Reception Center. She was previously the Assistant Warden of the Central Florida Reception Center and a Correctional Services Administrator and Consultant with the Florida Department of Corrections. Commissioner Casimir fills a vacant seat formerly held by Commissioner

Edward L. Griffin of the Department of Corrections. She is appointed to serve a term beginning September 25, 2020 and ending August 1, 2023.

Sergeant Jacqueline Harrison of the Miami-Dade Police Department is appointed by Governor DeSantis for a four-year term, beginning September 25, 2020, and ending August 25, 2024. She has served in many positions during her 30-year career with the department, including a Public Service Aide, Police Officer and Detective. Commissioner Harrison succeeds Commissioner William Weiss of the Martin County Sheriff's Office.

Director Charles McIntosh is the Dean of Criminal Justice and Public Service at the College of Central Florida and a Reserve Deputy with the Marion County Sheriff's Office. He currently serves as Vice Chair of the Training Center Directors Association's Rules Committee to assist Commission staff with proposed rule changes. Commissioner McIntosh's term begins September 25, 2020, and ends August 1, 2024. He replaces Commissioner Greg Hutching, who serves as the Training Center Director of the Florida Panhandle Technical College Public Safety Institute.

Richard Murphy is a police officer with the Tallahassee Police Department. He previously served as a police officer with the Henry County (Georgia) Police Department and the Macon (Georgia) Police Department. He served in and received an honorable discharge from the United States Air Force. Commissioner Murphy is appointed to serve a term beginning September 25, 2020, and ending August 1, 2024. He replaces Sergeant Kathleen Connell of the Tallahassee Police Department.

Darla Portman is a Master Police Officer with the Tampa Police Department. She is currently the President of the Tampa Police Benevolent Association and serves on the Board of Directors for the Florida Police Benevolent Association. The Governor appointed Commissioner Portman to serve a term beginning September 25, 2020, and ending January 1, 2021. Commissioner Portman replaces Detective Nick Marolda, formerly of the Lakeland Police Department.

Farewell to Seven Commissioners

The Commission commends all these Commissioners for their exemplary service, professionalism, and valuable leadership and wishes them well in future endeavors.

Kathleen A. Connell of the Tallahassee Police Department was appointed for two terms beginning April 7, 2009, and ending August 1, 2016; however, she continued to serve until a replacement was named. During her tenure, she served on the Officer Discipline Penalty Guidelines Task Force in 2010 and the Prejudicial Behavior Committee in 2016.

Chief Robert Hardwick of the St. Augustine Beach Police Department was appointed for a term beginning August 1, 2016, and ending August 1, 2020. During his tenure on the Commission, he provided dedicated service to the Commission and served as chair of the Officer Discipline Penalty Guidelines Task Force in January 2019.

Commissioner William "Bill" Harriss was appointed to serve in the "resident" seat on the Commission for two terms beginning August 2, 2013, to August 1, 2017. He was reappointed for a second term from August 23, 2018, to August 1, 2021; however, Commissioner Harriss plans to retire on December 31, 2020.



Director Greg S. Hutching of the Florida Panhandle Technical College Public Safety Institute began his tenure with the Commission on August 1, 2012, as the representative for the state's criminal justice training schools. He was reappointed for another four-year term beginning August 3, 2016, and ending August 1, 2020. Commissioner Hutching served as Vice Chair from June 19, 2013, until he was elected as Commission Chair from August 7, 2014, to August 10, 2017.

Sheriff David B. Shoar of the St. Johns County Sheriff's Office was appointed to serve a partial term on the Commission from September 4, 2009, to August 1, 2011; however, he resigned from the position on December 9, 2010. Sheriff Shoar was reappointed to the Commission on August 10, 2012, serving until September 25, 2020. During his tenure on the Commission, Sheriff Shoar served on the Prejudicial Behavior Committee in 2016; the Officer Discipline Penalty Guidelines Task Force in 2013; and as

Vice Chair of the Criminal Justice Standards and Training Commission from August 8, 2019, to August 13, 2020.

Deputy William "Willie" Weiss has represented the Martin County Sheriff's Office with distinction as a member of the Commission from February 28, 2013, to August 25, 2020, and during this time served on the Officer Discipline Penalty Guidelines Task Force in 2013, 2015, 2017 and 2019; and as Chair of the Criminal Justice Standards and Training Commission from August 8, 2019, until the end of his tenure.

Lieutenant Matthew L. Williams began his tenure with the Commission as a sergeant with the Clay County Sheriff's Office, serving from February 28, 2013, until September 2020 when he was promoted to lieutenant and could no longer serve in the "sergeant or below" seat on the Commission.

We welcome the newly appointed individuals to the Commission and commend each of the outgoing Commissioners for their contributions to the Commission, the state of Florida, and their respective communities.


Firearms Qualification
