2023 ANNUAL DRUGS IN DECEASED PERSONS REPORT

In 2023, there were 231,925 total deaths recorded in Florida. The recently released Annual Drugs Identified in Deceased Persons Report by the Florida Medical Examiners Commission contains information compiled from autopsies across the state. Medical examiners determined that 14,798 individuals died with one or more of the 41 tracked substances (excluding alcohol) in their body that may have been a factor in their death. This is a 5 percent decrease in total drug-related deaths compared to 2022. Opioids were found to be present or the cause of death in 7,235 of these individuals, a 10 percent decrease from 2022. Notably, there was a 12 percent decrease in fentanyl (an opioid) caused deaths, with the data indicating that at least 79 percent of fentanyl occurrences were illicitly obtained. The drugs that caused the most deaths were fentanyl (4,962), cocaine (2,377), methamphetamine (1,983), ethyl alcohol (1,236), amphetamine (860), benzodiazepines (849, including 493 alprazolam deaths), fentanyl analogs (749) and cathinones (642). Halogenated inhalants (93 percent), fentanyl (90 percent), fentanyl analogs (85 percent), synthetic cannabinoids (83 percent), heroin (81 percent), methamphetamine (74 percent), cathinones (70 percent), cocaine (67 percent), mitragynine (66 percent), hallucinogenic phenethylamines/piperazines (64 percent), xylazine (62 percent) and methadone (58 percent) were listed as causing death in more than 50 percent of the deaths in which these drugs were found.

The Florida Criminal Justice Executive Institute (FCJEI) is proud to announce the graduation of the Florida Leadership Academy (FLA) Class 58 on December 20, 2024. The academy was hosted by the Collier County Sheriff's Office. Participants attended four weeklong sessions from September to December. All 37 class participants serve in leadership roles that represent 23 criminal justice agencies throughout the state.

FLA's goal is to prepare first-line criminal justice supervisors to be effective leaders while also exemplifying the character and integrity of criminal justice professionals. FLA participants learn the skills necessary to support the needs of their agencies and communities.

The FCJEI launched FLA Class 59 in January 2025, which is being hosted by the Escambia County Sheriff's Office and the FDLE Pensacola Regional Operations Center. After Class 59 graduates, Class 60 will begin in May 2025 and will be hosted by the Clermont Police Department in Lake County.

New Trainings on Recognizing and Investigating Crimes Against Animals

New Trainings on Recognizing and Investigating Crimes Against Animals

The Criminal Justice Standards and Training Commission (CJSTC) directed Commission staff to develop additional training for law enforcement officers on how to recognize and respond to crimes against animals. Commission staff held several virtual and in-person workshops with subject matter experts (SMEs) from various law enforcement agencies, animal service centers, and non-profit organizations around the state to develop the following courses to address the needs of investigators and responding officers:

40-hour Advanced Course, #3022, Investigating Crimes Against Animals

This course is for investigators with limited experience in this field or patrol officers who wish to become animal crime investigators. The training covers various animal-related crimes, their underlying causes, and the laws associated with them. The training also teaches law enforcement officers the methods and best practices for processing the scene, collecting evidence, interviewing witnesses and suspects, and working with members of the community and animal service professionals to successfully prosecute the case.

16-hour Specialized Course, #3023, Recognizing Crimes Against Animals

This course is for patrol officers with limited experience or knowledge responding to calls for service regarding animals. The training covers various animal-related crimes, their underlying causes, and the laws associated with them. The training also addresses how to recognize and respond to these crimes at the scene, as well as best follow-up practices.

Both courses contain lesson activities designed to encourage students to think critically about the types of calls for service regarding animals they may be asked to investigate or respond to. They also come with photo banks for instructors to download and use in their own presentations.

On October 31, 2024, the CJSTC approved both courses. Officers who complete the 40-hour advanced course are eligible to receive salary incentive or mandatory retraining credit, and those who complete the 16-hour specialized course are only eligible to receive mandatory retraining credit. Commission Retires Two Courses

On October 31, 2024, the Criminal Justice Standards and Training Commission (CJSTC) retired the Specialized Instructor Course, #1200, Defensive Tactics Instructor Update and Specialized Course, #1195, Public Safety Telecommunications for Law Enforcement Officers.

Defensive Tactics Instructor Update

Commission staff initially developed the course in 2018 to inform current defensive tactics instructors of the changes made to Criminal Justice Defensive Tactics in the basic recruit training program and the Specialized Instructor Course, #802, Defensive Tactics Instructor.

However, defensive tactics instructors no longer take the course because it exceeds the four-year period allowed to reactivate their certification.

Public Safety Telecommunications for Law Enforcement Officers

Legislation pssed in 2012 provided an alternative to the Department of Health's (DOH) 232-hour telecommunications training program by allowing officers who fail the state telecommunications examination to take a 40-hour CJSTC course before retaking the exam (see Technical Memorandum 2016-14).

However, DOH's legal counsel discovered that the legislation passed in 2012 was inaccurately interpreted. To adhere to the legislation as originally intended, DOH now requires officers who failed the state telecommunications examination to take the department's full 232-hour training program instead of the 40-hour CJSTC course.
