# 2017 Analyst Academy begins in Orlando

The 2017 Florida Law Enforcement Analyst Academy classes kicked off January 9, in Orlando, and a second class will begin July 10, in Tallahassee.

In 2003, the Florida Department of Law Enforcement developed the Florida Law Enforcement Analyst Academy (FLEAA). Analysts learn criminal and intelligence analysis skills that are used by law enforcement and other emergency responders to successfully prevent crime and conduct complex investigations.

During this six-week academy, the analysts are challenged with hands-on training, assignments, and weekly quizzes. They develop the skills necessary to complete individual and group research projects. Students take a comprehensive examination following the completion of all course work. Successful graduates receive a state certification as a law enforcement analyst.

To date, there have been 26 academies and over 600 people have graduated, becoming certified law enforcement analysts in the state of Florida. These graduates represent over 100 different agencies and they perform the gamut of tasks and responsibilities possibly assigned to an analyst.

If you are interested in attending one of the academy classes in 2018, the application process begins in the spring. FDLE accepts applications to attend both Florida Law Enforcement Training and FLEAA classes beginning May 1st through July 1st of each year. Applicants who are approved to attend will be notified as soon as the selection process is completed. If an applicant is not selected for the 2018 program, they must reapply to be considered in subsequent years.

# **FLORIDA CRIMINAL JUSTICE EXECUTIVE INSTITUTE**

The Florida Criminal Justice Executive Institute (FCJEI) currently offers four leadership programs: the Chief Executive Seminar (CES), the Executive Leadership Seminar (ELS), the Senior Leadership Program (SLP), and the Florida Leadership Academy (FLA).

Some of these programs meet continuing education requirements for special incentive pay for Sheriffs salary supplement. Graduates of SLP can receive nine graduate level university credits offered through Florida State University, and all of these courses are supported by the Criminal Justice Standards and Training Trust Fund.

**Graduations** were held recently for the **Chief Executive Seminar, Senior leadership Program,** and the **Leadership Academy**. Twenty senior executives graduated on November 16, 2016 from CES; thirty-two senior executives graduated on December 2, 2016 from SLP; and thirty-four individuals from FLA class 37 graduated on December 16, 2016

The 38<sup>th</sup> Florida Leadership Academy Class, hosted at Southwest Florida Public Service Academy, began on January 9th, 2017. The thirty-nine class participants serve in leadership roles representing twenty-four criminal justice agencies throughout the state including police departments, sheriff's offices, corrections and state agencies. The graduation ceremony for this class is scheduled for April 7, 2017.

FCJEI also offers various Continuing Executive Development classes for criminal justice professionals. The Officer Discipline course will be offered May 8-11 in Jupiter and November 6-9 in Sarasota.

**Officer Discipline** is designed to provide participants with a comprehensive understanding of the various aspects of management issues relating to officer misconduct, internal affairs investigations, and the discipline process. Using a combination of lec-

# Florida Law Enforcement Officers' Hall of Fame update

The Florida Department of Law Enforcement took nominations for the Florida Law Enforcement Officers' Hall of Fame 2017 inductees from July 1 to August 31, 2016.

These individuals were nominated by the Florida Sheriffs Association, Florida Police Chiefs Association, Police Benevolent Association, Fraternal Order of Police, and the State Law Enforcement Chiefs' Association. The Hall of Fame Selection Committee, comprised of representatives from each of these associations, met at FDLE Headquarters on November 29, 2016, to discuss the nominees and vote on the final selection. The list of nominees will be presented to Governor Rick Scott and Florida's Cabinet for their consideration during the January 2017 Cabinet Meeting. The official announcement of the inductees will be made in April and the second Florida Law Enforcement Officers' Hall of Fame Induction Ceremony will be held in May 2017.

### MANDATORY RETRAINING STATISTICS

As of December 14, 2016, the following mandatory retraining statistics were reported:

The total number of officers who are due for mandatory retraining by June 30, 2017 is 19,579.

The total number of officers who have met the mandatory training requirement is 5,447.

The percentage of officers who have met the mandatory retraining requirement is 27.82.

## **FIREARMS MANDATORY TRAINING FOR 2018**

All officers who hold an active law enforcement certification are required to qualify on the Commission-approved 40-round course of firearms at least once every two years, with the results documented on Form CJSTC-86A.

The 2016–2018 cycle of qualifications is due by June 30, 2018. A total of 50,737 officers are required to complete firearms mandatory retraining by June 30, 2018.

As of December 14, 2016, the number of officers who have com-

pleted the required training for the 2016–2018 cycle is 8,978, or 17.70 percent.

Any officer who does not complete the required training by the deadline will be separated in ATMS effective July 1, 2018.

Please also note that officers who do not complete the required firearms mandatory retraining on or before June 30, 2018, are ineligible to perform the duties of a criminal justice officer until the requirement is met.

#### SECURITY REQUIREMENTS FOR ATMS

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures are in force:

- Passwords are to be changed every 90 days.
- If the ATMS user does not access the database within 90 days, the system will automatically disable the user.
- The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.

## **STATE OFFICER CERTIFICATION EXAM**

At each quarterly meeting of the Criminal Justice Standards and Training Commission, results for the State Officer Certification Examination (SOCE) are reported as part of the informational agenda.
