FDLE WELCOMES New Executive Leadership Team

Over the past few months, there have been several changes within FDLE's leadership structure.

Governor Ron DeSantis and the Florida Cabinet officially appointed Mark Glass as the Commissioner of FDLE. Commissioner Glass is a 30-year veteran of the United States Armed Forces. He joined FDLE in 2015 as the director of the Office of Statewide Intelligence. In 2017, he was appointed deputy director of Capitol Police and then director of Capitol Police in 2019. With more than 32 years of combined federal and state service, he has served as a law enforcement officer, military officer, national intelligence officer, federal civilian supervisor and senior executive.

Commissioner Glass appointed Shane Desguin as Chief of Staff (CoS). CoS Desguin will oversee Communications, Legislative Affairs, Policy and Planning, Budget, Protective Operations and the Business Support Program. CoS Desguin joined FDLE in 2005 as a special agent assigned to the Protective Operations Section. Most recently, he served as special agent in charge of the Office of Statewide Intelligence and Acting AC of Investigations and Forensic Science.

Commissioner Glass appointed Matt Walsh as Assistant Commissioner (AC) of Public Safety Services. AC Walsh will provide overall management and policy direction for public safety services statewide. He will oversee Capitol Police and the Criminal Justice

Information Services, Information Technology and Professionalism divisions. He joined FDLE in 2003 as a special agent assigned to the Sebring Field Office. Most recently, he served as the special agent in charge for Jacksonville Regional Operations Center.

Finally, Commissioner Glass appointed Vaden "Shane" Pollard as Assistant Commissioner over Investigations and Forensic Science. AC Pollard will provide overall management and policy direction for investigative and forensic services statewide. AC Pollard joined FDLE in 2005 as a special agent assigned to the Sebring Field Office. Most recently, he served as special agent in charge of Fort Myers Regional Operations Center.

55TH CLASS OF THE CHIEF EXECUTIVE SEMINAR

Twenty participants met for one week a month for three months, taking classes on topics such as future trends, managing generations, social media, risk management, stress awareness, and communication in a crisis.

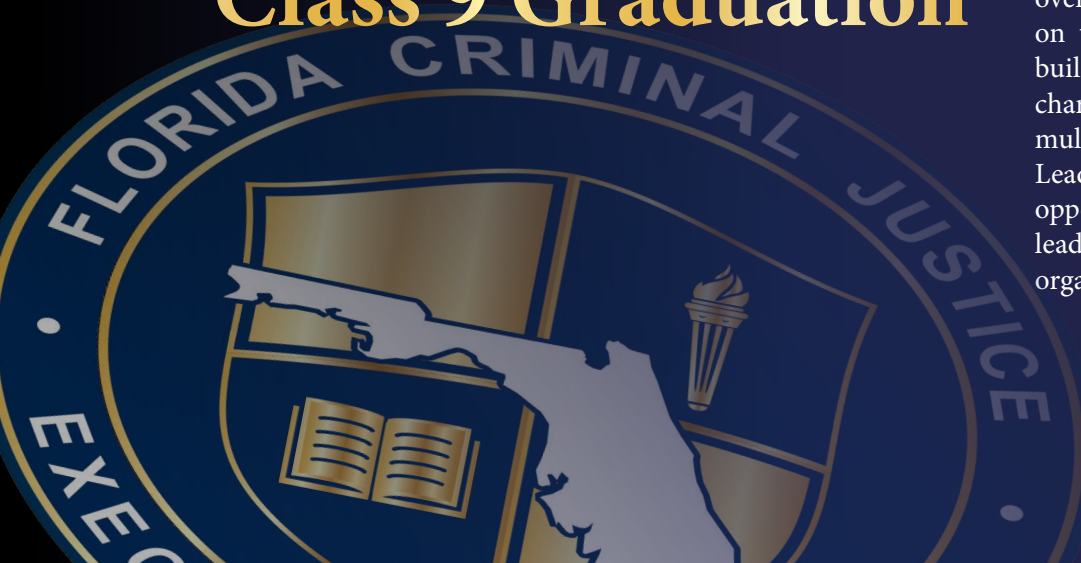
The goal of the Chief Executive Seminar is to prepare Florida's criminal justice leadership for the challenging demands of the future. Class participants study trends and events that may affect criminal justice professionals and Florida, while developing new leadership skills to address the changes that lie ahead.

The Florida Criminal Justice Executive Institute, established within the Florida Department of Law Enforcement and affiliated with the State University System, was established in 1990 by the Florida Legislature in recognition of the need for an innovative and multifaceted approach to the education and training of criminal justice professionals.



Executive Leadership Seminar Class 9 Graduation

The Florida Criminal Justice Executive Institute held the graduation of the Executive Leadership Seminar Class 9 on August 26, 2022, at the St. Petersburg Police Department. The 25 class participants met over three sessions to engage in training on topics such as the heart of leadership, building and maintaining community trust, character-driven policing and dealing with a multigenerational workforce. The Executive Leadership Seminar is an educational opportunity for the upper-management leadership of Florida criminal justice organizations.





SPECIALIZED INSTRUCTOR COURSE, #1201 Firearms Instructor Update Course

With revisions coming to the basic recruit training (BRT) Criminal Justice Firearms course, effective July 1, 2023, firearms instructors will be required to complete an instructor update. Current instructors must take the update course before teaching classes that begin after July 1, 2023. Instructors will have until June 30, 2024, to take the new course or their instructor certification will be deactivated.

The new Specialized Instructor Course, #1201, Firearms Instructor Update Course was approved by the CJSTC on August 18, 2022. The course is 24 hours in length and outlines the changes made to the BRT Criminal Justice Firearms course, instructor evaluations, forms, and courses of fire, and provides a general refresher

for firearms instructors. This course will prepare current firearms instructors to teach the newly revised BRT Criminal Justice Firearms course, firearms re-qualifications, and in-service training.

Only instructors that have completed the Firearms Instructor Update Course will be allowed to teach it. The CJSTC has exempted members of the Subject Matter Expert group from this requirement, so that they may begin to deliver the Firearms Instructor Update Course to other instructors.

SPECIALIZED INSTRUCTOR COURSE, #1419 First Aid Instructor Update Course



With revisions coming to the BRT First Aid for Criminal Justice Officers course, effective July 1, 2023, first aid instructors will be required to complete an instructor update. Current instructors must take the update course before teaching classes that begin after July 1, 2023. Instructors will have until June 30, 2024, to take the new course, or their instructor certification will be deactivated.

The new Specialized Instructor Course, #1419, First Aid Instructor Update Course, was approved by the CJSTC on August 18, 2022. This course is a four-hour online course and outlines the changes made to BRT First Aid for Criminal Justice Officers course, instructor evaluations, forms, and exercises, and provides a general refresher for first aid instructors. This course will prepare current first aid instructors to teach the newly revised BRT First Aid for Criminal Justice Officers course. Only instructors that have completed the First Aid Instructor Update Course will be allowed to teach it.

The FDLE Training Center will enter credit for this training course into the Automated Training Management System (ATMS) under the FDLE training center identifier. Local CJSTC training centers are not required to enter anything into ATMS for this course. Since it is an online course, all entries into ATMS will be handled by the FDLE Training Center for all instructors.
