#### **David F. Harvey**

Wakulla County Sheriff's Office Nominated by Florida Sheriffs Association

David F. Harvey started his law enforcement career in 1972 as a parole and probation officer for Franklin and Wakulla counties. In 1976, he was elected sheriff of Wakulla County at 26 years old. He went on to serve nine terms and retired 35 years later as Florida's longest-tenured sheriff. The office he led grew from 11 employees and an 18-bed jail to one with 180 employees and a 350-bed jail. The Wakulla County Sheriff's Office (WCSO) also became one of the state's first rural sheriff's offices to be accredited in both law enforcement and corrections. In 1978, he became a founding board member and visionary of the Florida Sheriffs Risk Management Fund (FSRMF). In 2010, while still sheriff and chairman of the FSRMF Board, he proposed that sheriffs not only own their self-insurance funds but also manage them in-house rather than outsourcing them to a third party. FRSMF became the largest owned and operated law enforcement self-insurance fund in the nation.

#### Henry N. Kirkman

Florida Department of Highway Safety and Motor Vehicles and Florida Highway Patrol Nominated by the State Law Enforcement Chiefs' Association

Henry N. Kirkman began his career in law enforcement in July of 1936 as a major in the State Road Department's Traffic Enforcement Division. Three years later, Department of Public Safety and Florida Highway Patrol Director W.F. Reid appointed Kirkman as captain of the newly created Florida Highway Patrol (FHP). The appointment was largely due to his experience in the United States Army during World War I. Following his return from World War II, Governor Millard Caldwell and his Cabinet unanimously appointed Colonel Kirkman as the director of the Department of Public Safety. He held this position until 1969, when he became executive director of the newly formed Department of Highway Safety and Motor Vehicles (FLHSMV). Colonel Kirkman retired on February 11, 1970, leaving behind a lasting impact. He laid the groundwork for what would become FHP's motto: "Courtesy, Service and Protection." Because of Colonel Kirkman's outstanding service to the citizens of Florida, the general headquarters building of FLHSMV is designated as the Neil Kirkman Building.

#### Arthur L. McGehee

#### Ocala Police Department

Nominated by the Florida Police Chiefs Association

Arthur L. McGehee began working part-time for the Marion County Sheriff's Office in 1957, at the age of 14. Then in 1971, he moved to St. Petersburg, Florida, to take a position as director of Administration for Police and Fire at the Public Safety Agency. He was appointed chief of police for the city of Ocala in 1974, where he remained for just over 20 years. Upon his retirement from the Ocala Police Department, he was appointed as director of the Florida Criminal Justice Executive Institute (FCJEI), a position he held until his untimely death on September 19, 2000. Chief McGehee also served as chairman and a founding member of the FCJEI Policy Board as well as president and lifetime member of the Florida Police Chiefs Association. He was a charter member of the Commission for Florida Law Enforcement Accreditation and played a major role in helping to develop standards and requirements that agencies would have to meet in order to become accredited.

#### **Charles R. Press**

*Villages of Key Biscayne Police Department Nominated by the Fraternal Order of Police* 

Charles R. Press began his 46-year career in law enforcement as a police officer in 1975 with the Miami Beach Police Department. Retiring as assistant chief after 29 years, he became chief of police with the Village of Key Biscayne in 2004. Chief Press developed and implemented innovative police management and community involvement programs that received local and statewide recognition. He initiated the accreditation process with the Commission for Florida Law Enforcement Accreditation (CFA), culminating in an Excelsior status. He restructured the department with a focus on transparency, accountability and excellent service delivery. He served as president of the Miami-Dade County Association of Chiefs of Police, implementing a number of projects designed to showcase police and community relations. He also served on the board of directors for the International Association of Chiefs of Police. With his heart for the community and advancements in law enforcement, Chief Press is recognized as a resolute motivational leader and law enforcement professional with an uncompromising commitment to integrity, duty and honor.

#### Steve Wayne

Florida Fish and Wildlife Conservation Commission Nominated by the State Law Enforcement Chiefs' Association

Steve Wayne began his law enforcement career in 1991 when he was accepted into the Florida Game and Freshwater Fish Commission's Law Enforcement Academy. Upon graduation, he served as an officer in Okeechobee County and later in Lake County until he was promoted to lieutenant in 2003. With his promotion to captain in 2007, he led 30 officers across Brevard, Indian River and Osceola counties until 2012, when he decided to direct his career towards investigations. He then became the first full-time port investigator for the Florida Fish and Wildlife Conservation Commission (FWC). Throughout the next nine years, his hard work brought to life one of the most robust and effective fish and wildlife port investigation units in the nation. Investigator Wayne's retirement in 2021 concluded 30 years of dedicated service, which established an enduring legacy at the FWC. The port investigation unit's continued hard work ensures that Florida's fish, wildlife and other priceless natural resources are conserved for future generations.



The Florida Law Enforcement Officers' Hall of Fame was created by the 2014 Florida Legislature to recognize and honor law enforcement officers who put their lives on the line for the safety and protection of Florida's citizens and visitors through their works, service and exemplary accomplishments.





Drug Abuse Resistance Education (D.A.R.E.) offers diversion and prevention lessons to K-12 students on topics such as opioid and prescription drug abuse, teen suicide, bullying, cybersecurity, vaping, marijuana, mental health and the celebration of life. As the world's most comprehensive drug prevention curricula, D.A.R.E. is taught to more than 1.5 million students annually in schools throughout the United States and its territories, as well as more than 50 countries internationally. Research has shown that these lessons are effective in reducing problem behaviors. Since 2018, more than 250 communities throughout the United States have launched D.A.R.E. programs. The Florida Department of Law Enforcement is proud to continue offering D.A.R.E. Officer Training (DOT). Each of Florida's DOT conferences features a coordinator, facilitator, educator and four mentor-instructors from various law enforcement agencies in Florida, all with several years of classroom teaching experience. School resource officers and deputies undergo a rigorous 80-hour training course to prepare them to teach curricula that is science and evidence-based. At the end of it, they come away with a greater understanding of classroom teaching techniques and methods to build stronger relations between students and law enforcement.

D.A.R.E. Class 86 was held in Altamonte Springs from June 6-17, 2022. Twenty-seven attendees successfully graduated as D.A.R.E. instructors. The graduating class included deputies from Gadsden, Hamilton, Hendry, Jackson, Lake,

Madison, Marion and Volusia. Among the graduates were also officers from Clermont, Fort Myers and Orange Park Police Departments, as well as Rocky Mount Police Department in North Carolina.

Most recently, D.A.R.E. Class 87 was held in Ft. Lauderdale from July 18-29, 2022 and had a graduating class of 28 attendees. These graduates included deputies and officers from various sheriff's offices, police departments and out-of-state law enforcement agencies.

D.A.R.E. continues to seek the advice of experts from various fields, relying on guidance from four advisory boards, including the Scientific Advisory Board, the Education Advisory Board, the Executive Law Enforcement Advisory Board and the Youth Advisory Board.

The Florida Criminal Justice Executive Institute (FCJEI) is proud to announce the graduation of the Florida Leadership Academy (FLA) Class 51 on August 12, 2022. The academy was held at the Cape Coral Police Department and participants met for four week-long sessions from May to August. The 41 class participants serve in leadership roles representing 27 criminal justice agencies throughout the state.

The FCJEI is preparing to launch FLA Class 52, which will take place at Broward State College from September to December 2022.

FLA's goal is to prepare first-line criminal justice supervisors to be effective leaders while also exemplifying the character and integrity of criminal justice professionals. FLA participants learn the skills necessary to support the needs of their agencies and communities.

The Florida Law Enforcement Analyst Academy is proud to announce the graduation and certification of 26 law enforcement analysts on June 9, 2022. Analysts attending the academy met one week a month for six months. The analysts were challenged with weekly assignments and quizzes, group and individual projects and a comprehensive final exam. Successful graduates are designated by FDLE as Certified Law Enforcement Analysts.

The Florida Law Enforcement Analyst Academy was developed in 2003 by the Florida Department of Law Enforcement to provide analysts the opportunity to hone their criminal and intelligence analysis skills. The curriculum for this academy is continuously updated to ensure that it remains relevant with the everchanging world of technology. The academy provides resources and tools to assist the analysts in their mission to predict and prevent criminal activity. With the graduation of this class, 33 academies have been delivered and 777 analysts have been certified.

# **OFFICER DISCIPLINE** SEARCHABLE DATABASE

Following each disciplinary hearing of the Criminal Justice Standards and Training Commission, hearing results are published in the Commission's Quarterly Update and posted on the FDLE website. This information includes the respondent's name, employing agency, the offense(s), the associated penalty guideline and the discipline levied by the Commission. Despite being publicly available, this information was not easily searchable. To improve user accessibility, Commission staff developed a database of Commission disciplinary actions, which became available on the FDLE website starting June 1, 2022.

The database provides the same information included in the Quarterly Update, but allows the user to select specific timeframes, agencies respondent names, disciplinary actions or offenses. The database will also allow the user to sort data from various parts of the report. It is important to note that the database only contains information related to disciplinary actions taken by the Commission. The database contains information from 2012 and will accumulate data with each subsequent Commission meeting.

# Basic Recruit Training Program FIREARMS & FIREARMS & INSTRUCTOR UPDATES

With revisions coming to the firearms and first aid courses, effective July 1, 2023, changes will come to both Instructor courses. Therefore, firearms and first aid instructors will be required to complete an instructor update. Instructors must take the update course before teaching classes that begin after July 1, 2023. Instructors will have until June 30, 2024, to take the update course or instructor certification will be deactivated.

While the firearms instructor update will require in-person instruction, the first aid instructor update will be online. The current plan is to take both instructor update courses to the CJSTC for approval in August 2022.

# VANDATORY Victim of Sexual Offenses

# COURSE

The 2021 Florida Legislature passed House Bill 1189, creating s. 943.1724, Florida Statutes. This bill requires the CJSTC to create instruction for law enforcement recruits and current officers on the response to sexual offenses. This two-hour online course was developed in consultation with the Florida Council Against Sexual Violence (FCASV).

Furthermore, the bill requires all law enforcement officers to complete the training as a part of basic recruit or as a part of mandatory retraining before July 1, 2024.

The course, Victims of Sexual Offenses, number 1418, was approved by the

CJSTC on May 12, 2022, and became effective immediately.

The course material has been incorporated into the law enforcement basic recruit training curricula in the 2022.7 version and added as a training requirement for applicants taking the Law Enforcement Officer Proficiency Course following approval for an Equivalency of Training.
