## Defensive Tactics Instructor Update Course



On July 1, 2020, a new Criminal Justice Defensive Tactics Basic Recruit Training Program went into effect. Because of the significant changes to this program, the Criminal Justice Standards and Training Commission approved the Defensive Tactics Instructor Update course (number 1200) and mandated that all current defensive tactics instructors must complete this course to maintain their defensive tactics instructor certification. The deadline to complete the update course was August 13, 2021. The Defensive Tactics Instructor Course (number 802) was also updated effective October 31, 2019, to include the program changes.

As of August 13, 2021, all defensive tactics instructors who had not completed the 24-hour Defensive Tactics Instructor Update course, or who had not completed the Defensive Tactics Instructor Course after October 31,

2019, had their defensive tactics instructor certification lapse. A total of 560 defensive tactics instructors lapsed. Commission staff sent a letter to each agency or training school to notify them of the instructor's certification status. The Commission does not require defensive tactics instructor certification for instructors who only conduct agency in-service training and do not teach Commission-approved courses. No other instructor certifications were impacted by this requirement.

Instructors whose defensive tactics instructor certification has lapsed must meet the following requirements to reactive their certification.

- If the lapse is for a period of four or fewer years:
  - complete the Specialized Defensive Tactics Instructor Update course (number 1200) at a Commission-certified training school;
  - demonstrate the defensive tactics proficiency skills pursuant to Rule 11B-35.0024, F.A.C.;
  - complete continuing education or training approved by the training center director, agency administrator or designee;
  - complete a high-liability internship documented on the Instructor Competency Checklist, Form CJSTC-81, that is supervised by an instructor who is certified in the updated defensive tactics course.
- If the lapse is for a period of more than four years, comply with Rule 11B-20.0014(1), F.A.C., which requires the applicant to repeat the entire instructor training process.

# 2021 Training Center Directors Workshop

After being cancelled in 2020 due to COVID-19, the 22nd Training Center Directors Workshop was held at the Florida Public Safety Institute from August 24 through August 27, 2021. A total of 24 people, including 12 directors, participated in the full workshop, while specific topic areas were attended by additional participants. The workshop provided a valuable opportunity for new directors to network and to learn some best practices. The attendees received 28 credit hours of training that may be used toward their instructor retraining requirements.

The Training Center Directors Workshop was started in 2002. This workshop provides new training center directors and their staff with guidance on the rules and requirements related to training center certification, staffing and facilities, along with information regarding officer training, instructor certification and requirements related to the Standards and Training Trust Fund. To date, a total of 437 directors, coordinators and fiscal agents representing 41 of the 42 training schools have attended a workshop. Over the years, the workshop has evolved based on feedback from the participants to provide the most current and relevant information possible.

The planning for the 23rd Training Center Directors Workshop in 2022 has already begun. Be on the lookout for further information in upcoming Quarterly Update newsletters.

# ADVANCED COURSE UPDATE: DOMESTIC INTERVENTION AND INVESTIGATION, COURSE NUMBER 091

In 1986, Domestic Intervention, course 091, was developed in support of career development training. In 2021, the course was updated to give officers a broader understanding of the short-term and long-term effects of domestic violence on victims, their families and communities. At the August 2021 meeting, the Criminal Justice Standards and Training Commission approved the rewrite of advanced course Domestic Intervention and Investigation, number 091, effective August 19, 2021.

Domestic Intervention and Investigation is an 80-hour course that takes a culturally responsive and trauma-informed approach to domestic violence. It outlines task-oriented procedures for investigating cases effectively while highlighting the officer's role in promoting victim safety. Emphasis is placed on gathering sufficient information that will stand independent from victim testimony.
