The Florida Law Enforcement Officers' Hall of Fame recognizes and honors law enforcement officers who put their lives on the line for the safety and protection of Florida's citizens and visitors through their works, service and exemplary accomplishments.

Nominations were accepted from the Florida Sheriffs Association, the Florida Police Chiefs Association, the Police Benevolent Association, the Fraternal Order of Police and the State Law Enforcement Chiefs' Association. One representative from each association served as the Selection Committee that identified five nominees for consideration of approval by the Governor and Cabinet. An induction ceremony will be held on Saturday, June 3, 2023.

2023 HALL OF FAME NOMINEES:

Anthony Peterson was with the Saint Petersburg Police Department just shy of thirty years where he served in patrol, vice and narcotics, gang intelligence, Special Investigations Unit (SIU) and training. Detective Peterson demonstrated exceptional bravery throughout his career and handled extremely dangerous situations under great duress. He utilized sound judgement and appropriate techniques to take control of any situation, while upholding the law and mentoring the agencies newest officers. During his service with the SIU, Detective Peterson was shot in 2008 and again in 2020, and yet remained with the unit, acting as lead detective on some of SIU's largest and most in-depth investigations. For his actions in the line of duty, he was awarded both the Purple Heart and the Medal of Valor twice. In 2017, he was the recipient of the Ned March/Bud Purdy Award of excellence and the 2020 St. Petersburg Police Department Officer of the Year. On March 2, 2021, he was recognized as the first ever Law Enforcement Officer of the Day on the House floor by Speaker of the House, Chris Sprowls, and Attorney General, Ashley Moody. Although he retired from law enforcement in 2022, he continues to serve as a background investigator with the St. Petersburg Police Department.

Dorene Thomas began her 40-year career in law enforcement service as a parking enforcement officer and part-time dispatcher at the St. Pete Beach Police Department in 1975. Moving to the Pinellas Park Police Department as its first female officer in 1980, she was promoted to sergeant in 1986 and lieutenant in 1998. In August 2000, she was appointed chief of the Pinellas Park Police Department. Chief Thomas also served her country as a member of the United States Naval Reserve. She has been recognized as the International Crisis Intervention Team Chief of the Year, Police Officer of the Year, Sailor of the Year, Tampa Bay Government Businesswoman of the Year, was awarded the Hometown Heroes Award and the 2013 Iconic Woman of the Year Award for a business with over 50 employees. She embraced building relations between the agency's employees and the command staff while keeping her community and its citizens first. During her tenure, Chief Thomas was credited with shepherding Pinellas Park Police Department through the years of agency turmoil and turbulent budget woes; leveraging emerging technology that improved officer safety and agency responsiveness to its citizens; and building a new intelligence-led policing

initiative. Chief Thomas led the Pinellas Park Police Department with style and a commitment to the law enforcement profession that permeated all levels of the agency and its leadership.

Douglas Muldoon started his police career in 1976 with the Palm Bay Police. On April 23, 1987, a lone gunman went on a rampage killing 8 people, including 2 police officers. Chief Muldoon, a captain at the time, was tasked with setting up a command post and coordinating a response of over 1,000 police officers responding from the entire state, in what was to be a 7-hour standoff. After this horrific event, he helped to prepare other police departments on how to better handle similar events. Chief Muldoon remained with Palm Bay, and continued his accession within the department, holding the ranks of major and deputy chief before being named chief of police in April 2011. Chief Muldoon distinguished himself in Florida law enforcement when he was elected President of the FBI National Academy Associates (FBINAA), a worldwide organization of over 16,000 members from 170 countries. He currently serves as committee chair for the Florida Police Chiefs Association Public Private Security Partnership. He has consistently embraced and excelled in the various leadership roles that he has fulfilled throughout his career. Chief Muldoon is well respected, educated, experienced, and actively involved in improving the quality of life for the community at large and the law enforcement professionals he has served.

Gary W. Hester began his 35-year career in law enforcement in 1979 with the Polk County Sheriff's Office where he served in detention, patrol, criminal investigations, and special investigations. During his tenure at the Sheriff's Office, he held many ranks ranging from sergeant all the way to chief of staff under Sheriff Grady Judd. As a deputy sheriff, he had the privilege of being one of the first five K-9 handlers in the agency, where he and his K-9 partner Trouper placed first in the obedience category at the USPCA K-9 trials in 1982. In 1990, he was awarded a bureau commendation for an investigation that resulted in the arrest of over 30 drug criminals and the seizure of currency and property in excess of \$600,000. Chief Hester was an integral part of spearheading the agency's Proactive Community Attack on Problems (PROCAP). His leadership in a reassessment of resource allocation of patrol units resulted in a realignment of district and region boundaries to maximize the agency's resources, response and proactive policing. In 2010, Chief Hester retired from the Polk County Sheriff's Office to become the chief of police for the Winter Haven Police Department, where he served for four years, and then briefly as the Haines City Police Chief in 2017.

John E. Brooks began his 43-year career in law enforcement in 1975 as a patrol officer for the Miami Police Department. Over the next 25 years, he would progress through the ranks of the department before retiring in 2000 as an assistant chief of police. Shortly after leaving the Miami Police Department, Chief Brooks joined the Broward County Sheriff's Office as a captain where, in 2001, he became intricately involved in all aspects of combating terrorism and became BSO's liaison to the FBI directly after the 9/11 attacks. In 2005, Chief Brooks was promoted to major and assigned to the new "Division of County and Domestic Security" where he commanded three districts and a compliment of over 500 sworn and civilian personnel with a budget totaling \$38 million. While in this position he was the agency's representative to the FBI Joint Terrorism Task Force and was awarded one of the highest clearances with the United States government. In 2007, after being promoted to the rank of lieutenant colonel for BSO, Chief Brooks was appointed chief of police for Sunrise Police Department, becoming the seventh police chief in Sunrise history. He remained the chief of Sunrise Police Department until his retirement in January 2018.

Summary

Detective Anthony Peterson is a St. Petersburg native and in May of 1992 was sworn in as an officer of St. Petersburg Police Department. Throughout his career he served in many positions to include patrol officer, gang detective, vice and narcotics detective, surveillance and investigations unit (siu), and most recently a trainer in the training division. Detective Peterson has served in some of the most dangerous units and positions. Detective Peterson was shot in the line of duty in April 2008 and almost lost his life. His commitment to the officers, agency and City of St. Petersburg is so strong not only did Detective Peterson return to work he returned to the very unit he was assigned to when the shooting occurred. Detective Peterson was again shot in the line of duty while serving in the same unit in December 2020. In true "Tony" fashion he returned to full duty and now became a trainer to help mentor the agencies newest officers. After a 29 year and 8month career Detective Tony Peterson retired but his love for law enforcement didn't allow him to go far. He is now a background investigator for those seeking employment with the St. Petersburg Police Department.

I nominate Detective Anthony "Tony" Peterson for the Florida Law Enforcement Officers Hall of Fame. Detective Peterson has exceeded his duty requirements and has had a career that included heroic and brave acts of service that demonstrated selflessness to our fellow officers and his community.

Detective Anthony Peterson was with Saint Petersburg Police Department just shy of thirty years. He has served in capacities including patrol, vice and narcotics, gang intelligence, Special Investigations Unit (SIU), and most recently, training. In April 2008, SIU began working an armed robbery investigation. The suspects were observed ordering the employees around at gun point and then they moved out of sight. Fearing for the victims, Detective Peterson moved in closer. As he did this, the suspects unexpectedly burst out a side door within feet of Detective Peterson. He identified himself and immediately took fire from one of the suspects. He was shot twice and returned fire. The suspects were arrested at the scene and ultimately were sentenced to life in prison. As a result of being shot, Detective Peterson spent nearly a month in the ICU, and at one point in an induced coma.

He eventually made a full recovery and returned to work . . . to the very same unit (SIU).

On December 2, 2020, detectives from SIU located a suspect in a child abuse case who was also a possible suspect in a homicide. Detectives sent uniformed officers to stop and identify the suspect. The suspect began to violently resist and rammed several vehicles. SIU detectives moved in to assist and Detective Peterson pulled up to the driver's side of the suspect vehicle.

The suspect immediately opened fire on Detective Peterson and he was shot twice. Again. The suspect was subsequently shot and killed. Detective Peterson again made a full recovery and again returned to work. Detective Peterson is the perfect blend of being tactically sound, an intelligent investigator, and a natural leader. He has an uncanny ability to locate suspects. He has been the lead detective on some of the largest and most in-depth investigations SIU has ever conducted. He personifies class and professionalism and provides our community with dedicated and selfless service. Here are two more examples of the great work Detective Peterson has done over his thirty-year career.

In 2012 Detective Peterson was contacted by a neighboring agency in reference to a series of bank robberies throughout the county. They developed a suspect and were using a tracking device to track his movements. During their initial investigation the suspect showed interest in a bank in St Petersburg. During this time the agencies agreed, they would conduct the surveillance of the suspect, however if he came to Saint Petersburg, SIU would take over the

surveillance. During one of the evenings SIU was contacted by the agency and informed that the tracking device used had failed, and they believed the suspect was last seen heading to St Petersburg.

Detective Peterson found a local business owner, in the area of the bank, that was closing for the day. Detective Peterson, after speaking with the owner was allowed to remain in the closed business to watch the bank in question as well as the street. During his surveillance he was able to identify the suspect and vehicle as he approached a traffic light with other vehicles surrounding. Detective Peterson informed other SIU detectives and a surveillance began, during the surveillance it was clear the suspect was casing the bank.

Detective Peterson remained at the business and watched the bank, as the suspect eventually parked at a nearby apartment complex and approached the bank. Detective Peterson observed the suspect commit the bank robbery and members of SIU arrested the suspect as he fled. This case ended a serial violent bank robbery, and he was eventually sentenced to over 40 years in prison.

In 2018 Detective Peterson was contacted by SVU about a 30-year-old serial rapist case. Detectives from SVU reopened the case and were able to develop a suspect, however needed his DNA for comparison. The special investigation unit followed the suspect for weeks attempting to obtain his DNA sample. The intense surveillance led throughout the county on a daily basis. During the surveillance detective Peterson observed the suspect and his wife drink from Gatorade bottles. He quickly noticed they were different flavors and identified the flavor the suspect was drinking. The information was provided to other detectives and the surveillance continued for another five plus hours. The bottle was eventually obtained after the suspect discarded it at a brush site. The recovery of the bottle resulted in positive match of DNA collected over 3 decades prior. The suspect in the cold case serial rapes has been identified and sentenced to more than 40 years in prison.

Detective Peterson embodies all the characteristics of a great officer, detective, trainer, and a mentor for young officers. His commitment to the agency and community are second to none. Even when he is attending his local church, Calvary Chapel Fellowship he leads the security team and trains them on his off time. In recognition of Detective Peterson's 29 plus year career Speaker of the House, Chris Sprowls and Attorney General Ashley Moody recognized him as the first ever Law Enforcement Officer of the Day on the House floor on March 2nd, 2021. Please consider Detective Anthony Peterson for the Florida Law Enforcement Officers' Hall Of Fame.

The Awards Board members in attendance at our meeting on October 9, 2008, carefully reviewed the nomination for the Medal of Valor and Purple Heart awards for the following Department employee as summarized below:

Starting in March 2008, there were a series of armed robberies at multiple area pharmacies. The group of individuals suspected of committing these crimes used progressive force and violence toward the pharmacy clerks and cashiers, culminating with a shot discharged upon leaving the business at their last robbery. It was clear that these suspects who had been recorded on surveillance cameras, needed to be caught before people in the community or pharmacy personnel were seriously injured or killed.

On April 30, 2008, the Special Investigations Unit (SIU) received a tip, began watching the group of suspects and later followed three of them as they drove to the 5100 block area of 66th Street North. Detective Anthony Peterson exited his vehicle and took a foot position while watching the suspects' vehicle drive suspiciously around a dead-end road and through a business parking lot. He immediately advised his unit, and they took perimeter positions as two of the suspects exited the vehicle. The other suspect drove away and was taken into custody by other SIU detectives without incident. Meanwhile, the two suspects had run inside a Blockbuster Video store, and Detective Peterson directed the SIU Unit into position around the store exterior, with one detective able to see the suspects and confirm a robbery was in progress. Detective Peterson was positioned by a glass emergency exit door, and he continued to creep up with a third detective to see what the suspects were doing after the first detective lost sight of the suspects.

Suddenly, the emergency door flew open, with the two suspects running out from the robbery they had just committed. Detective Peterson immediately drew his firearm and told the two suspects to "freeze." One of the suspects shot him in the abdomen and arm. Even though severely wounded, Detective Peterson returned fire and shot the suspect, who fell to the pavement and was taken into custody, along with the other suspect. Detective Peterson then collapsed to the ground and was given aid by his fellow detectives until medical rescue personnel arrived. After complicated life-saving surgery and months of difficult recuperation time, thankfully, he is expected to recover completely.

The heroic actions of Detective Peterson, even while seriously wounded, immediately stopped these dangerous and violent criminals from their crime sprees that were putting innocent citizens' lives at serious risk. He demonstrated, through his actions, the dedication to our citizens that we are all sworn to "protect and serve."

The Awards Board members unanimously felt Detective Peterson demonstrated exceptional bravery throughout this incident. He handled an extremely dangerous situation under great duress, utilized sound judgment and appropriate techniques to take control of the situation, while upholding the law in spite of being seriously wounded. Upon review of the circumstances of this event, all Awards Board members agreed that Detective Anthony Peterson should receive the Medal of Valor and the Purple Heart as his actions met the criteria for both awards as noted below:

I would like to nominate Detective Anthony Peterson for the prestigious Ned March/Bud Purdy Award. Detective Peterson has been a member of the St. Petersburg Police Department since January 6, 1992. He is currently assigned to the Special Investigations Unit and has been assigned to the Department's surveillance unit since April 2002. His professionalism, dedication and commitment has remained the same.

It takes a unique individual to not only be a member of a surveillance unit, but to have the longevity in that unit that Detective Peterson has had is truly remarkable. This commitment by not only him, but his family, should be applauded. To be a member of this type of unit is to know that you and your family may have to sacrifice vacations, holidays, weekends and scheduled days off at a moments notice. As I have explained when I have been asked on numerous occasions, "What hours are you working?" The response is usually, "I don't know, whatever the suspect or pattern dictates." This makes it hard for any member of the unit to make plans: dental and doctor appointments, repair work, and school functions, just to name a few of the inconveniences. To have endured these circumstances and continue to be committed and dedicated for 16 years to this type of police work takes a special person. He has also suffered several injuries throughout his career. These range from bruises and abrasions to his knees, being bitten by a K-9 in the groin, and having been shot at. Those were enough for a career and Det. Peterson endured those in his first week in the Unit. I knew then that he was dedicated to the Unit and the citizens of the community he grew up in. Through all of these he always managed to come back to work and be ready for the next assignment with none of the injuries keeping him down for any significant amount of time.

However, nothing could prepare him or the other members of the unit for the near tragedy that occurred on April 30, 2008. The Special Investigations Unit had been assigned to conduct a surveillance of suspects in a recent series of armed robberies to pharmacies. These suspects had committed three "take-over" robberies and had progressively gotten more aggressive. During these robberies, the suspects pointed handguns at the pharmacy clerk and also at the cashier in the front of the business. On their last robbery, a shot had been fired by the suspects as they left the business.

The Unit had conducted a surveillance of the suspects to a Block Buster Video store in Pinellas Park. While Detective Peterson was moving closer to the door the suspects exited. They were running out the door when Detective Peterson challenged them. In a split second the suspect fired his weapon at Detective Peterson. Detective Peterson returned fire and they exchanged fire as the suspects tried to flee. Detective Peterson was shot multiple times.

Detective Peterson received the Medal of Valor and the Purple Heart for his actions which were nothing short of heroic. This again gave him all the reason in the world to re-evaluate his decision to remain in the Unit, but when he returned to duty, he said there was nowhere else he would rather be than working with these equally dedicated individuals in the Special Investigations Unit.

Detective Peterson has been in numerous other high risk/ liability arrests throughout his career in SIU to include: an armed robbery to the PNC bank located at 38 Avenue and 49 St. N., an armed robbery to the Smoke Shop at 11 Avenue -34 St. N., and an armed robbery to the gas station at 30 Avenue- 49 St. N. During this robbery, Detective Peterson along with two other members of the unit were forced to use their firearms to stop the suspect after the suspect confronted them with a firearm.

Detective Peterson has been involved in the arrest of several residential burglary suspects, and in some cases the most extreme of these we refer to as "creep-in" burglars. These subjects have been given this moniker due to them breaking into occupied residences while knowing that the residence is more than likely occupied due to the time of night. These subjects are very dangerous as they have the mentality that they are either going to fight or flee, but may have to fight just to get away. On one of these 'creep-in" burglaries, Detective Peterson had watched the crime occur and was directing the Unit to move in to make the arrest as the suspect was leaving. However, the victim had woken up and only saw Detective Peterson in the area. The victim had armed himself and was challenging Detective Peterson. While he was trying to identify himself, I approached and I was able to identify our unit and advise the victim that Detective Peterson was actually one of the good guys. The victim was very appreciative of Detective Peterson's efforts along with the other members of the unit who had taken the suspect into custody due to his actions.

As if everything I mentioned above wasn't enough, Detective Peterson has always been someone I could rely on for a variety of assignments. These aren't always the most glorious assignments but like a recent example, I needed someone to advise the radio shop on equipment being installed in vehicles, as I was out of town. Detective Peterson not only spoke with them but went out of his way to go to the shop and test the equipment and give them his suggestions. Detective Peterson has always stepped up to assist in every way possible, and this is just another example of his dedication to the unit and its mission. As an individual working within a team oriented concept, Detective Peterson has managed to stand out and should be recognized for his achievements. He is one of the individuals who is working on an assignment when everyone is wondering, "What are the police doing about any current problem?" He is one person in a team who is constantly being asked to step up and help put an end to a serious criminal problem in the city. After a lengthy career of dedicated service I feel he is very deserving of this recognition. With this in mind, it is with great pleasure and pride that I nominate Detective Anthony Peterson for the Ned March/ Bud Purdy Award for his many achievements throughout a stellar career

It is my privilege to author this memorandum to nominate Detective Anthony Peterson for Officer of the year. Detective Peterson has been a Police Officer with this department since May of 1992. Detective Peterson was transferred to the Special Investigations Unit in April of 2002 and has remained there ever since. He is a fixture within the unit and his years of experiences have been heavily relied upon to train any detective that has entered the unit in the last fifteen years. He has been involved in countless take downs of murders, burglar's and robberies in progress. For the past eighteen years he has selflessly put his life in harms way to help keep our city and citizens safe. This includes an incident back in 2008 where Detective Peterson confronted a suspect immediately after a robbery, resulting in a gun fighter in which he suffered serious injuries. Detective Peterson fought his way back from those injuries and came back to continue to work in his current unit, pursing the most dangerous criminals within the city.

This brings me to December 2nd, 2020. Detective Peterson was a part of surveillance of a subject who had Aggravated Child Abuse charges, who was known to be violent and was known to carry a firearm. The unit followed the suspect to a location where they had patrol officers get out with him to confirm his identification and place him into custody. When patrol officers attempted this the suspect fought and fled in his vehicle. Special Investigation Detectives at this time moved up to assist in the arrest of the suspect, when this occurred the suspects vehicle intentionally rammed several of the detectives vehicles in his violent attempt to flee. Detective Peterson's and another vehicle ended up being rammed by the vehicle and coming to a stop with Detective Peterson's drivers door next to the suspects drivers door. At this time the suspect pulled a firearm and opened fire on Detective Peterson from only several feet away. Detective Peterson was able to exit his vehicle and exchange gun fire with the suspect and move himself to a safe location. At this time Detective Peterson realized that he had been shot in the exchange of gun fire and flagged down other detectives to assist him as he applied self aid to his injuries while being transported and stabilized at the hospital.

Detective Peterson has spent the last year training multiple detectives who were transfered to the unit. He coordinates and runs the units surveillance training as well and is constantly debriefing newer detectives after they have completed take downs and surveillance is strives to help them learn and grow from these experiences. Detective Peterson is also the Major Case liaison for the unit and spends countless hours meeting with them in order to take the cities most violent offenders off the streets.

Detective Peterson exemplifies what it means to be selfless and heroic. He would be deserving of this award this year without his valiant acts from December 2nd. There is no one more deserving of this award than Detective Peterson and I thank you for your consideration.

I would like to nominate Detective Anthony Peterson for Officer of the Year. He joined the St. Petersburg Police Department, January 6, 1992 and has been part of the Gang Intelligence Team for the last three years. Detective Peterson is also in charge of our S.H.O.C.A.P. (Serious Habitual Offenders Comprehensive Action Program) and teaches G.R.B.A.T. (Gang Resistance Education And Training). Detective Peterson has done several Gang Presentations during this past year for Civic Organizations, Citizen Academy, High Schools, Middle Schools, and other Special Interest Groups.

Detective Peterson is also involved in our Sexual Predator and Sexual Offender Programs. When these individuals are released from prison, they must register with the police department. Detective Peterson is then notified of where they are residing in the city and visits these individuals, verifying they are at the address and complying with the guidelines the court has imposed on the individuals and if they are not complying, they are arrested and sent back to prison.

Detective Peterson is also in charge of the Serious Habitual Offenders Comprehensive Action Program, which deals with juveniles who have committed felony crimes. Detective Peterson goes out and visits these individuals each month and talks to the parents and the juvenile making sure they are following the guidelines set up by the court. He has worked very diligently to reduce the number of juveniles being sent back to juvenile court. He has the highest number of S.H.O.C.A.P individuals in Pinellas County. He attends a S.H.O.C.A.P. meeting once a month at the Juvenile Assessment Center and participates in discussions on how to keep the juveniles out of the court system or which ones need to be certified as adults and taken out of the juvenile system all together.

Detective Peterson was also nominated as the Fraternal Order Of Police member of the month for March 2001. After finishing teaching a G.R.E.A.T. class on March 6, 2001, Detective Peterson was interacting with some of his students when a subject walked by wearing a red hooded sweatshirt and a ball cap. A former G.R.E.A.T. student approached Detective Peterson and advised there was a subject outside with a gun wearing a red hooded sweatshirt getting on a tricycle. Detective Peterson ran outside and observed the subject riding off campus holding one hand on his waistband area. Detective Peterson yelled for the subject to stop but he did not comply. Detective Peterson chased the subject, on foot, down the sidewalk in front of the school, and grabbed him off the tricycle. The subject had one hand in his front sweatshirt pouch over the firearm. At this time Detective Peterson reached for his firearm and unsnapped his holster at which time the subject immediately complied. Detective Peterson removed the gun, which was a short-barrel .22 caliber revolver. During the search, subsequent to arrest, a kriife was also found in the subject's possession.

The suspect was seventeen years old and had a lengthy criminal record. He also was a member of a local gang. The subject was charged with felon in possession of a firearm, armed trespassing, and carrying a concealed firearm on school property. The individual was charged as an adult because of his criminal history.

Detective Peterson's quick actions may have prevented another potential act of violence at one of our schools.

Detective Peterson is assigned to Asian Gangs and has closed several cases during the year. Detective Peterson worked an Asian gambling case involving a body shop in our city. The owner was running a business during the day and a gambling house at night. Detective Peterson did a surveillance on the business, writing down tag numbers, and doing field information reports on people leaving the business. As a result of this information the Gang Intelligence Team was able to catch the individuals in the act of gambling and seized their money and several gambling devices.

Detective Peterson was assigned to Vice and Narcotics before he came to the Gang Intelligence Team. Detective Peterson worked a case of an Asian Gang Member selling narcotics. He received information from a confidential informant; one of our gang members had gone into the drug business. The Gang Intelligence Team followed the suspect and observed him do a drug transaction with another subject. When the Gang Intelligence Team moved in to make the arrest, the subject took off running. Detective Peterson gave chase and lost the suspect, but advised he had to be in the immediate area. A perimeter was set up, Detective Peterson located the subject under a residence and arrested him. 28.2 grams of cocaine were found in the suspect's vehicle.

Detective Peterson also worked a case with Detective J. Letcher involving a group of gang members who were taking over a neighborhood. The individuals were threatening neighbors and doing criminal activity in the area. The detectives were able, through surveillance and interviewing neighbors in the area, to arrest one gang member for burglary and another for aggravated battery. This was enough to drive the other members of the gang, who did not even live in the neighborbood, away and they have not returned. It is a pleasure to have Detective Peterson is a pleasure working with the Gang Intelligence Team. Detective Peterson's consistently outstanding performance, and devotion to duty, coupled with his devotion to his family and his positive attitude, makes him a deserving candidate for the Officer of the Year award.



PINELLAS PARK POLICE CHIEF DORENE THOMAS

(Mr. JOLLY asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. JOLLY. Mr. Speaker, I rise today to recognize someone who has been described as a trailblazer, a pioneer, and a woman of firsts: Pinellas Park Police Chief Dorene Thomas who, on this Friday, will retire after four decades of public service.

Thomas became the first sworn female police officer at the Pinellas Park Police Department in 1980. In fact, when she started, the evidence room was located in the men's locker room, something ehe would eventually change.

In 2000. Thomas became the department's first female police chief, hut she often said she would simply prefer to be knowe as a good police chief rather than a female police chief.

Five years ago, she was elected president of the Florida Police Chiefs Association, another first for women. She has also started intensive crisis intervention training, which teaches officers how to work with people with behavioral or mental health challenges.

Mr. Speaker, it is a privilege to recognize a person who has helped keep our citizens safe, to honor a person who has led with courage, kindness, grace, and understanding.

I urge my colleagues to joio me in thanking Chief Thomas for her selfless years of service. Thank you for making Finellas County a safer place, and thack you to all the men and women who, today, serve on the front lines of law enforcement.

Chief Thomas, enjoy your retirement. You have very well earned it.

PRESIDENT OBAMA'S REQUEST TO WRITE RULES FOR THE WORLD'S ECONOMY

The SPEAKER pro tempore (Mr. ALLEN). Under the Speaker's announced policy of January 6, 2015, the gentleman from Oklahoma (Mr. RUS-SELL) is recognized for 60 minutes as the designee of the majority leader.

Mr. RUSSELL. Mr. Speaker, at his State of the Union Address. President Obama asked us in Congress to grant us fast-track Trade Promotion Authority, so he can "write rules for the world's economy."

I sat alarmed for America's future should we expand this President's authority, given how he has extended executive overreach, fumbled our foreign policy, debilitated our defense, and diminished our domestic tranquility. At least this time, the President asked to bypass Congress.

Regardless of the merits of trade partnership or the tactics of their negotiation, two fundamental questions loom: Why do we trust this President, given his track record in foreign affairs? And what serious harm would come to the Nation by waiting 21 months?

Trade Promotion Authority, or TPA, would prevent Congress from amending as much as one word of the rules he writes, a sweeping agreement the White House has been working toward for the past 6 years. Even if parameters were set beforehand, violations would be subject to an up-or-down vote with no amending permitted. Unlike a treaty, a simple majority is all that would be needed to pass.

For Congress to cede oversight on such a sweeping agreement could have grave implications. The American people must be at the table, and they can be, through their elected representatives in Congress.

In a balanced process, the full range of congressional committees would hold hearings with experts, establish clear objectives, set the terms of negotiation, and be regularly informed throughout the negotiating process.

This would ensure trade deals are in the best national interest for the long haul, not designed to please some small groups of well-connected insidors for some tempting short-term benefit.

While trade is vital in securing coonomic freedom and in strengthening our values and friendships, we must approach any partnership with a comprehensive view of its strategic impact. Advocates have stated that a Trans-Pacific Partnership will open trade involving 40 percent of global economic activity.

This is a misrepresentation when one considers that 6 of the 11 nations proposed for the partnership already have strong trade agreements with the United States and many of the remainder enjoy excellent trade relations, such as with Japan.

The President also claims a trade surplus without delineating this improvement will come from services such as financial, insurance, and computing, not from manufacturing, as he purports. Given Obama's scathing treatment of financial and insurance investment overseas, one wonders if there is not some other hidden motivation.

Alarmingly, Mr. Obama uses containment language with regard to China as a major premise for obtaining fasttrack authority. While we employ economic instruments of our national power with regard to an ascendant China, we must ensure in tandem efforts with diplomatic and informational instruments as well. Strategically, these are lacking.

Further, should a trade diepute result in an impasse, nations historically have lashed back with their last remaining option, their military. I have been on the receiving end of many of those strategic implications. Ours must be prepared -our military—as we explore these new frontiers.

 \bar{I} have heard no serious discussion from anyone in Congress or the White House thinking comprehensively and strategically in this manner, that our military and our diplomatic efforts must also be resourced and reinforced as we move economically in this pivot to Asia.

When John Hay opened trade with China more than a century ago as a hedge on an ascendant Japan to balance European concerns, the achievement was widely heralded. Japanese society had rapidly embraced Western science and technology since the days of Commodore Perry. A vibrant economy blossomed. Western ideas in manufacturing, banking, business, and even military doctrine quickly transformed Japan into a formidable power. This was not without political consequence.

Japan had transformed her society, fought as an ally in a world war with the West, imported goods to a demanding public, built ships together with the West, and signed treaties. Their rapid transformation alarmed the Japanese Diet hardliners, who used this anti-Western sentiment to wedge political power.

Within a 15-year span, the lengthy embrace of the West gave way to competition for resources, distrust, the fall of Japanese Government, and the doctrine of their Greater East Asia Co-Prosperity Sphere.

In only a couple of more years, what was embraced in the West was now widely disrespected in Japan. Despised, they were deliherately attacked; few ever saw it coming. That Japan and the United States are such strong allies and friends today is a testament of our mutual commitment to the repairing of human diplomatic and economic tragedies.

We cannot allow President Obama to rush willy-nilly into a fast-track Chinese hegemony without regard to strategic thinking. Given his dismal foreign policy record, it comes as no revelation, but it does come with consequences. What serious harm will come to our Nation by waiting 21 months when we have an administration that actually could achieve foreign policy successes, instead of one foreign policy defeat after another?

A dog may lap up antifreeze because it seeme good to the taste and pleasant to the eye, but it does so with consequence. We should not be lured by the appeal to our natural senses for trade and economic growth.

Patience now may prevent horrific consequences in a major war in the foture. We do that by advancing our national instruments of power with diplomatic effort, military readiness, and preparedness in tandem with our economic effort.

What serious harm can come by waiting 21 months? As Abraham Lincoln famously said:

Nothing good can be frustrated by time.

We do not need to give the President this anthority. We need to wait, have the patience, lay the strategic foundation so that we can do what is best for our country, and move into a trade agreement that will have a long-lasting foundation.

Mr. Speaker, I yield back the balance of my time.

100TH ANNIVERSARY OF ARMENIAN GENOCIDE

The SPEAKER pro tempore. Under the Speaker's announced policy of January 6, 2015, the gentleman from California (Mr. SCHIFF) is recognized for 60 minutes as the designee of the minority leader.

Mr. SCHIFF. Mr. Speaker, on April 24, we will mark the 100th anniversary of the Armenian genocide. 100 years ago, 1.5 million Armenians, along with the Syrians and Greeks, were slaughtered by the Ottoman Empire in the first genocide of the 20th century.

The sheer scale of genocide thwarts our capacity to comprehend it: 1.5 million Armenians killed, 6 million Jews killed in the Holocaust, 1 million Tutsis. The numbers become abstractions sanitized by their enormity. It is only when we consider each of those lives individually that the full horror comes into focus.

The victims of genocide are more than victims—they are human beings. The Armenians massacred from 1915 to 1923 were men, women, and children who were targeted iu what was then an unprecedented campaign to wipe out an entire poople.

It is our duty in the modern day to remember those lost and to bear witness that the campaign to destroy the Armenian people failed. We do so by speaking the truth, and we do so by speaking the names of those 1.5 million and by keeping both the way they lived and the way they died alive in our memory.

Pinellas Park chooses woman as police chief


Dorene Thomas had been serving as interim chief for two months. She is the only female permanent chief in Pinellas County.

In a surprise move Wednesday, the Pinellas Park city manager named Dorene Thomas to be chief of the city's beleaguered Police Department.

Thomas, 47, has been serving as the interim chief for two months, since the former chief, David Milchan, left amid allegations that he had threatened the city manager and waved a finger in his face.

The appointment makes Thomas the only permanent female police chief in Pinellas County. Largo has an acting chief who is a woman. It's unclear whether Thomas is the first woman chief in county history.

"The two months that she's been in charge over there, she's demonstrated that she's an outstanding leader in the Police Department," City Manager Jerry Mudd said. "She's made improvements in the environmental climate over there. From what I'm seeing, I believe she's the very person to lead our Police Department into the future."

The decision surprised Thomas, who thought Mudd was waiting until later in the year to appoint a permanent chief. At the same time, Thomas said she was pleased because it will give her and her co-workers a sense of stability.

Thomas has been with the city for 20 years. She was a lieutenant when she was named interim chief.

As chief, Thomas will earn about \$77,600 a year. That's a \$14,400 increase from her salary as interim chief. In all, it's a 35 percent increase over the \$57,500 she was making as lieutenant.

"I think her responsibility level has increased 100 percent," Mudd said.

"I think it's a good thing," Pinellas Park council member Ed Taylor said. "Everybody's enthusiasm level for Dorene as interim has been tremendous." Her appointment was popular with the Pinellas County Police Benevolent Association.

"I think it's a good choice," said Bill LauBach, the police union's executive director.

LauBach said he thought Thomas would be able to lead the department out of its difficulties.

"It'll be a different kind of leadership than what they've had," LauBach said. "I think she's up to the job. There has to be a change."

He said those changes should include a fresh look at problems as well as fresh faces in management.

The department has had serious difficulties in recent months as three women filed state and federal claims of sexual discrimination and harassment. The federal Equal Employment Opportunity Commission recently ruled that the department had discriminated against one of them. The agency also gave the other two the right to sue regarding their grievances.

In addition, two male officers filed union grievances claiming they were victims of a "hit list" of officers targeted for firing.

In response, the city hired an outside consultant to perform a climate survey of the department and an outside attorney to investigate those allegations.

The investigation into the existence of a hit list is ongoing. Climate survey results are due Monday.

Mudd had said he would not appoint a permanent chief until after the survey came back. Yet with the survey's return imminent, he changed his mind. That's because the survey will likely include many recommendations for changes in the department, Mudd said. Pinellas Park PD enters a new era

The Pinellas Park Police Department is gearing up for a big year.

Not only is it celebrating its 100th anniversary this year, but Chief Dorene Thomas announced that she's retiring after 35 years of service in Pinellas Park. She made her announcement at the Pinellas Park PD's Jan. 6 centennial celebration.

Her last day will be April 24 and Assistant Chief Michael Haworth will step up April 25 to become chief when she leaves.

"Chief Thomas has been a tremendous asset to our police department and our city," City Manager Doug Lewis said. "She has brought a level of superior service and respect and has honored our residents with her dedication and compassion."

Thomas spent five years working in law enforcement for St. Pete Beach before being hired as a patrol officer for Pinellas Park in 1980. From there she was promoted to sergeant in 1986 and then lieutenant in 1998. She served briefly as interim police chief before being offered the job permanently in 2000, making her the first full-time female police chief in Pinellas County.

"I've met some wonderful people along the way," she said. "It's been a really wonderful journey for me. It's been indeed my honor and I'm humbled to have been a servant."

Haworth, a graduate of the FBI National Academy and Air Force veteran, joined the PPPD in 1990 as a police officer. In 1995, he was promoted to sergeant and captain in 2001. In 2013, along with Lewis, he served as interim co-city manager before the job went to Lewis. Haworth was promoted to assistant police chief in 2014.

"Michael has done an outstanding job throughout his career and is the perfect choice to lead our department into the next hundred years," Lewis said.

Though attendees of the centennial celebration were emotional over Thomas' announcement, the event also honored the department's long history.

In 1913, the town of Pinellas Park had a population of 250 and was policed by George Williams, the town marshall. By 1915, the city had been established and the police department was formed. Williams was appointed the first chief of police – he was also the department's only employee.

The city's police force grew slowly. In the 1930s, there were only two employees, and the department was restructured in 1948. At that time, there were six employees, which grew to 11 by 1958, 20 by 1965 (including two full-time detectives) and about 35 by the mid-1980s, Thomas said. Today, the department boasts 106 sworn officers.

"The city has a population of almost 50,000, so we've grown quite a bit and our police department has grown as well," she said.

Each officer received a new badge recognizing the department's centennial on Dec. 6. Its civilian employees and volunteers all received a similarly designed lapel pin.

The department also honored Officer Jimmy Rexroad as the 2015 Police Officer of the Year at the event.

Rexroad, a former Marine, began his career with the PPPD in 1987. Since then, he's served as a SWAT team member, child abuse investigator, crime prevention officer and the department's first community policing bicycle officer.

After 9/11, he focused on homeland security and safety teaching security in the community. He also worked on the department's efforts to raise money for the Special Olympics, helping to make it the number one agency in the state for the amount of donations collected.

He's received numerous awards throughout his career, including the department's Employee of the Quarter in 2007 and the Excellence in Prevention Award in 1995. He's also received five Performance Recognition Awards, four Letters of Merit, one Chiefs Commendation Award, three Distinguished Service Recognitions, and one Meritorious Service Award, and was previously nominated for Officer of the Year five times.

Pinellas Park Police Chief Dorene Thomas is retiring after 40 years in law enforcement.

"My first job at St. Pete Beach Police Department and I was, at that time I was hired as a meter maid," said Chief Thomas. "Now we term it as a parking enforcement officer."

That job led to a patrol position with Pinellas Park Police Department.

"I was excited, I was excited and my dream had come true," she said.

A dream come true for Thomas, who in 1980 was the first sworn female officer in the department.

"The evidence locker room was located in the men's locker room, so I had to knock on the door to go in and put the evidence in," she said.

In 2000, the first woman officer became the first female police chief.

"When I came here I never thought I would be chief," she said. "I thought, 'Gee, maybe I'd like to be sergeant one day.' "

Thomas has held many positions, from meter maid and patrolman to crime scene tech and sergeant. Now, decades later, she has decided to retire.

"We're in a good place," Thomas said. "We like each other and we're going forward. I think that's what I'm most proud of."

Thomas describes her career as eventful and fulfilling. She's also proud of initiating intensive crisis intervention training.

"Shows people how to work with people with behavioral health issues," she said. "It's a way of educating. It's a way for us to be able to help people."

As Chief Thomas packs up and prepares for her final week of work, she hopes her service has made a difference.

"What I'd like to leave is a message to balance your life and I hope that I've made a difference in yours as you have made in mine."

Florida Law Enforcement Officers Hall of Fame Nomination Narrative

Retired Chief Doug Muldon started his police career in 1976 with the Palm Bay Police department after following the legacy of his father, Frank Muldon, a 29-year veteran for the Bogota New Jersey Police department. When Chief Doug Muldon started his career with Palm Bay, it was a small rural community of 7,500 people covering 65 miles. The department had less than 20 officers. When he left as Chief the city had grown to a population of over 110,000 and expanded to over 110 square miles with a sworn force of 170 budgeted officers.

On April 23, 1987, a single event would forever change the city of Palm Bay. A lone gunman, William Cruse, went on a rampage killing 8 people, including 2 police officers, and seriously wounding 14 others. One of this nation's first nationally covered mass shooting incidents. Doug, a Captain at the time, was tasked with setting up a command post and coordinating a response of over 1,000 police officers responding from the entire state, in what was to be a 7-hour standoff with the offender. Ultimately, through the efforts of Doug and others on the scene, the subject was taken into custody without other casualties. For the next two years after the healing period of a shaken police department, Doug was tasked to present lessons learned and prepare other police departments on how to better handle similar events. Doug remained with Palm Bay, and continued his accession within the department, holding the ranks of Major and Deputy Chief before being named Chief of Police in April 2011. Doug served as police Chief until his retirement in January 2015.

Along the way Chief Muldon distinguished himself as a who's who in Florida law enforcement when he was elected President of the FBI National Academy Associates, a worldwide organization of over 16,000 members made up from over 170 countries. Chief Muldon had previously served as Florida's state president of the FBI graduates. During his year as president of the National Association, Doug was called upon numerous times to speak on behalf of all law enforcement on critical issues affecting the law enforcement profession. Chief Muldon has also served a president of the Brevard's Chiefs of Police Association in 2009 and represented District 7 for several years on the Board of Directors for the Florida Police Chief's Association (FPCA).

Retirement didn't slow down Doug's love for the law enforcement profession. Chief Muldon currently serves the chair of the FPCA's Public, Private Partnership Committee, he chairs the FBINAA Charitable Foundation Board, Florida FBINAA Scholarship and Youth Leadership Committee, and sits on the FPCA's Foundation Board. The purpose of the foundation is to provide small and rural police chiefs with scholarships to attend FPCA training opportunities that their budgets prohibit them from attending, it also provides college scholarships to Police Explorers. Doug is also a board member and strong advocate for Survive First, an organization committed to assisting law enforcement officers in dealing with issues involving post traumatic syndrome and potential suicide issues. His support of Survive First has become extremely personal as he has sponsored fundraisers and personally solicited friends, colleagues, and organizations through Florida and the United States to secure resources to prevent and treat officers/deputies contemplating suicide. Doug has also been involved ensuring that law enforcement leaders and departments are educated in identifying conduct and indicators of suicidal contemplation by their employees.

Doug has won numerous awards over his career for his work in the development of Tac-Tel Medicine Program, assisting SWAT members using a secured network to advise Trauma Centers of impending serious medical injuries in the field to reduce casualties.

In December 2013 Congressman Bill Posey recognized Doug for his work and tenure in his community through the Congressional Record. Doug remains active as a volunteer deputy with the Brevard Sheriff's Office. It is seldom that a commander in law enforcement through out the United States has not heard of Chief Doug Muldon, a true asset to the Florida Law Enforcement Community. Therefore, it is a great privilege for me as past recipient of this award to nominate Chief Doug Muldon into the Florida Law Enforcement Officer's Hall of Fame.

I welcome this opportunity to recommend Chief Douglas Muldoon (Ret.) for consideration for selection to the Florida Law Enforcement Officer's Hall of Fame.

Chief Muldoon served 38 years with the Palm Bay Police Department. He served the last four years as the Chief of Police, the first internal police chief in more than 36 years. During his tenure, he was involved with the Florida Police Chiefs Association serving as a Director and as the Chairman of the Public Private Partnership Committee. He was the first Deputy Chief to become President of the Brevard County Association of Chiefs of Police.

I have known Chief Muldoon for the past 30 years, having met him in 1992 at a Florida FBI National Academy Associates conference in Pensacola, Florida. His service to the law enforcement community became readily apparent as he was serving as an area representative in the organization at the time. In 1994, he was elected to the Florida Chapter FBINAA Board of Directors. In 1998, he assumed the position of President of the Florida FBINAA Chapter. Chief Gary W. Hester Polk County Sheriff's Office: 1979 – 2010

Chief Gary W. Hester is a Polk County native, having been born in Winter Haven in Chief Hester began his career at the Polk County Sheriff's Office in 1979 serving in Detention, Patrol, Criminal Investigations, and Special Investigations throughout his 31-year tenure. Chief Hester has held many ranks including Sergeant, Lieutenant, Captain, Major, Colonel, and Chief of Staff under Sheriff' Grady Judd.

Chief Hester was recommended for Correctional Officer of the month in 1979 after only working in the Polk County Jail for three months. As a deputy Sheriff, Gary was one of the first five K-9 handlers in the agency - his partner was "Trouper". In 1982, he and K-9 Trouper placed first in the Obedience category at the USPCA K-9 trials in Naples. During his time as Captain, Gary worked in the Bureau of Special Investigations at the height of the crack cocaine epidemic in Florida, and was recognized time and time again for the seizure of narcotics, currency, property, and drug arrests. He was also recommended for Officer of the year in 1983, 1984, and 1988. In 1990, he was awarded a Bureau Commendation for an investigation that resulted in the arrest of over 30 drug criminals and the seizure of currency and property in excess of \$600,000. In 1996, he was awarded a Sheriff's Commendation for a 130% increase of drug arrests over the previous year. In 2000, he was awarded a Meritorious Service Medal with the Vice Unit for shutting down one hundred and seven (107) illegal adult related businesses in Polk County, to include lingerie modeling, nude clubs, massage parlors, escort services, adult bookstores, and theaters operating under the guise of legitimate business. Chief Hester was an integral part of spearheading our Proactive Community Attack on Problems (PROCAP). Within his first year as Colonel, Gary led a reassessment of resource allocation in patrol. This resulted in a realignment of district and region boundaries to maximize our agency's resources, response and proactive policing. He also created and organized the Analytical Unit in the Bureau of Special Investigations. Gary also traveled making professional presentations to other agencies regarding the progressive PROCAP philosophy that allowed law enforcement to track "hot spots" of criminal activity in a form of preventative policing. Every performance evaluation in his personnel file raves on his formidable interpersonal skills as a leader, and his focus on the agency's crime fighting mission.

Gary has a Master of Science Degree in Criminal Justice from the University of Alabama and a Bachelor of Arts Degree in Criminology from Saint Leo College, where he graduated Summa Cum Laude. He is a graduate of the 97th Session of the Administrative Officers Course at the Southern Police Institute. Gary has attended numerous leadership and police operations courses and seminars, and was an Adjunct Professor of Criminal Justice at the University of South Florida and has been a guest lecturer for the Southern Police Institute. Gary also co-authored an article entitled "Sheriff Law Enforcement Officers and the Use of Force," which was published in the Journal of Criminal Justice.

Chief Hester retired from the Polk County Sheriff's Office in 2010 to become the Chief of Police for the Winter Haven Police Department, where he served for four years, before becoming the Polk County Deputy County Manager for Public Safety from 2014-2017. Chief Hester also served as the Haines City Police Chief in 2017.

Gary has a myriad of letters from law enforcement officials, both internal and external, and from countless community members praising his dedication to excellence, for going above and beyond, and his outstanding service to this community.



Chief Brooks served in the United States Air Force Reserves from 1972 to 1978. He began his law enforcement career in 1975 as a patrol officer for the Miami Police Department. In 1977 he joined the "Special Weapons and Tactics Team" and became a supervisor in 1980. Chief Brooks was promoted through the ranks and worked in areas of Patrol, Homicide, Task Force/Street Narcotics, Personnel Recruitment, Background Investigations, and Special Investigations and advanced to the head of the Criminal Investigations Division, as an Assistant Chief.

A graduate of Barry University, Chief Brooks received his Masters Degree in Criminal Justice from Florida International University in 1994. He graduated from the F.B.I. National Academy + 154th Session.

Chief Brooks joined the Broward Sheriff's Office in May 2000 after retiring from the City of Miami as an Assistant Chief of Police with over 25 years of service.

Chief Brooks joined the Broward Sheriff's Office as a Captain, and in 2001 became intricately involved in all aspects of combating terrorism in the community becoming a member of the "Emergency Responses Committee for the Domestic Security Task Force." Additionally, Chief Brooks was the BSO liaison to the FBI directly after 9/11. In 2004 Chief Brooks was appointed Commander of Broward Sheriff's Office Pompano Beach District. He was responsible for the day-to-day activities within the District.

In 2005, Chief Brooks was promoted to the rank of Major and assigned to the new "Division of County and Domestic Security." With a budget totaling \$38 million, Brooks commanded three Districts and a compliment of over 500 sworn and civilian personnel. Brooks was in charge of Port Everglades, Fort Lauderdale/Hollywood International Airport, the Broward County Courthouse, Transit Security and was the agency's representative to the "FBI Joint Terrorism Task Force." Chief Brooks was awarded one of the highest clearances with the United States Government.

On July 25, 2007, Chief Brooks was promoted to the rank of Lieutenant Colonel for the Broward Sheriff's Office commanding the "Patrol Services Bureau."

On September 11, 2007, Chief Brooks was appointed Chief of Police by the Mayor and City Commission of the City of Sunrise, Florida becoming the seventh Police Chief in Sunrise history. Chief Brooks came to Sunrise three months earlier as the interim Chief from the Broward County Sheriff's Office. He remained Chief until retirement in January of 2018.

Chief Brooks is a member of numerous law enforcement organizations and the past President of the "Broward County Chiefs of Police Association" in 2011. Chief Brooks was appointed by Governor Seott to serve as a Regional Chair of the State Regional Drug Enforcement Strike Force and is currently serving as a Board Member for the Hundred Club of Broward County.

Nomination of Chief John E. Brooks

It is with great honor and privilege that I nominate retired Chief John E. Brooks for the Florida Officers' Hall of Fame. Chief Brooks has been a stellar member of the law enforcement community for over 45 years, and his commitment and dedication to the profession have been profound. He was an integral part of South Florida society during his tenure and was ahead of his time as he worked to strengthen the bond between law enforcement and the community while respecting and caring for the rule of law early on in his career.

Chief Brooks' career path began when he served in the Unites States Air Force Reserves from 1972 to 1978, at which time he fully realized his love of this country and his desire to help protect the liberties and freedoms of his fellow man. As a natural extension of his military assignment, Chief Brooks decided to be of service to his local community and joined the Miami Police Department in 1975. Chief Brooks would spend the next 25 years of his life progressing through the ranks of the police department and working to protect his officers and safeguard the community.

After working as a patrol officer for 5 years, Chief Brooks carned the rank of Sergeant and was initially assigned to the Patrol Section, where he managed a squad of ten officers. During this time, he also managed the front-line operations and actions of the Special Weapons and Tactics Team (SWAT) during Miami's 1980 civil disturbances. Chief Brooks navigated through uncharted waters as he delicately balanced the safety of his officers and the community while preserving the freedoms guaranteed to the people of Miami. He strongly believed in holding people accountable for their actions and maintaining the structure and stability of society during this trying time.

Chief Brooks excelled in his patrol position and was assigned to the position of Sergeant of the Homicide Detail in 1981. Between the years of 1982 to 1984, he achieved the highest clearance rate of the Miami police Department, investigating and solving over 140 homicides. Chief Brooks was able to bring closure to family members, friends, and loved ones of victims during the most difficult, harrowing times in their lives; and it was all accomplished during a time when the luxuries of modern-day technologies did not exist.

Chief Brooks was promoted to the rank of District Commander of the Patrol Section in 1985, at which time he developed strong working relationships with community leaders, residents, and business owners through his assigned districts. Chief Brooks was a pioneer of the implementation of the Community Oriented Policing Philosophy at the Miami Police Department as he recognized the vital need for law enforcement agencies and their communities to work together. He expounded upon this philosophy when he was promoted to Lieutenant of the Task Force/Street Narcotics Unit, where he implemented a problem oriented policing program to pinpoint and improve upon crime and deteriorating conditions within the community.

Nomination

As his ability to ensure the police department's mission was being accomplished in a professional manner became more evident with each rank he held, Chief Brooks was promoted to Major of the Miami Police Department's Special Investigations Section. Chief Brooks oversaw numerous high-profile investigations and successfully coordinated and administered dignitary and intelligence functions for major events held in Miami. One such event was the Summit of the Americas, which was the first event of this nature to be held in the United States. Chief Brooks completed his career at the Miami Police Department in 2000 holding the rank of Assistant Chief of Police for the Criminal Investigations Division, where he supervised 21 inter-related areas of law enforcement, including criminal acts, crime scene, bomb squad, and intelligence. He maintained his steadfast belief in community engagement while focusing on the order necessary for society to thrive.

Realizing that he still had a lot more to offer the South Florida community, Chief Brooks joined the Broward Sheriff's Office (BSO) in 2000 as a Captain of the Strategic Investigations Division. He immediately immersed himself in the fight against terrorism by becoming a member of the Emergency Responses Committee for the Domestic Security Task Force and the BSO liaison to the Federal Bureau of Investigations (FBI) directly after the 9/11 attacks on our country. In 2005, Chief Brooks was promoted to Major and commanded the newly created Division of County and Domestic Security. He oversaw Port Everglades, the Fort Lauderdale/Hollywood International Airport, the Broward County Courthouse, Transit Security and was the agency's representative to the FBI Joint Terrorism Taskforce. He also commanded the BSO Field Forces, which deployed over 300 personnel to ensure the safety and security of the community during critical incidents.

In 2007, the opportunity presented itself to become the Chief of Police for the Sunrise Police Department in Broward County. He took the position in September of 2007 and became the 7th Chief in Sunrise history. Chief Brooks immediately took the reins and imparted his extensive basis of knowledge to his new leadership role. He was instrumental in the Sunrise Police Department obtaining accreditation status from the Commission for Florida Law Enforcement Accreditation (CFA) and procured new equipment and technology for the department members so that they could more successfully serve the community. Chief Brook's emphasis on Community Oriented Policing remained at the forefront of his administration, and he successfully led the agency until his retirement in 2018.

I wholeheartedly believe that a resume or biography cannot truly do justice to the impact that Chief John Brooks had in the greater field of law enforcement and society as a whole. Words cannot adequately express his commitment to his fellow officers, the community, his country, and the vision he maintained for the betterment of all. Although his accomplishments and recognitions are remarkable, I believe his character during his years of service is the most impressive aspect of his career. Chief Brooks maintained a strong belief system and was unwavering in his desire to bridge the gap between law enforcement officers and their communities, recognizing that this relationship would be the catalyst for the most successful outcomes. He has dedicated most of his life to serving others; being a voice for those who could not speak for themselves; maintaining lawfulness; reinforcing America's resilience against terrorism; and further legitimizing the field of law enforcement; all while maintaining his strong, moral character. Chief Brooks was and continues to be an honorable member of the law enforcement community and an induction into the Florida Law Enforcement Officers' Hall of Fame is well deserved.


