INSTRUCTIONS FOR COMPLETING FORM CJSTC-3

HOW TO USE THIS FORM

Use this form to record the performance of all role-plays listed on this form.

HOW TO COMPLETE EACH ITEM

1. **Training School Name.** Enter the name of the training school.
2. **Course Sequence Number.** Enter the Course Sequence Number.
3. **Training Class Beginning Date.** Enter the date the class started. Enter as in this example: 04-01-2008.
4. **Training Class Ending Date:** Enter the date the class ended. Enter as in this example: 04-01-2008.
5. **Role-Play Practicum Check Sheet.** A minimum of three different basic recruit students will participate in each practicum. After each student performs a role-play, the instructor will lead the class in a discussion to evaluate and provide constructive feedback on the student's performance.
6. **Role-Play Performance Date.** Enter the date each role-play practicum exercise was conducted.
7. **Instructor Signature.** The instructor who conducts the role-play practicum shall sign in the "Instructor Signature" column corresponding to the role-play performance date.
8. **Training Center Director or Designee's Signature and Date.** The training center director or designee shall sign and date this form.
9. **Completed Form.** The training center director shall retain the completed form in the class file.
