## AGENDA ITEM: 1

Petition for Variance or Waiver: Request for Waiver of Rule 11B-27.00213(4)(b), F.A.C., by the Florida Department of Corrections on behalf of 190 officers

### ISSUE NUMBER 1

This agenda item is presented to the Commission by the Florida Department of Corrections to request a permanent waiver of the above mentioned rule for 190 officers named in the Petition.

### EXECUTIVE SUMMARY

1. 190 officer trainees on a Temporary Employment Authorization (TEA or TEAs) with the Florida Department of Corrections were terminated while in good standing on June 3, 2011, at 5:00 p.m., because of budget constraints.
2. Petitioner does not wish its officer trainees to be unable to find further TEA employment as a result of this budget issue. Rule 11B-27.00213(4)(b), F.A.C., would prevent these trainees from seeking another TEA within four years of this break in service. Petitioner urges that this is an unreasonable outcome, which punishes the trainees for a situation over which no one had control.
3. The Department of Corrections has supplied a list of the names of all 190 officers. That list is made a part of this issue.

**RECOMMENDATION(S):** Commission staff recommends that the Commission grant a permanent waiver of Rule 11B-27.00213(4)(b), F.A.C., to Petitioner effective immediately, thereby permitting the 190 terminated officer trainees to seek further TEA employment without having to wait four years from their termination date. However, these 190 officer trainees will be subject to all rules and statutes regarding TEA employment once they become re-employed on a new TEA with a new employer.

### VOTING IMPACT

**CONSEQUENCES OF A "YES" VOTE ON STAFF RECOMMENDATION:** The Petitioner's request for a rule waiver will be granted and the 190 named officer trainees shall be permitted to seek another TEA without waiting four years. These 190 officer trainees will be subject to all rules and statutes regarding TEA employment once they become re-employed on a new TEA with a new employer.

**CONSEQUENCES OF A "NO" VOTE ON STAFF RECOMMENDATION:** The Petitioner's request for a rule waiver will not be granted and the 190 named officers shall not be permitted to seek another TEA without waiting four years.

**11B-27.00213; Temporary Employment Authorization.**

(4) Agencies applying to temporarily employ or appoint an individual who has had a previous TEA registered with the Commission in the same discipline, may do so only if:

(a) The individual was previously certified as a full-time or part-time officer; or

(b) The individual was previously hired on a TEA and has separated from the employing agency or discontinued training while still in good standing, and has had a break-in-service from the last employment for a minimum of four years. Such individual shall comply with the firearms training requirements pursuant to Rule 11B-35.0024, F.A.C., and Section 943.17(1)(a), F.S., unless the agency administrator has waived such requirements in subsection (2) of this rule section, and shall enroll in a Commission-approved Basic Recruit Training Program within 180 days of employment in the first training program offered in the geographic area, or in the first assigned state training program for a state officer.

**Section 120.542, F.S.**, mandates threshold proofs and notice provisions for variances and waivers from agency rules.

(2) Variances and waivers shall be granted when the person subject to the rule demonstrates that the purpose of the underlying statutes will be or has been achieved by other means by the person and when application of the rule would create a substantial hardship or would violate principles of fairness. For purposes of this section, "substantial hardship" means a demonstrated economic, technological, legal, or other type of hardship to the person requesting the variance or waiver. For purposes of this section, "principles of fairness" are violated when literal application of a rule affects a particular person in a manner significantly different from the way it affects other similarly situated persons who are subject to the rule.

Dear Mr. Zadra,

Several correctional officers, who were employed by the Florida Department of Corrections pursuant to the Temporary Employment Authorization (TEA) provision contained in Section 943.131, Florida Statutes, recently lost their jobs.

These individuals were terminated solely for budgetary reasons and *not performance related issues*. The Department is concerned that these former employees, who left in good standing with the agency, will be unable to be rehired by the Department of Corrections or hired by another agency under the purview of the Criminal Justice Standards and Training Commission (Commission), on a TEA, until a minimum of four (4) years has passed, pursuant to Florida Administrative Code Rule 11B-27.00213 (4) (b).

In our effort to assist these employees with obtaining future employment in the law enforcement/correctional field, the Department is seeking to have the Commission waive that portion of Florida Administrative Code Rule 11B-27.00213(4)(b) that requires an officer candidate previously on a TEA, and separated while still in good standing, to have a four year break in service before seeking another TEA. The Department respectfully requests that the Criminal Justice Standards and Training Commission convene on an emergency basis to consider granting a waiver of this four-year break-in-service requirement for the employees whose names appear on the attached list.
