Does operator have an "Add to Watch List" entry screen?		
Does entry screen prompt operator for mandatory data fields?	1	
Does entry screen present optional data entry fields to operator?		
Does operator have ability to choose either a "Search" or "Match"		
submission?		
Are all required NIST fields completed for a "Search" submission?	1	
Are all required NIST fields completed for a "Match" submission?	1	
Is operator able to view results of submission? (HIT, NOHIT, AMBIGIOUS, ERROR)		
RISC Requirements		
Does operator have ability to enter a RISC "Search" submission? (RFP codes 009 or 013)		
Is operator provided correct response from search? (RED – Hit; YELLOW – Ambiguous/Timeout; GREEN – Not Identified)		
Is the operator presented which database the RED (Hit) was made against?		
Is the operator presented with the results from the FALCON search?		
Is the operator alerted to an FBI number discrepancy?		
DNA Requirements		
Does operator have ability to select either a "Search" or "Match" submission?		
Is operator properly notified of "HIT", "Sample on file", "No Action Required"?		
Is operator presented a data entry screen when a "HIT", "Sample not on File" returned?		
Does data entry screen properly fill in Name, DOB, Sex, Race, SID, FBI #, DOC #, SSN with non-modifiable data?		
Is operator able to enter data in State, County, FL Statute, Offense, Court Case #, Court Ordered Collection, Probation status, Date collected fields?		
Is operator presented a data entry screen when a "NOHIT", "Sample Required" returned?		
Is operator able to enter data in all fields?		
Is operator able to print 2D Bar code Label with required data?		
Does label include fingerprints?
