

## Location

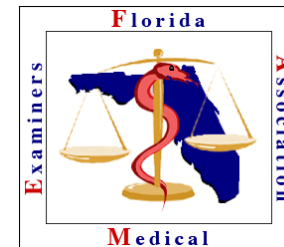
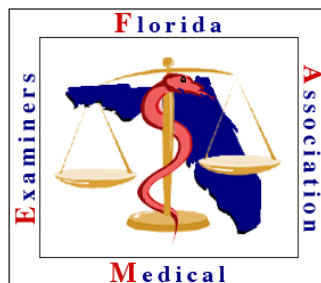
