From the Chairman of the Medical Examiners Commission

On behalf of the Medical Examiners Commission (MEC), I am pleased to provide this *Annual Workload Report* to each of our district medical examiners. Although the MEC is no longer required to submit this report to the Governor and the Legislature, the information included is invaluable to the many interested parties well beyond the boundaries of our medical examiner districts. The MEC continues to strongly believe in the value and worth of compiling this statewide data and in providing it to the general public and to policy makers alike.

The Report of Drugs Identified in Deceased Persons provides highly sought after and critical information related to drug deaths in Florida. This unique report continues to track the unfortunate results of the abuse of both prescription and illicit drugs. This report assists Florida's state and local agencies in allocating and focusing their precious resources. Dating back to 1987, this annual report was first conceptualized for tracking deaths due to cocaine, with heroin later added in 1995. The report is constantly evolving. More drugs are tracked as their abuse potential and prevalence becomes known. The Report of Drugs Identified in Deceased Persons has currently evolved to include the tracking of 46 drugs and ethanol.

One of the MEC's proudest accomplishments continues to be its joint initiative with the Florida Department of Law Enforcement (FDLE) and Florida's 25 medical examiner districts to resolve the approximately 881 unidentified deceased persons in our state. With new technology and advances in forensic science, this project continues to pay dividends for many families seeking closure of a loved one's fate. We will continue to encourage participation and provide access to various resources to reduce the backlog of these unidentified deaths.

Thank you for your on-going professional commitment to providing the State of Florida with high quality medical-legal death investigative services. This is very much a team effort and you are to be commended for your exemplary efforts and professionalism.

INTRODUCTION

The Medical Examiners Act, Chapter 406, Part I, Florida Statutes, was enacted by the 1970 Legislature in order to establish minimum and uniform standards of excellence in statewide medical examiner services. This report is compiled to illustrate the direction taken by the Medical Examiners Commission (MEC) during 2018 to ensure an effective and viable program of medical examiner services throughout Florida.

COMMISSION APPOINTMENTS

New Appointments

Honorable Charlie Cofer, J.D., the 4th Judicial Circuit's elected public defender, was appointed by Governor Rick Scott to the public defender position on the Commission. He replaces Public Defender James Purdy from the 7th Judicial Circuit. Mr. Cofer's appointment is for a term beginning August 29, 2018, and ending July 1, 2021.

Reappointments

Stephen J. Nelson, M.D., the district medical examiner of District 10, was reappointed for a term beginning August 29, 2018, and ending July 1, 2020.

Robin Giddens Sheppard, L.F.D., a licensed funeral director for Hardage Giddens Funeral Home was reappointed for a term beginning August 29, 2018, and ending July 1, 2020.

Honorable Carol Whitmore is a county commissioner in Manatee County and was reappointed for a term beginning August 29, 2018, and ending July 1, 2021.

MEDICAL EXAMINER DISTRICTS

In 2018, the Commission recommended that the medical examiners for Districts 2, 5 and 6 be reappointed by the Governor for additional three-year terms.

District 4 Medical Examiner Valerie J. Rao, M.D., retired in July 2018, and was not considered for reappointment. Additionally, District 7 is Home Rule and a new medical examiner was appointed effective April 2, 2018.

Surveys and assessments for the reappointments of district medical examiners for districts 1 (Escambia, Okaloosa, Santa Rosa and Walton counties), 2 (Franklin, Gadsden, Leon, Liberty, Jefferson, Taylor and Wakulla counties), 3 (Columbia, Hamilton, Lafayette, Madison and Suwannee counties), 5 (Citrus, Hernando, Lake, Marion and Sumter counties), and 6 (Pinellas and Pasco counties) were sent via email to the constituents of these districts in January. Surveys and assessments for the funeral homes were sent via U.S. mail in February.

Based on the survey results received from District 1, the Commission met in Destin to discuss the reappointment of District 1 Medical Examiner Andrea N. Minyard, M.D. After hearing from several of the District 1 constituents, Dr. Minyard, and discussion among the Commission members, the Commission voted unanimously to table Dr. Minyard's reappointment decision until a future MEC meeting. This would allow the Commission an opportunity to review information relating to cases where jurisdiction was declined, and allow the counties to complete

an audit and the Commission to review those findings. Due to Hurricane Michael, the meeting scheduled for November was canceled, and this issue was not discussed until the January 2019 meeting. Dr. Minyard was appointed as the Interim District 1 Medical Examiner while awaiting the Commission's decision.

District 13 Medical Examiner Mary K. Mainland, M.D., stepped down to the deputy chief medical examiner position and Kelly Devers, M.D., was named the District 13 Medical Examiner effective August 1, 2018.

District 22 Medical Examiner Riazul H. Imami, M.D., Ph.D., was reappointed by the Governor on July 27, 2018, for a term ending July 1, 2020.

Districts 5, 6, 8, 10, 12, 19, 20 and 23 were reappointed effective August 29, 2018.

District 14 Interim Medical Examiner Jay Radtke, M.D., was appointed as the District 14 Medical Examiner effective August 29, 2018.

Districts 2 and 21 were reappointed effective September 27, 2018.

Dr. Wolf was appointed District 24 (Seminole County) Interim Medical Examiner effective September 28, 2018, by State Attorney Phil Archer.

DISCIPLINARY ACTIONS

There were seven formal complaints filed in 2018. Three of the complaints were found not legally sufficient by staff, without the need for review by a probable cause panel, and one case is still under review. Three cases went before a Probable Cause Panel. In one of the three cases, it was determined that there was no violation of statute or rule. The other two cases resulted in findings of probable cause, with one case being dismissed by the Commission and the other is pending a formal hearing.

ANNUAL EDUCATIONAL CONFERENCE

The 45th Annual Educational Conference of the Florida Association of Medical Examiners was held at The Mission Inn Resort & Club in Howey-in-the-Hills. The conference was a success with around 100 attendees. The program content was excellent with positive feedback.

STATE CHILD ABUSE DEATH REVIEW COMMITTEE

District 2 Associate Medical Examiner Anthony Clark, M.D., continued to serve as the Florida Medical Examiners Commission representative on the statewide Child Abuse Death Review Committee.

VIOLENT CRIME AND DRUG CONTROL COUNCIL

District 12 Medical Examiner Russell S. Vega, M.D., continued to serve on the Violent Crime and Drug Control Council as the statutorily mandated medical examiner (F.S. §943.931(2)(i)).

UNIDENTIFIED DECEASED INITIATIVE

Unidentified deceased success stories can be attributed to many of the tools that are available to medical examiners and law enforcement when investigating unidentified decedents. Some of these tools include the NCIC/FCIC database, which contains missing person records and can include fingerprint and dental records; the Florida Unidentified Decedents Database (www.fluiddb.com); the National Missing and Unidentified Persons System "NamUs" (www.NamUS.gov); and the Unidentified Deceased Initiative online training video, which was developed by FDLE's Bureau of Professional Development and the Missing Endangered Persons Information Clearinghouse (MEPIC).

MEPIC is available to assist in the identification of unidentified medical examiner cases. Their staff can provide assistance with DNA status, fingerprint submissions, dental records, FCIC/NCIC queries on active missing persons cases, resource information, forensic artists, and the opening of cases. The Department of Homeland Security and Immigration and Customs Enforcement have fingerprint databases from undocumented aliens they have encountered. These databases are not tied into the FBI database. MEPIC can assist the medical examiners in submitting fingerprints through these databases if other avenues fail to produce results.

Sixteen success stories were reported during 2018 from Districts 8, 9, 10, 11, 16, 17, 20, 21, 22, 23 and 25. The number of solved cases has grown significantly due to the analytical and investigative efforts of the MEPIC staff. This has been especially helpful in the identification of decedents who were foreign nationals.

District 8

This case involved a deceased white male, approximately 35 to 59 years of age, who was found in 2008 floating in the Gulf of Mexico, 30 miles from Yankeetown, Levy County, Florida. The manner and cause of death is still pending further investigation. On February 26, 2018, the District 8 Medical Examiner's Office provided Inspector Pollard with the fingerprint cards for their unidentified person. The fingerprint cards were submitted to FDLE's CJIS Biometric Services, however no identification was made at the time.

On March 6, 2018, Inspector Pollard provided the deceased's fingerprint cards to Kim Cashwell, Identification Manager for the Hillsborough County Sheriff's Office (HCSO). Ms. Cashwell had been contacted by NamUs in reference to conducting a direct fingerprint comparison between this unidentified person and an HCSO missing person that NamUs believed could be a match. Ms. Cashwell contacted Inspector Pollard and advised that the unidentified person was not a match to her missing person. However, during the course of the fingerprint analysis, Ms. Cashwell came across a potential match, Robert Mitchell Howard. Inspector Pollard provided this information to CJIS Fingerprint Analyst James Pollock and requested that he conduct a direct comparison between the unidentified person's fingerprints and Robert Mitchell Howard's fingerprints. After reviewing the prints, Fingerprint Analyst Pollock advised that the deceased's prints were identified with Robert Mitchell Howard.

Senior Crime Intelligence Analyst (SCIA) Jon Rigsby conducted database searches on Howard and found that Howard was never entered as a missing person in NCIC. SCIA Rigsby was able to obtain an arrest report, booking photograph and Florida Driver's License photographs of Howard to provide to the Medical Examiner's Office. SCIA Rigsby was also able to obtain information on potential next of kin, which was also provided to the Medical Examiner's Office.

District 9/25

The first case was a body that was recovered with no distinctive scars, marks or tattoos, but NCIS indicated that there was a tattoo on the decedent's forearm. After some further investigation, the decedent was identified as a Mexican national who had been arrested by Border Patrol in the past and incorrect tattoo information was documented. The next of kin was notified.

The second case involved the body of a white Hispanic male who was recovered hanging in an orange grove in 2016. The only viable prints were three prints on one hand. Fingerprint identification was received from the CJIS Biometrics Unit that the decedent was a Mexican national who had been arrested in New Jersey in the past. The wife of the decedent was eventually located, although she had not been entered into any database.

On March 26, 2018, the District 25 Medical Examiner's Office (Osceola) contacted FDLE in reference to an unidentified deceased case involving a white male who was found fully decomposed in his hotel room on April 17, 2017. The deceased had a medical history of coronary artery disease, tachycardia, and chronic back pain. He also suffered head trauma from falling in the bathroom. The Osceola County Sheriff's Office (OCSO) investigated the case. OCSO tentatively identified the subject on scene with his hotel registration and a copy of a Florida identification card in the name of J. R. Kennedy. OCSO ran the deceased's fingerprints; however no identification was made. OCSO was also unable to locate any information on the subject's next of kin. The District 25 MEO requested assistance from FDLE in identifying the deceased and locating next of kin.

SCIA Rigsby searched the Florida Driver and Vehicle Information Database (DAVID) on "J. R. Kennedy with a date of birth of March 2, 1953". During the course of his search, SCIA Rigsby located documents in DAVID which showed that J. R. Kennedy was actually born Eliot Steven Berkowitz. In September 2013, Berkowitz legally changed his name in the state of Washington to J. R. Kennedy. Inspector Pollard requested SCIA Rigsby conduct a criminal history search on Berkowitz to determine if he had any prior arrests and may have been fingerprinted. SCIA Rigsby ran the subject's criminal history and found that he had prior arrests and provided Inspector Pollard with an FBI number. On March 26, 2018, Inspector Pollard submitted a request to FDLE's CJIS Biometric Services Unit to conduct a direct comparison of the unidentified deceased person's fingerprints to those of Berkowitz. On March 28, 2018, CJIS advised that the unidentified deceased person's prints were identified with Eliot Steven Berkowitz.

SCIA Rigsby conducted database checks on Berkowitz and was able to locate information on Berkowitz's next of kin. SCIA Rigsby also found that Berkowitz was a lawyer and was formerly registered with the Florida BAR. The fingerprint hit confirmation and information obtained by SCIA Rigsby was provided to the District 25 Medical Examiner's Office and they accepted the identification.

The fourth case involved a white Hispanic male who was found deceased on December 10, 2012, as a result of being struck by a motor vehicle in Orlando, Florida. On November 29, 2017, MEPIC received the decedent's fingerprints from the Medical Examiner's Office and ran the prints through the state, federal and Department of Homeland Security fingerprint databases, but no identifications were made. On March 29, 2018, the decedent's prints were submitted to the United States Customs and Border Patrol Missing Migrant Program and the prints were identified with Artemio Guzman-Velazquez, a Mexican national. SCIA Rigsby was able to obtain an arrest report and booking photograph of the subject from the Taft Police

Department in California to assist with the identification. On April 17, 2018, Inspector Pollard provided the information regarding the fingerprint hit and associated documents to the District 9 Medical Examiner's Office and they accepted the identification. The Orlando Police Department is currently working with the Consulate of Mexico to locate and notify the next of kin.

District 10

The first case involved a white Hispanic male approximately 30-50 years of age who died after being struck by a vehicle. CJIS Biometric Services identified the man via his fingerprints as Favel Avalos, born in Mexico. Further inquiries yielded a criminal history in Texas and Florida which provided the name Fabian Sanchez Avalos. No booking photos could be located by Texas law enforcement agencies, but the Miami-Dade Police Department located two photos of Mr. Sanchez. Despite a nearly ten year difference between the booking photos and a postmortem photo provided by the Medical Examiner's Office, Mr. Sanchez's appearance was virtually unchanged. On booking paperwork, law enforcement indicated that Mr. Sanchez stated his occupation as "roofer." No next of kin could be located for Mr. Sanchez. The Medical Examiner's Office will be contacting the Consulate of Mexico for assistance in identifying possible relatives.

The second case was identified via an extract of all available NamUs cases which pinpointed cases with available fingerprints not uploaded to NamUs. The deceased is a Hispanic male, believed to be between 18 and 30 years of age who died in a motor vehicle crash. The subject's right hand could not be fingerprinted due to burns, but the left hand contained viable fingerprints.

On April 13, 2018, MEPIC received a high resolution scan of a fingerprint card associated with the case. This card was submitted to CJIS Biometric Services with negative results. The fingerprints were then submitted to the Department of Homeland Security on April 18, 2018, and the fingerprints were identified with Javier Pablo-Tepec, a Mexican national. Contact with Immigration and Customs Enforcement (ICE) confirmed the subject's hometown in Mexico, as well as his mother's and father's names. No other information about the subject's time in the United States could be located, and the deceased may have resided in the U.S. using a fictitious identity. This information was provided to the Medical Examiner's Office, which accepted the identification.

District 11

On March 6, 2018, Inspector Pollard received a set of fingerprints pertaining to an unidentified deceased person from the District 11 Medical Examiner's Office (Miami-Dade County). The deceased was a black male, approximately 18 to 44 years of age, who was found on April 24, 1999, floating in a canal in Miami-Dade County. On March 29, 2018, Inspector Pollard submitted the deceased's fingerprints to the Department of Homeland Security for searching. The prints had previously been run through state and federal fingerprint databases and no identification had been made. The Department of Homeland Security advised that the deceased's fingerprints were identified with Jean Remy Bazile, a Haitian national. SCIA Rigsby was able to obtain a Florida Driver's License record and an arrest report and booking photograph of the subject to provide to the Medical Examiner's Office. SCIA Rigsby attempted to locate information on the subject's next of kin; however, the subject had no living next of kin in the United States. On April 16, 2018, Inspector Pollard provided the District 11 Medical Examiner's Office with the information on the fingerprint hit and they accepted the identification. The Medical Examiner's Office will be contacting the Consulate of Haiti for further assistance in identifying and notifying the subject's next of kin.

District 16

On May 24, 2018, the Monroe County Medical Examiner's Office contacted MEPIC for assistance with determining the identity of a deceased subject found in September 2017. The deceased was a 67-year-old white male who was initially identified as Dennis Lee Green. The Monroe County Sheriff's Office matched the subject's fingerprints to Florida arrest records for Dennis Green, but queries of criminal history records indicated that the subject was also known as David Eugene Speraw. In addition, a series of tips received from a citizen indicated that the deceased's true name was David Speraw, a man from Pennsylvania. With the subject's identity in doubt, the Medical Examiner's Office requested assistance in verifying the subject's true identity.

Queries of court and criminal history records for both identities returned results in Maryland and Florida using both names. Possible driver's license photos were obtained from Pennsylvania and Alabama. A booking photo from Baltimore, Maryland, matched the decedent to the name David Speraw. Open source searches located archival newspaper articles from 1990 which referenced Speraw in Pennsylvania as a person of interest in an FBI narcotics investigation.

Based on this research, the subject's birth name was determined to be David Eugene Speraw. The identity of David Lee Green appears to be either an alias adopted by the deceased or a stolen identity. No next of kin information could be located for David Speraw, but based on information provided in the citizen's tip, a possible next of kin living in Pennsylvania was identified. The Medical Examiner's Office is currently working with the Monroe County Sheriff's Office to contact this possible relative.

District 17

On December 10, 2017, skeletal remains were found in an abandoned house in Dania Beach, Florida. At the time of discovery, there were no possible names or any identifying marks, features or information to lead to a possible identification. The remains were examined by anthropology and odontology. District 17 investigators completed an NCIC packet and sent a bone sample to the University of North Texas (UNT) Human Identification Center to be analyzed and entered into CODIS. They also had a forensic artist work on the case who performed a forensic sculpture of the skull. The only unique and possible identifying item was a rope type necklace with a round glass type multicolored charm. All of the data on the case along with pictures of the clothing, forensic sculpture and necklace were added to the Broward Sheriff's Office Found and Forgotten website.

On January 8, 2018, Chief Investigator Tom Steinkamp received an email from Romy Franco with the University of North Texas Human Identification Center regarding a missing person DNA association between their case and a missing person report from Howell (New Jersey) Police Department. The UNT report stated, in part, that on July 17, 2017, they received two family reference DNA samples belonging to the mother, Christina Ethel Generoso, and a sibling, Tamar Eileen Csaszar, of missing person Jason Vincent Grabert. The family reference samples were entered into the Unidentified Human Remains and Relatives of Missing Persons indices of the Combined DNA Index System (CODIS) and an association was found. The report stated the genetic data obtained from the submitted items were consistent with the unidentified remains originating from a biological child of Ms. Generoso and from a biological sibling of Ms. Csaszar.

Mr. Steinkamp contacted Lt. Markulic with the Howell Police Department regarding their case. The report was filed on January 7, 2012, by the mother. The report advised that Jason traveled to the Fort Lauderdale, Florida area and was last known to possibly be in Cancun, Mexico. Lt. Markulic stated they have had no further info on the case since the original report and provided the contact information for Ms. Generoso.

An internet search for missing person Jason Vincent Grabert was conducted and found a missing person flyer from the GINA Missing Person Foundation. The flyer stated the missing person, Jason Vincent Grabert, was missing since January 3, 2009. The flyer stated Jason suffered from paranoid schizophrenia and stomach problems. Jason felt that he was a targeted individual from going on unauthorized websites and was looking into wilderness isolated groups as he wanted to fall off the grid. He had disappeared once, but came back in a few weeks. Jason wiped all personal information and pictures from his mother's computer before he disappeared. His mother thought he would return so there was a delay in reporting him missing. He was last seen wearing a black onyx charm with his grandmother's ashes inside.

On January 8, 2018, Mr. Steinkamp received a call from Christina Ethel Generoso. Ms. Generoso stated her son went missing in 2009 in the Fort Lauderdale area, but his cellphone was found in Iowa. Ms. Generoso stated the information from the flyer was correct. Mr. Steinkamp described the unique round glass type charm that was found on the rope type necklace at the scene. She described it as being the one Jason wore with her mother's ashes inside. Ms. Generoso stated in the middle of 2017, she went with her daughter to Rutgers University for a missing person's day where they submitted DNA.

The second case involves a decedent found in a parking lot in the city of Fort Lauderdale on April 30, 2003, in an advanced state of decomposition. One fingerprint was obtained from the decedent and was run through the FCIC/NCIC systems with no results. The Fort Lauderdale Police Department investigated local missing persons reports and entered the available information into the NCIC teletype system. A note was found among the decedent's effects, written in a foreign language that was later determined to be the Serbo-Croatian dialect. The information obtained from the note at the time did not reportedly generate any leads on the decedent's identification.

In 2010, the decedent's information was entered into the Unidentified Persons section of the NamUs website by Broward Medical Examiner Investigator Wendy Crane. A copy of the note was also uploaded onto the site with permissions set for the public to be able to view it.

In 2017, a phone call was received from a family member of Zulejha Visnjic, who had reportedly not been heard from since early 2003. Ms. Visnjic, who resided in the Hollywood area, told family that she was going to Canada to visit and/or reside with family there. The family member stated that he had viewed the details of the unidentified persons case and the note on the NamUs website. Reportedly, the handwriting was familiar, and it specifically referenced names of family members. Additionally, he stated that the decedent had immigrated to this country from Bosnia.

The fingerprint that was obtained from the decedent in 2003 was sent to US-VISIT to be run against U.S. immigration records, but no identification resulted. A US-VISIT fingerprint analyst reported that the decedent likely immigrated prior to the automated system, and her fingerprint hard copy could not be located. A decision was made to make contact with the decedent's daughter, Zana, to obtain a sample for DNA comparison. Investigator Crane contacted Carrie Sutherland of NamUs for assistance in obtaining a buccal swab from Zana, who resided in Indiana. The NamUs manager in the Midwest region was able to coordinate the submission of Zana Visnjic's DNA to the UNT lab for comparison with the remains in this case.

On February 28, 2018, communication was received that Zana Visnjic was confirmed to be a maternal relative of the remains, which were identified as Zulejha Visnjic. Investigator Crane contacted Ms. Zana Visnjic to advise her of the DNA results and unfortunately confirm her mother's death.

District 20

MEPIC received a positive hit on one of the many fingerprint cards provided by the District 20 Medical Examiner's Office and Collier County Sheriff's Office. These cases were identified for scrutiny by the use of a data extract of cases in the NamUs system. The decedent, a migrant farm worker, was initially located in the Immokalee area, where he had been the victim of blunt force trauma later determined to be a homicide. He was transported to Naples Community Hospital where he identified himself as Irraglo Faustino before passing away. That name was later determined to be false.

The Department of Homeland Security's Latent Fingerprint Unit identified the deceased as Fanstin Hidalgo-Castillo, a Mexican national. Mr. Hidalgo previously encountered the Border Patrol in 1997 when he was apprehended near the U.S.-Mexico border. He was repatriated to Mexico, but a photo was taken before his return. The name, identifying information, and photograph were provided to the Medical Examiner's Office, who reported that the photo was "exactly the same" as their unidentified decedent.

Unfortunately, no other information about the subject or encounters with him could be located, and no next of kin information was found. Given the previous mention of the name Irraglo Faustino, the subject likely resided in the U.S. using a fictitious identity. This information was passed to the District 20 Medical Examiner's Office and shared with Collier County Sheriff's Office. The Medical Examiner will coordinate with the Mexican Consulate for assistance in notifying Mr. Hidalgo's family or living relatives.

District 21

This case is from the District 21 Medical Examiner's Office (Lee County). The case involved a white Hispanic male between 21 to 35 years of age, who was found deceased on January 1, 1989. This individual was a victim of a homicide and succumbed from exsanguination as a result of a gunshot wound to the heart. A suspect was identified in this case; however it is unknown if this suspect was ever charged or prosecuted for this crime.

MEPIC began working this unidentified case in March 2017. At the time, there was no fingerprint card for the subject, so initial efforts were focused on creating a composite of the deceased and running the deceased's identification photograph through the Pinellas County Sheriff's Office facial recognition program. In May 2017, MEPIC was able to obtain a fingerprint card for the deceased from the Fort Myers Police Department. The fingerprints were run through the CJIS Biometric Services Unit and the Department of Homeland Security but the prints were not identified to any records. Reports from the Fort Myers Police Department provided potential names/aliases for the subject, which were run against databases and missing persons websites. All of those efforts were unfruitful. As a last and final attempt, the subject's fingerprints were submitted to the United States Customs and Border Patrol (CBP). On April 24, 2018, CBP advised that the subject's prints were identified with an FBI record pertaining to Kenneth Earl Henard.

SCIA Rigsby worked diligently to obtain information on Mr. Henard and his next of kin. Since this case was from 1989, all of Mr. Henard's arrests occurred prior to that year and locating records was very challenging. However, after conducting numerous phone calls to several law

enforcement agencies throughout the United States, SCIA Rigsby was able to locate a booking photograph of Mr. Henard from Longmont, Colorado. SCIA Rigsby also discovered that the subject's birth name was Kenneth Mitchell Henard, and that his father was Kenneth Earl Henard. It appeared the subject either used his father's name as an alias or was mistakenly documented under his father's name, due to his father potentially having a prior criminal history as well.

One of the more difficult tasks in the Unidentified Deceased Initiative is locating next of kin. Particularly in old cases, it becomes very difficult to locate any living next of kin. SCIA Rigsby scoured through open sources and was able to locate two possible next of kin of Mr. Henard on the website Ancestry.com. A possible daughter and possible sister identified themselves as relatives of Mr. Henard on the Ancestry.com message board between 2001 and 2008. The possible daughter specifically stated she was looking for her father, Kenneth Mitchell Henard, and provided his exact date of birth. SCIA Rigsby was able to match the subjects to their posts via email addresses they left as contact information on the message board. SCIA Rigsby was further able to obtain current addresses and a phone number for the next of kin. All of this information was provided to the District 21 Medical Examiner's Office and the Fort Myers Police Department. The Medical Examiner's Office was ecstatic about the identification. The Fort Myers Police Department made the death notification, as it is unknown what the status of their homicide investigation is at this time.

District 22

This case was identified via an extract of all available NamUs cases which pinpointed cases with available fingerprints not uploaded into NamUs. The deceased is a white Hispanic male between 40 to 60 years of age, who was found deceased on April 11, 2005, as a result of multiple injuries from a motor vehicle accident.

On April 17, 2018, MEPIC obtained and submitted the decedent's fingerprint cards to the Department of Homeland Security's Biometric Support Center. On April 20, 2018, the fingerprints were identified with Luis Alberto Moncada-Varela, a Honduran national. Information obtained from the United States Customs and Border Patrol provided further information on the subject's mother and his last known address in Honduras. Border Patrol was also able to provide a booking photograph of the subject from his illegal entry arrest in 2004. This information was provided to the District 22 Medical Examiner's Office, which accepted the identification. The District 22 Medical Examiner's Office will be working with the Florida Highway Patrol and the Consulate of Honduras to make the death notification.

District 23

The first case involved an unidentified white male between 40 to 65 years of age who died after being struck by a motor vehicle on December 22, 1991. Despite relatively poor quality fingerprints, CJIS Biometric Services identified the subject as Hugh Daniel Dolman. Contact with Immigration and Customs Enforcement officials confirmed that the subject was a Canadian citizen who had been previously deported on two occasions: once after being charged with auto theft and driving without a license in 1971 in Florida, and again in 1989 after serving two years in a federal detention facility for illegal re-entry. Mr. Dolman was known by numerous aliases and appears to have resided in Portland, Oregon, during much of his time in the United States.

The age of the records in question proved to be an impediment to locating more precise information, and Immigration and Customs Enforcement authorities indicated that Dolman's original alien file was declared lost in 2010. Mr. Dolman does not appear to have obtained any form of picture ID during his time in the United States. No driver's license records could be

associated with him in either the United States or Canada. Attempts to obtain his photo from the federal Bureau of Prisons were unsuccessful. No next of kin could be identified.

The second case involved a black male who died on May 11, 1991, after jumping in front of a tractor-trailer. No age estimate was available. CJIS Biometric Services identified the subject as Arthur Walter Shannon, born in Georgia in 1937.

Mr. Shannon had a history of misdemeanor crimes from 1960 to 1986, with most charges related to homelessness, vagrancy, public drunkenness and disorderly conduct. Due to the age of his arrests, most records and photographs of Mr. Shannon had been purged, but a search of the Palm Beach County archives located two sets of booking photographs from the 1980s. No next of kin could be identified for Mr. Shannon.

METHODOLOGY

Death statistics in Florida reflect the total number of certificates of death recorded by local county registrars of vital statistics. These include both resident and non-resident deaths. Data for 2018 was obtained from the Department of Health, Office of Vital Statistics. Rates related to deaths in this report are medical examiner cases per every 1,000 recorded deaths.

Population estimates for the state of Florida (as of April 1, 2018) were provided by the Florida Legislature's Office of Economic and Demographic Research. Unless otherwise noted, rates related to population in this report are deaths for every 1,000 residents.

Information concerning autopsy numbers and other workload distribution figures are supplied by each of the 25 medical examiner districts on the Annual Report Workload Data Form. These forms are filed annually with the MEC staff within the Florida Department of Law Enforcement by June 30 of each year.

Deaths included in this report are classified as "Natural" or "Violent." It should be noted that, for the purposes of this report, the term "Violent" includes all non-natural deaths.


