

# Organizational Updates Safety, Security & Emergency Preparedness





### **Behavioral Threat Assessments**

On May 17, 2022, the School Board of Broward County, Florida approved the creation of a Behavioral Threat Assessment (BTA) department under the Safety, Security & Emergency Preparedness Division to lead and monitor all BTA processes for all District schools, including charters.

#### **The New BTA Department Will:**

- Implement requirements of the Marjory Stoneman Douglas High School Public Safety Act, BTA state statutes and requirements of District Policy 4380 – Behavioral Threat Assessment
- Collaborate with the Special Investigative Unit to ensure inclusion of law enforcement in completing BTAs
- Provide required and ongoing professional development to school and District staff
- Ensure compliance with development of school-based BTA Core Teams,
   timely completion of BTAs and implementation of monitoring plans



### **Behavioral Threat Assessments - Continued**

- Provide support and ensure compliance with implementation of monthly Behavioral Threat Assessment meetings
- Provide real-time support to schools with completion of behavioral threat assessments and feedback to school-based teams
- Conduct quality assurance reviews of completed behavioral threat assessments and provide feedback to schools
- Assist schools with informing students, staff and the community on processes and resources to report safety and security threats
- Collaborate with Student Support Services to ensure students receive necessary support

\*Implemented processes to ensure the expedient transfer of Behavioral Threat Assessments, Monitoring Plans, Suicide Risk Assessments and Safety plans **within and outside** the school District



# **Security Staff**

- District Sworn Personnel (Police Chief, Lieutenants, Sergeant, Detectives)
- Unarmed District School-Based Security Staff (Including Floater Program)
- District Guardians (Armed Safe School Officers)
- School Resource Officers (via municipal SRO Agreements)

# Department of Education (DOE) School Hardening Grant



#### DOE School Hardening Grant – Single Point of Entry (SPoE) Video Intercom

- All schools will have an SPoE with a video intercom integrated into the Video Management System (VMS) to communicate with visitors prior to entry
- The Safety, Security & Emergency Preparedness (SSEP) Tech Team have deployed and integrated SPoE video intercom systems

 They also provide ongoing Districtwide technical and training support to the system and its users, working alongside the vendor for any support/repair needs

**Project Status:** 98% complete (Four schools left)



#### **DOE School Hardening Grant - Emergency Communications System**

#### **Scope**

- 53 Schools: High Schools, Community Centers and Colleges
- Primary Intercom Components and Classroom Call Buttons updates to enhance 2-way communications
- Interior and Exterior Speaker additions
- National Fire Protection Association (NFPA) Readiness Layer to comply with code

#### **Accomplishments**

- All 53 sites risk assessments complete
- Equipment pre-ordered to help with supply chain delay
- Resulting system will be NFPA compliant to allow integration with fire evacuation system – dual purposing speakers for complete campus coverage

**Project Status:** On target to complete December 2023



#### DOE School Hardening Grant - Video Management System (VMS)

#### District VMS 16,000+ cameras


- Over the last three years, BCPS has added 6,000 analytical cameras
- As of Spring 2022, VMS Assessment shows over 90% of cameras online and in compliance with naming convention guidelines
- The District continues to assess campus locations to add coverage, taking advantage of E-RATE to fund the conduit/cabling for additional cameras
- The centralized VMS is accessible by Broward Sheriff's Office (BSO) and municipalities, in addition to District Security Operations Center (DSOC)
- Between annual assessments, each time a repair is completed, standards are met and reviewed for naming and GPS coordinates
- The District security operations team completes annual full system assessments



### **Camera Geocoordinates**

#### Collaboration with Broward Sheriff's Office

- Field surveyors hired by BCPS walked all campus locations and documented camera GPS coordinates
- Coordinates were entered into the centralized camera system
- Specific camera locations appear on visual maps of the county at the BSO Real Time Crime Center



Project Status: 100% Complete



#### DOE School Hardening Grant - Auto Lock Door System



As part of the DOE School Hardening Grant, the District's Physical Plant Operations team began replacing door locks on classrooms and lab doors at schools with level handle locks (commonly known as "storeroom function locks").

- Project is 52% complete
- Installed roughly 8,500 of the 15,000 locks needed
- Final purchasing order of 5,000 locks was placed recently
- Project is scheduled to be completed by the end of this calendar year

# **School Safety Inspection App**



- Used by Safety and Security personnel to document compliance based on routine, comprehensive and administrative site visits
- In the past school year, an app was used to capture safety inspection requirements
- The app is used for data compilation and analysis
- A more robust app is being developed to ensure statutory compliance, best practices, and BCPS standards

#### **Hand-Held Metal Detectors**

# Policy 2010: Use of Hand-Held Metal Detectors on School District Property Board Adopted 04/05/2022

- As part of the District's overall plan to enhance safety and security, hand-held metal detectors may be randomly used to screen persons for firearms and other dangerous objects that are prohibited on School District Property by applicable law and District policies
- Pilot screenings have been completed at several schools
- Signage informing the public about this new security screening process have been delivered to all sites and are currently being installed to replace the temporary signs





# **Incident Management System**



- BCPS utilizes Microsoft Communications Tools that assists with two-way communication between school sites and District office personnel
- A more comprehensive incident management system is being researched to align with the new District's vision as it relates to incident management in collaboration with various divisions
- Security Tips continue to be managed through an updated tracking/accountability system, overseen by the District Security Operations Center (DSOC)

# Security Tips Program – In-Progress



SRO Training on Threat Assessment, Student Diversity and related topics, as well as on all District Security Operations Center (DSOC) updates and processes.

# School Safety Task Force – Report Findings

The BCPS School Safety Task Force (SSTF) met during the 2021–2022 school year to evaluate safety and security practices, policy updates and legislative activities. A final report resulted in these seven (7) recommendations:

- 1) Continue to prioritize positive school climate practices
- 2) Broaden participation in enhanced de-escalation professional training
- 3) Ensure all staff and affected families receive annual updates on procedures for accessing support after a crisis
- 4) Define and enforce emergency procedures for early morning and late afternoon/evening school site operations
- 5) Creation of a new District Behavioral Threat Assessment (BTA) department to assist schools and improve quality assurance
- 6) Improve communication to staff and parents/guardians during crisis incidents and incident follow-up
- 7) Increase behavioral support staff to support students and teachers



# School Year 2021-2022 – Total "New" Security Staff Trained – 232 Retrained "Existing" Staff for Grand Total of 939

Some high stakes 2021-2022 security training stats:

- Hand-held Wand Training: 1,050
- Tabletop Training/Exercises: 1,578
- Hurricane Shelter Staff & Volunteer Training: 686

**Training Feedback:** Staff found the training relevant and useful to their role with a 98-100% satisfaction ratings.



# Mental Health – Support for Students and Families

#### **Support for Students and Families**

- Mental health professionals (school counselors, school social workers, school psychologists and family therapists) are available at all schools
- Services include individual/group counseling as well as crisis support
- School social work service referrals can be made for supportive counseling and social service needs by staff, students and parents
- The BCPS Family Counseling Program provides up to 12 sessions of counseling, free of charge, to all Broward students and families
- Therapists are located throughout the county; Bilingual services, evening hours, and teletherapy are available
- BCPS referrals can be made by calling the BCPS Family Counseling Program main office at (754) 321-1590
- Students who require more in-depth services are referred to community providers through our Behavioral Health Partnership



# Mental Health – Support for District Staff

#### **Support for District Staff**

The District continues to make mental health, recovery and resiliency-building of our employees a priority.

- The Employee Assistance Program (EAP) is a confidential and free benefits program that utilizes a policy of support and assistance for employees and their families and has worked with thousands of employees and families since 1984
- The EAP can help to solve problems that may or may not impact job performance
- When employees seek help on their own, no administrators and/or supervisors are notified, and nothing appears in any School Board files

- BCPS is now able to issue access to all law enforcement personnel
- 2,252 Behavioral Threat Assessment (BTA) employees trained in Comprehensive School Threat Assessment Guidelines (CSTAG)

# SB70 Alyssa's Alert



- BCPS evaluated vendors and selected Motorola/SaferWatch with Alyssa's Alert in May 2021
- Successfully coordinated with Broward Sheriff's Office (BSO), City of Coral Springs and City of Plantation Public Safety Answering Points (PSAP's) to test functionality of the system
- Collaborated with SaferWatch to complete testing for Broward Charter Schools
  - Successfully completed testing on 89 of the 94 operating charter schools in Broward

BCPS schools are 100% compliant



# **Reunification Plan Implementation**

The District's reunification plan is a product resulting from the collaboration between BCPS and municipal partners, including city officials and first responders.

The implementation of this plan is being completed in three phases:

<u>Phase I</u> (Completed) – Information gathered on reunification processes/plans

<u>Phase II</u> (Completed) – Met with municipal partners to ensure comprehension and commitment to plan

Phase III (In Progress) – Collaborative meetings between school administrators, District staff, city officials and first responders to finalize reunification plans

# Rule 6A-1.0018 (Charter Safety Compliance)

The Safety Security & Emergency Preparedness (SSEP) division established a Charter School Safety Compliance unit.

- Provide Charter administrators with direct line to SSEP compliance customer service professionals
- Ensure benchmarks are met
- Oversee compliance document entries into the Charter Tools platform
- Monitor compliance of monthly Behavioral Threat Assessments (BTA) meetings in Navigate360
- Manage and review BTA data entries into EdPlan

# Preventing Recidivism through Opportunities, Mentoring, Interventions, Support and Education (P.R.O.M.I.S.E.)


#### **Description**

- PROMISE is a Pre-arrest Diversion Program
- Referred students are monitored in the Discipline Management System
- Student information is entered in the Prevention Web (Law Enforcement has access to this information)
- This program is included in the 3 civil citation options

- Florida Department of Juvenile Justice (DJJ)
- Juvenile Justice Information System (JJIS)/Prevention Web
- Interagency Agreement on Juvenile Offenders with Law Enforcement

- Interagency Agreement with School Resource Officers (SRO)
- Broward County Social Service Agencies
