## State of Florida Civil Asset Forfeiture Annual Report Fiscal Year 2018-2019

Pursuant to Section (s.) 932.7061, Florida Statutes (F.S.), every law enforcement agency shall submit an annual report to the Florida Department of Law Enforcement (FDLE) by December 1, indicating whether the agency has seized or forfeited property under the Florida Contraband Forfeiture Act and detailing receipts and expenditures of those seizures/forfeitures.

The FDLE Professionalism Division – Records Section<sup>1</sup> identified a total of **435** law enforcement agencies as of October 10, 2019. Of the 435 agencies, 32 agencies were not required to comply with the reporting requirement as they did not employ law enforcement officers.

## **Chief Financial Officer Notification:**

A total of **403** agencies were required to comply with s. 932.7061, F.S.

In February 2020, the FDLE Office of Inspector General (OIG) notified the office of the Chief Financial Officer at the Department of Financial Services (DFS) of **14** law enforcement agencies that did not submit an annual report by the prescribed deadline in accordance with s. 932.7062, F.S. FDLE OIG provided the following additional information to DFS regarding 5 of the 14 law enforcement agencies identified above:

- Cottondale Police Department submitted the agency annual report February 10, 2020;
- Bellaire Beach Marshal's Office The last employee retired in April 2018;
- Brevard County Public Schools The last employee separated in July 2014;
- Mexico Beach Police Department Agency disbanded effective November 1, 2019. The Bay County Sheriff's office entered into an agreement with Mexico Beach City to provide services; and
- Palm Beach Shores Police Department The agency merged with the Palm Beach County Sheriff's Office effective November 1, 2019. All civil asset forfeiture data (if any) is included in the Palm Beach County Sheriff's Office civil asset forfeiture annual report.

In March 2020, DFS notified the FDLE OIG that all previously non-compliant agencies had submitted their civil asset forfeiture annual reports. No financial penalties were imposed.



## **Civil Asset Forfeiture Reports**

FDLE received a total of 403 annual civil asset forfeiture reports:

- 280 Police Departments;
- 66 Sheriff's;
- 18 University/Community College Police Departments;
- 18 State Agencies; and
- 21 State Attorneys.

The summary below and the enclosed report reflect data from these reports (see Attachment A).

- Total revenue of \$26,778,347.60 from direct forfeiture, interest income or received from other agencies.
- Total expenses of \$29,491,184.57 disbursed as follows:
  - Drug treatment, drug abuse education, drug prevention, crime prevention, safe neighborhood, or school resource officer programs;
  - Matching funds for federal grants;
  - Protracted or complex investigation cost defrayment;
  - Additional equipment or expertise;
  - Automated external defibrillators for law enforcement vehicles;
  - Transferred to other law enforcement agency; and
  - Other law enforcement expenditures (see Attachment B).
- The types of property seized were as follows:
