- \$24

Ex. Foreign visas, foreign adoption, 3rd party criminal history record check companies

"Applicant & Licensees"

- Florida/National Check
- Requires fingerprints (Biometric search of CCH, other states and national databases)
- \$21.25-37.25 (Florida cost varies per statute \$8-\$24 + \$13.25 federal fee)
- · Authorized in Florida Statute/federal law

Ex. Daycare workers (DCF/\$21.25), CWP (DACS/\$28.25), school employees (districts/\$37.25)
