The Defendant is to be admitted to bail with the following special conditions (initial all that apply):

1. DW Bail may only be modified by the trial judge to whom this case is assigned or the Chief Judge of the Circuit Court and upon proof that the funds for bond are not tainted by illegal activity. See United States v. Nebbia, 357 F.2d 303 (2nd Cir. 1986), F.S. 903.046(2)(f), Winer v. Spears, 771 So.2d 621 (Fla. 3rd DCA 2000).

2. DW Prior to the Defendant's release, the Defendant must fulfill a Nebbia requirement wherein the Defendant will submit for the State's review documentation showing proof of the legality of the funds used for both the bond premium and bond collateral. The State or Defendant has the right to object and request a further hearing as to the legality of the funds.
3. DLV If for any reason, the defendant is inadvertently released without the Nebbia requirement being fulfilled, upon request the defendant shall immediately be taken back into custody regardless of whether or not he has posted a bond.
4. _____ The Defendant shall surrender his passport and travel documents to the ~~Miami-Dade County Clerk~~ ^{Indian River} ~~County Clerk~~ ^{CLC L} prior to his release. ~~The Defendant's~~ ^{Indian River} surrendered passport and travel documents shall remain in the custody of the ~~Miami-Dade~~ ^{Indian River} County Clerk until the completion of the case and the Defendant shall not reapply for any passport and travel documents.
5. DW The Defendant shall have no contact, direct or indirect, with any State's witnesses, including victims listed in the Affidavit in Support of Arrest Warrant.
6. _____ Upon release, Defendant shall submit to home confinement with electronic monitoring.
