The Florida Violent Crime and Drug Control Council, in partnership with state, county and local law enforcement, continues to play an integral role in supporting criminal investigations, helping ensure the safety and security of Florida's communities and visitors. Since its inception in 1993, the Council has initiated and supported legislation to improve the overall quality of life for Florida's citizens and visitors.

The Council oversees four individual funding categories: violent crime investigations, drug control and money laundering investigations, criminal gang investigations, and victim/witness protection reimbursement. Due to budgetary constraints, the Council has only funded victim/witness protection reimbursement requests since September 2008.

In 2020, the Legislature continued authorization for the Florida Department of Law Enforcement (FDLE) to use trust funds to support victim/witness protection reimbursement requests. The Council funded 13 victim/witness protection and relocation reimbursement requests totaling \$43,311.88 in 2020. These totals decreased compared to 2019 funding of 12 victim/witness protection reimbursement requests totaling \$53,237.08.

FDLE did not submit a FY 2021-22 legislative budget request to fund reimbursement grants for the upcoming fiscal year. It has not been determined if FDLE will be able to fund the victim/witness protective services for FY 2021-22 to reimburse state and local agencies for expenses that meet the criteria set by the Council.

## **Overview of Funding and Council Meetings**

Pursuant to Florida Statutes, the Council held one open conference meeting in December 2020 to address the future of the Council and victim/witness protection reimbursement cases funded.

The Council's six-member Victim and Witness Protection Review Committee held four closed conference meetings in March, June, September, and December of 2020. The Committee approved 13 reimbursement funding requests for a total of \$43,311.88.

FDLE continues to maintain the Council's website as a valuable source of information for the public and law enforcement community. The website contains information on Council membership, upcoming meetings, regional contacts, online forms and applications, and stepby-step application procedures.

#### **General Membership**

Pursuant to Section 943.031, Florida Statutes, the Council is comprised of 14 members. Council members receive no compensation, but are reimbursed for per diem and travel expenses. Standing members serve as long as they remain employed in the same capacity that served as the basis for their appointment and members appointed by the Governor serve two-year terms. FDLE continues to provide the support necessary to assist the Council in the performance of its duties.

### 2020 FISCAL SUMMARY

Florida Statutes require all agencies awarded Council funds to complete a report on all active/open violent crime and drug funded cases every six months. The completed report, which is provided to FDLE by the receiving agency, must detail the expenditure of Council funds during the reporting period. If a previously open/active case is closed during the reporting period, the agency must submit a final report and closing letter to FDLE. All unspent funds must be returned to the State of Florida. There were no open/active violent crime or drug cases in 2020.
