The revised Specialized Instructor Course, #801, Firearms Instructor Course (version 2023.07) was approved by the Criminal Justice Standards and Training Commission (CJSTC) on February 16, 2023. The course is 44 hours in length and outlines the changes made to the Basic Recruit Training (BRT) Criminal Justice Firearms course, instructor evaluations, forms, and courses of fire. This course will prepare criminal justice officers to become Commission-certified firearms instructors to teach the newly revised BRT Criminal Justice Firearms course, firearms re-qualifications, and in-service training.

The new BRT Firearms course for Criminal Justice Officers will go into effect for basic recruit training programs beginning on or after July 1, 2023. After July 1, 2023, only Commission-certified firearms instructors who have completed the revised Firearms Instructor Course, #801, or the Firearms Instructor Update Course, #1201, will be authorized to teach the new curriculum.

The revised Firearms Instructor Course will go into effect on July 1, 2023. Those seeking to become firearms instructors must either take the current version (2011.07), and the Firearms Instructor Update Course (version 2022.08), or they must wait until July 1st to take the new version (version 2023.07).

Specialized Instructor Course, #1114 First Aid Instructor Course

The revised Specialized Instructor Course, #1114, First Aid Instructor Course (version 2023.02), was approved by the Criminal Justice Standards and Training Commission (CJSTC) on February 16, 2023. The course is 40 hours in length and outlines the changes made to the Basic Recruit Training (BRT) Criminal Justice First Aid course, instructor evaluations, forms, and exercises. This course will prepare criminal justice officers to become Commission-certified first aid instructors to teach the newly revised BRT Criminal Justice First Aid course.

The new BRT First Aid course for Criminal Justice Officers will go into effect for basic recruit training programs beginning on or after July 1, 2023. After July 1, 2023, only Commission-certified first aid instructors who have completed the revised First Aid Instructor Course, #1114, or the First Aid Instructor Update Course, #1419, will be authorized to teach the new curriculum.

The revised First Aid Instructor Course went into effect February 16, 2023. Those seeking to become first aid instructors must take version 2023.02.

Training Center **Directors** Workshop

The 24th Training Center Directors Workshop will be held at the FDLE Headquarters on June 6-9, 2023. The workshop provides a valuable opportunity for new directors to network and to learn some best practices. Attendees may use the 28 hours of training toward their instructor retraining requirements.

The workshop was started to provide new training center directors and their staff with training on the rules and requirements related to training center certification, staffing and facilities along with information about officer training, instructor certification and requirements related to the Criminal Justice Standards and Training Trust Fund. Over the years, the workshop has evolved based on feedback from the participants to provide the most current and relevant information possible.

The workshop is open to training center directors, coordinators, and fiscal agents. Registration opened have not previously attended the workshop.





Annual Salary Incentive Compensation Reports

On January 10, 2023, the 2023 Annual Salary Incentive Compensation Reports were posted in the Automated Training Management System (ATMS) under the "Reports" tab. The report is a computer-generated list of salary incentive, training and employment records reflected in the ATMS files for criminal justice officers. Pursuant to Chapter 943.133(7), F.S., "The employing agency must annually submit information to the commission, as specified by rule, relating to all certified officers employed by or appointed to the employing agency so that the commission may update its records for all certified officers." Additionally, pursuant to Chapter 943.22(2)(i), F.S., "Each employing agency shall annually submit reports to the commission containing information relative to compensation of full-time officers employed by it." Completion of this report satisfies the requirements of Chapters 943.133(7) and 943.22(2)(i), F.S. The deadline to submit the completed report is May 26, 2023.



Training Centers Receive

Perfect Audits

Section 943.25(4), F.S., requires that the Commission establish, implement, supervise and evaluate the expenditures of the Criminal Justice Standards and Training Trust Fund for Commission-approved advanced and specialized training program courses. Rule 11B-18.010, F.A.C., requires that the Commission audit any training facility or program and fiscal agent's accounting records and procedures for compliance with laws, rules, budget provisions and contractual agreements.

New Training Schools





At its quarterly meeting on February 16, 2023, the Commission approved the requests of two organizations to become certified training schools. The Department of Financial Services, Division of Investigative and Forensic Services, in Region XV and the Escambia County Sheriff's Office in Region I were approved for Type "B" certification which grants them the authority to deliver Commission-approved law enforcement basic recruit training program courses and Commission-approved advanced and specialized training program courses.

Prior to being approved by the Commission, both organizations had to have approval from their respective regional training council to apply for certification and then participate in a needs analysis conducted by Commission staff. The needs analysis included a complete inspection of all of the proposed training facilities and interviews with the agencies and other training schools in the area to help determine if an unmet training need existed.




