Approval of Source of Dry Gas Standards For the State of Florida

Dear Mr. Renner:

The information provided to the Florida Department of Law Enforcement by Mid America Airgas, also known as AirGas, establishes the following:

- Mid America Airgas, hereafter referred to as AirGas, is a manufacturer of 0.08 g/210L ethanol dry gas standards.
- Intoximeters, Inc. is the distributor of your dry gas standards.
- Airgas produces dry gas standards that are traceable to the National Institute of Standards and Technology.
- Airgas dry gas standards are certified as to content and alcohol vapor concentration. A
  Certificate of Analysis is provided with each cylinder of dry gas standard.
- Airgas is capable of producing a minimum of 300 cylinders of dry gas standard during a thirty day period at a vapor alcohol concentration of 0.08 g/210L.
- Airgas dry gas standards are reliable for at least two years from the date of manufacture.

Based on the information provided, effective September 14, 2009, Mid America Airgas, also known as Airgas, is an approved source of dry gas standards for use in the State of Florida.

SUBJECT:

Airgas – Dry Gas Standard

Effective September 14, 2009, the Alcohol Testing Program has approved Mid America Airgas, also known as Airgas, as a source of dry gas standard for use in Florida.

The following information concerns Airgas dry gas standards:

Main Distributor:

Airgas dry gas standards may be purchased from other vendors in Florida as well.

Cylinder Size:

105 Liter Aluminum Cylinder

Concentration:

0.08 g/210L

Label:

Each Airgas dry gas standard cylinder displays a label which notes the Lot Number, Ethanol Concentration, and Expiration Date. Do not use dry gas standard cylinders

beyond their expiration date.

Certificate of Analysis:

Each Airgas dry gas standard cylinder is accompanied by a copy of the Certificate of Analysis for that lot. You need only retain one copy of the Certificate of Analysis for

Handling and Disposal:

Airgas dry gas standard cylinders should not be exposed to temperatures above 125° Farenheit. Temperatures above this could activate the safety relief valve and release

the contents.

Dry gas standard cylinders are considered hazardous materials for transport purposes in accordance with USDOT-39, Compressed Gases N.O.S. UN1956. A hazardous material transport license is required to ship dry gas standard cylinders. Always remove the dry gas standard cylinder prior to shipping an Intoxilyzer 8000.

Dispose of dry gas standard cylinders in accordance with your local or county

ordinances.
