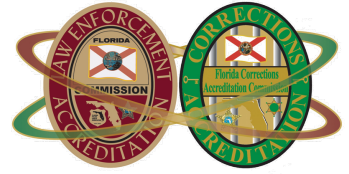

On 04/27/2022 I conducted the monthly inspections for our instruments. Instrument 80-007507 failed on the interferent controlled test. The first controlled test it was detected. On the second controlled test nothing was detected. The third controlled test it was detected again. I checked the seal on the simulator and made sure the interferent was in date. The simulator had been heating up for approximately 40 minutes. I repeated the interferent test again with the exact same results. Instrument 80-007507 was not in compliance and taken out of service awaiting repair. I then went to our second instrument and completed the inspection with no issues. I am sending instrument 7507 to you as per our telephone conversation. Thanks and have a great weekend.
