

I checked our records and could not find any deregistration paperwork for CMI Inc. Intoxilyzer 8000s 80-001267 and 80-001269.

I reviewed the Palm Beach Sheriff's Office's records for 80-001267 and 80-001269. The last agency inspection reports we have for those instruments was from 05/12/2014 agency inspection (both were in compliance with 11D-8, AI was Gregory Croucher).

I took over as the agency inspector for the Palm Beach Sheriff's Office's Intoxilyzer 8000s in February 2016. Instruments 80-001267 and 80-001269 have not been in evidentiary use during my time as PBSO's agency inspector (February 2016 to present). They currently are used only for training purposes.

Per your request, for record purposes, please consider this a formal request to deregister 80-001267 and 80-001269 as they have not been in evidentiary use for several years and we have no plans to put them back into evidentiary use for the foreseeable future.
