

1. INTRODUCTION

The Florida Department of Law Enforcement's (FDLE's) Florida CJIS Portal Interface Control Document (ICD) is a technical document that explains how contributing agencies communicate with FDLE's systems. Each contributing agency's technical staff can use this ICD to program or configure their systems to send records in the NIEM XML format through FDLE's Florida CJIS Portal (Portal). This ICD supports communication with Florida Incident Based Reporting System (FIBRS), Criminal Justice Data Transparency (CJDT), Florida Arrest Affidavit (FAA), the Computerized Criminal History (CCH) system for OBTS reporting, and LInX.

To have a complete picture of how and what to communicate with FDLE, multiple documents are needed. This document describes how to send records to FDLE. The FDLE and CJAdmin IEPDs describe the data's record formatting requirements in technical terms. Data Dictionaries are business documents that describes what needs to be sent to FDLE.

This document has four main sections:

1. **ICD Overview:** This section describes how the supporting documentation is structured.
2. **Incoming Messages:** Messages coming from Contributors that are stored in Portal, and if applicable, forwarded to the designated systems.
3. **Outgoing Messages:** Messages coming from the Florida Arrest Affidavit (FAA) System that are stored in Portal and forwarded to the agencies which have Record Management Systems (RMS) and Jail Management Systems (JMS) and are interested in consuming the Arrest Report Type. If applicable, these messages can also be forwarded to the designated systems.
4. **Account Access:** Each contributing agency must have a Service Account. Service Accounts are created based on the agency request. Requests are made by filling out the "Florida CJIS Portal Service Account Request" spreadsheet and submitting to FDLE.

1.1. REFERENCES

There are several documents that outline how to complete a successful XML submission. All of the documents referenced below are housed on CJNet and available to all criminal justice agencies. *FDLE recommends routinely checking CJNet for updates.*

Commercial vendors assisting agencies must retrieve the documentation through their client agency(ies). The latest versions of the documentation listed below are stored in the CJNet locations mentioned in the following table:

2. ICD OVERVIEW

This ICD describes how contributors submit request messages to FDLE. The ICD schema can be described as a wrapper layer around the IEPDs. The wrapper contains the request (submission of data) and response (success, warnings, and errors). Response includes schema errors as well as business rule errors. The business rules are defined between the Data Dictionaries and IEPDs.




Figure 1: ICD and IEPD Layers

There is a single wrapper schema for each IEPD version. ICD wrapper schemas are posted on CJNet. The IEPDs identify how to build the report leveraging NIEM and contains sample submissions, mapping spreadsheets for the data elements, etc. See Figure 1 for a visualization of the schema layers based on the current IEPDs.

Appendix A contains images that demonstrate the message layers in a high-level and the directory structure layering of the IEPD versus the ICD wrapper and how they align.

The next sections detail the API and schemas for incoming and outgoing messages.

3. INCOMING MESSAGES

This section describes the transaction flow, transaction API to send and receive messages, and schema definition with examples for the messages coming from Contributors and forwarded to designated systems like FAA, FIBRS, CCH, CJDT, and LInX. Incoming messages are expected to come from the Contributors via their native system. Examples of this includes Record Management Systems (RMS), Jail Management Systems (JMS), Computer Aided Dispatch (CAD), etc.



3.1. TRANSACTION FLOW

Contributing agencies will send a submission based on either CJAdmin IEPD or FDLE IEPD. The Contributor can submit NIEM XML based on the current or prior two versions of the FDLE and CJAdmin IEPDs. Accepted versions of the IEPDs are listed below.

Once a submission is received, Portal will validate the data (XML validations, business validations, etc.). If the data is valid, Portal will forward the submission to the designated systems (FAA, FIBRS, CCH, CJDT, and LInX) to process. Once the designated systems respond, Portal will aggregate all responses and send a single response to the Contributor. If the validation fails, Portal will send an error response. The designated systems may send a response as an error message or a success response. The designated systems may perform additional system-specific validations.




Figure 2: Incoming Message Transaction Flow

The following section describes the message flow between the Contributor and FDLE:

NOTE: The Contributor will use the REST (Representational State Transfer) web service API exposed by FDLE to submit the request (data) and receive a response. Refer to the Transaction API section for the web service API.

1. The Contributor system constructs the submission utilizing the appropriate XML Schema, as specified in this document. Refer to the Schema Definition section for detailed information about the XML schemas.



2. The Contributor will submit data using the FDLE REST service.
 3. Once the XML message (request) is received by the FDLE Portal it will log the request in the Portal database and place the transaction into the queue for validation.
 4. Portal will validate the request to make sure it meets the criteria as specified in the IEPD defined in the header (some business rules are enforced in the designated systems) and perform the following steps:
 - a. If the submission passes the initial header validation, the schema and global business rules are validated.
 - b. If successful, then Portal will forward the request to the designated systems based on the information available in the submission.
 - c. The designated systems will receive messages at the same time, and they will process the message synchronously. The designated systems will process the Contributor request and generate a response (if applicable) for the Contributor to consume.
 - d. For FDLE IEPD, Portal will use submission indicators to decide which designated systems will get the message. For CJAdmin IEPD, all messages will go to CJDT and only the "FBI Workforce Count" message is forwarded to FIBRS.
 5. Portal will aggregate all responses from designated systems. Portal will wait for the configured amount of time (10 seconds) to collect responses from the designated systems. All the responses received during that time will be aggregated. If any of the designated systems do not respond within the specified time interval, Portal will respond with a message that the response was not received in the designated time frame.
- NOTE:** Recommend Contributors configure a timeout to be more than 10 seconds. Portal will take a maximum of 10 seconds to send a response.
6. Portal will send a response back to the Contributor.
 7. If the response indicates an error (timeout or validation) for any of the designated systems, the Contributor will resubmit the data using the rules mentioned in the FDLE IEPD and CJAdmin IEPD. Refer to DATA INSERTS, DELETES, AND REPLACEMENTS in the FDLE IEPD "Master Document.pdf" document and refer to DATA INSERTS, DELETES, AND REPLACEMENTS in the CJAdmin IEPD "Master Document.pdf" document.

3.2. SECURITY

As part of the Contributor onboarding, FDLE will establish a service account for each contributor. The Contributor will use this credential and pass it in a request header while making a call to the Portal. The communication between the Contributor system and the FDLE Portal will be encrypted using 128-bit Encryption. If a Contributor wants to make multiple calls (batch processing), they can retrieve the security token (Bearer token) first using user ID and password and then use the token to submit messages until the token is expired.



Contributors will only be able to send data using authorized XML schemas identified in the IEPDs. Refer to the Account Access section.

3.3. TRANSACTION API

FDLE will publish the REST API, which will be used by the Contributors to send their submissions. The Contributor will send their data in either a CJAdmin Request XML Schema or FDLE Request XML Schema. In the IEPD, the schemas are referred to as Report Types.

The Contributor will use the following API to submit the data as well as receive the response from the Portal.

3.4. SCHEMA DEFINITION

3.4.1. CJAdmin IEPD Request and Response Schema Elements

The following section describes the schema layout and element definition for the CJAdmin Request and Response schemas. Contributors will be able to submit only



data (report type) that they are authorized to submit. Contributors will use the CJAdmin IEPD to submit the following records:

1. County Corrections Daily Report
2. County Corrections Weekly Report
3. County Corrections Annual Report
4. State Corrections Daily Report
5. State Corrections Annual Report
6. FBI Workforce Count Annual Report
7. Private Registry Attorney Annual Report
8. State Attorney Annual Report
9. Regional Conflict Counsel Annual Report
10. Public Defender Annual Report

The Contributors will be able to submit multiple CJAdmin reports as part of a single submission. The possible combinations are.

1. Daily
2. Weekly
3. Monthly
4. Daily – Weekly
5. Daily – Monthly
6. Weekly – Monthly
7. Daily – Weekly – Monthly




Figure 3: CJAdminIEPDRequestType




Figure 4: CJAdminIEPDHeaderType




Figure 5: CJAdminIEPDRequestPayloadType




Figure 6: CJAdminIEPDResponseType




Figure 7: CJAdminIEPDResponsePayloadType




Figure 8: *ErrorType (CJAdmin)*




Figure 9: **WarningType (CJAdmin)**




Figure 10: FDLEIEPDRequestType




Figure 11: FDLEIEPDHeaderType




Figure 12: FDLEIEPDRequestPayloadType




Figure 13: FDLEIEPDResponseType




Figure 14: FDLEIEPDResponsePayloadType




Figure 15: FDLEIEPDResponseSubSystemPayloadType




Figure 16: Error Type (FDLE)

4. OUTGOING MESSAGES

This section describes the Arrest Report data coming from FAA to the Florida CJIS Portal and how those records are consumed by the external agencies' systems like Record Management Systems (RMS) and Jail Management System (JMS). The forwarding of the Arrest report to the designated systems like FIBRS and LInX is described in the Incoming Message section. This functionally is expected this fall.

Agencies who are using the FAA application to file arrest affidavits are encouraged to pull the data from the FAA system and house in their native system for ease of access to the records. This allows for agencies to have the original stored in their files and any additional documentation can be added/maintained based on the agency's current business flow. Booking agencies and Clerks of Court would benefit from retrieving the data in an electronic and standardized format.

4.1. TRANSACTION FLOW

The following section describes the flow when FAA sends the Arrest report to Portal:




Figure 17: Outgoing Message Transaction Flow

1. The FAA user (police officer) fills out the Arrest report and submits it to the FAA.
2. The FAA validates the data based on the FAA business rules. If addresses are included in the Arrest, the FAA system makes a call to the Melissa Database to validate the addresses.
3. The FAA constructs the NIEM XML request based on the FDLE IEPD and submits it to Portal.
4. Once the request is received, Portal validates the request based on the FDLE IEPD business rules (FDLE Business Rules.pdf). If the request is invalid, Portal responds back with an error response to the FAA system.
5. Portal forwards the request to the designated system, if applicable.
6. Portal sends the request to the queue in real-time. The messages in the queue are read by Portal, to send the messages to the external agencies interested in consuming the Arrest Report.
7. Portal receives the response from the designated system, if applicable.
8. Portal sends the response from the designated system to the FAA system.
9. The FAA receives a response back from Portal.



The following describes what happens once the message is dropped into the queue:

10. Portal reads each message from the queue and stores it in the designated ORI-specific container. Portal will also route messages to one or more ORIs based on the routing rules. For example, if the routing rule says if the message is destined for **ORI1** and it should be delivered to **ORI4** and **ORI6** as well, in this particular case, the message will be stored in the **ORI1** container as well as stored in the **ORI4** and **ORI6** containers. (The routing rules will be managed by the FDLE System Administrator within the Portal UI.)
11. Portal creates (if not present) a folder hierarchy based on the MessageCreationDateTime year, MessageCreationDateTime month, and MessageCreationDateTime day, and the message (XML) is stored under the folder as shown in the diagram below. The messages stored in the container will be available for external agencies to consume for 180 days from the time the message is dropped in the folder. (The message life is configurable within FDLE Azure Tenant.)

Example XML Container Folder Hierarchy Structure:




Figure 18: Container Folder Structure

The following describes how messages can be consumed by external agency systems (JMS, RMS, etc.) from the message Container. The agency system can consume the data in real time or in batch mode. It is up to each agency system to decide which API they want to use to consume messages:

1. The agency system authenticates with Portal using a Username and Password (Service Account). Portal returns the security token to the agency system which the agency system can use to make subsequent calls. The communications between the agency system and Portal will be encrypted (FIPS 140.2) using 128-bit Encryption.
2. The agency system will make a call to Portal using a security token to read messages. The system can request messages based on a time range like the last hour, the last 4 hours, or the complete day.
3. Portal will return those messages to the external systems. The communication between the external agency will be logged in Portal.
4. Once a message is consumed, it will be moved under the “Archive” folder.



4.2. SECURITY

The agency will use a security token to retrieve the data from the container. The agency will use a service account (User ID and Password) and client ID to retrieve a token. The client ID and service account information will be provided to the agency as part of the onboarding process. The agency will use that token to make subsequent calls. The token will be valid for one hour. If the token expires, the agency system can request a new token using a service account. The data in transit will be encrypted using 128-bit Encryption. The external agency will have a single account to submit and consume messages.

Contributors will only be able to send or consume data using authorized XML schemas identified in the IEPDs. Refer to the Account Access section.

4.3. TRANSACTION API

FDLE will publish the REST Web Service for agencies to consume the data stored in the agency (ORI) specific container. As shown in the above diagram, the data will be stored in the hierarchical folder structure. The agency will use the API to get the list of the files, i.e., Arrest Reports for a given day and then make subsequent calls to retrieve each Arrest Report.

5. ACCOUNT ACCESS

To submit XML files to FDLE through the Florida CJIS Portal, a Service Account must be created. Agencies are expected to submit all applicable XML report types from a single Service Account.

FDLE requires agencies to establish a test account and successfully submit prior to receiving a production account. A single request can be submitted for both test and production. The production account creation will be dependent on a successful testing.

5.1. STEPS FOR REQUESTING A SERVICE ACCOUNT

1. Complete the “Florida CJIS Portal Service Account Request” spreadsheet to request a service account. Refer to CJNet at <http://www.flcjn.net/CJIS-Resources/Resources/FDLE-ICD.aspx>
2. Send the completed spreadsheet to FDLE at ucr@fdle.state.fl.us.
3. FDLE will establish the TEST account and email the Agency contact.



4. In the email, FDLE will provide a URL to setup the account and establish an initial password.
5. The agency contact clicks the link and directs Agency to the login landing page. *If shown the main login page, they need to click, “Forgot Your Password?”.*
6. The agency contact will enter the email address (provided in the Florida CJIS Portal Service Account Request) and click “Send Verification Code”.
7. The code will be emailed to the account email.
8. The agency contact will enter the code and click “Verify Code”.
9. The agency contact is then Navigated to a “Change Email” and “Continue” buttons. *Do not change the email address. This is the user ID.*
10. The agency contact clicks “Continue”.
11. The agency contact is prompted to enter or select a phone number. This needs to be a number immediately accessible to complete the process.
12. There should be a prompt to select either “Send Code” or “Call Me” for the code. Select one.
13. The system will send a text or call the number and provide a code.
14. The agency contact will enter in code from the text, or follow the instructions provided on the phone call.
15. Once the response is entered in correctly, the agency contact clicks “Verify Code” and is automatically directed to enter a password.
16. The agency contact is prompted to set up their password meeting the requirements listed on the screen.
17. The agency contact re-enters the password and is automatically directed to the system landing page.
18. The TEST setup is complete. Log out from the system landing page. See the Security section(s) of this document for how to use the account information.

5.2. ADDITIONAL INFORMATION

After the test submission criteria are met, as agreed by FDLE and the agency, Steps 3-18 will be repeated for the production account.




