WELCOME MEMBERS and OPENING

ITEM 1 – Florida Statute Table Operations Manager Tina Engert

Florida Department of Law Enforcement

Action Item

Sheriff Prendergast recognized Operations Manager Tina Engert who provided an overview of the updated Florida Statute Table. Manager Engert stated the updated Florida Statute Table reflects changes made by the 2021 Florida Legislature during the Regular Session. Although there is only one table, the Florida Department of Law Enforcement provides two main views. One view is the Arrest Statute Table version, which only contains the current arrestable offenses. The Clerk Statute Table version contains all arrestable offenses in addition to historical statutory information. FDLE provided a Changes Only Table, which documents all of the changes, additions, deactivations, and corrections made to the Florida Statute Table since its last update. FDLE asked the Council for the adoption of the updated Florida Statute Table, and once adopted, anticipated publishing the updated Florida Statute Table on Tuesday, November 2, 2021.

Action Item: Sheriff Prendergast asked for a motion to adopt the updated Florida Statute Table. Chief Roufa moved to adopt the updated Florida Statute Table, and Council Member Ling seconded. The motion passed.
