# **Automated Training** Management System

he culmination of two years of programming development and work has arrived. The new and improved version of the Automated Training Management System (ATMS) went live on June 23, 2017. In addition to the existing functionality of the legacy version of ATMS, the new version incorporates a number of new features. The highlights include the incorporation of the canine team certification process and the creation of a method for an officer to obtain their Global Profile Sheet automatically. The new version of ATMS is compatible with all major browsers making access much easier. Also making the transition much smoother, existing ATMS users were able to use their existing login credentials to access the new system.

As with any new software program, there are changes from the way the existing program functioned. To help minimize any disruption or delay in agencies and training schools entering officer, instructor, or student information, current ATMS users were allowed to access the new system for several weeks during May. Additionally, several training opportunities were held in May to allow ATMS users to participate in WebEx sessions to watch a demonstration of the new system.

# New Sex<br/>Crimes<br/>Investigation<br/>Course<br/>available in<br/>TNAS

n September 2016, Advanced Course #033 Sex Crimes Investigations was retired. Two separate courses, Adult Sex Crimes Investigations and Child Sex Crimes Investigations, were developed to replace the retired course. The Commission adopted Advanced Course #1170 Adult Sex Crimes Investigations at its January 2017 meeting for immediate use by agencies.

At its May 2017 meeting, the Commission adopted Advanced Course #1171 Child Sex Crimes Investigations effective May 11, 2017. This new 40-hour course was developed with the help of subject matter experts from various criminal justice agencies, the Department of Children and Families, Leon County Human Services, and the Florida Council against Sexual Violence. The Training Center Directors Association's Advanced/Specialized Training Committee provided a final review.

The Child Sex Crimes Investigations course reflects a trauma-informed and victim-centered approach to sex crimes investigations. In contrast to the retired course, it takes a more task-oriented approach to child sexual abuse investigations and outlines procedures for effectively investigating these cases while focusing on the child's wellbeing. Some of the topics covered include best practices for recognizing child sexual abuse, collecting and corroborating evidence, and preparing for a successful prosecution.

NEW AND IMPROVED AUTOMATED TRAINING MANAGEMENT SYSTEM continues

To continue to assist current and new ATMS users, the WebEx presentations were recorded and are available for viewing. An ATMS User Guide has also been produced and is available. The Field Services and Officer Records staff continue to be available to assist agency and training school ATMS users with the new system as well.

The implementation of the new ATMS does not mark an end to the programming. Over the coming months, we will continue to work to enhance the system by adding a document management system as well as a means for electronic signature and notarization of forms. There are a number of enhancements we already anticipate adding and we welcome suggestions improving the for user experience with ATMS.

The existing ATMS served our needs well for the past 20 years. The development of the new ATMS marks a milestone for technology projects. It was developed and implemented on time and under budget. We wish to thank our Command Staff for recognizing the need to replace ATMS; the Florida Legislature for appropriating the funds for replacement; our programming staff who worked tirelessly to produce a very high quality system; and all of our criminal justice partners who assisted in the testing and development of the new ATMS. The new version of ATMS is a more user-friendly and powerful tool and should provide many years of excellent service for all of Florida's criminal justice partners.

The 38 class participants serve in leadership roles criminal representing 31 justice agencies throughout the state including police departments, sheriff's offices, corrections, and state law enforcement.

The Academy consists of four week-long sessions and runs from May to August. Participants learn skills necessary to support the needs of their agencies and communities in preparation for future challenges.

The goal of the Academy is to prepare first-line supervisors in criminal justice organizations to exemplify the character and integrity expected of criminal justice professionals, while examining the various components necessary to become efficient leaders.

We are currently getting ready to launch the 40th Florida Leadership Academy Class to be hosted by the Walton County Sheriff's Office from September to December.

# FLORIDA LAW ENFORCEMENT ANALYST ACADEMY

he Florida Law Enforcement Analyst Academy is proud to announce the graduation/certification of 22 law enforcement analysts on June 9, 2017. Analysts attending this academy met one week a month for six months. The analysts are challenged with weekly assignments and quizzes, group and individual projects, and a comprehensive final exam. Successful graduates receive a state certification as a Law Enforcement Analyst.

The Florida Law Enforcement Analyst Academy was developed in 2003 by the Florida Department of Law Enforcement to provide analysts the opportunity to learn criminal and intelligence analysis skills. The curriculum for this academy incorporates the changing world of technology and resources that will provide analysts the tools needed to predict and prevent criminal activity. With the graduation of this class, twenty-seven academies have been delivered and over 600 analysts have been certified.

# **EXECUTIVE LEADERSHIP SEMINAR** WILL GRADUATE 30 CRIMINAL JUSTICE EXECUTIVES

he Florida Criminal Justice Executive Institute will be graduating 30 criminal justice executives from the Executive Leadership Seminar on August 4, 2017. Seminar participants have been meeting at FDLE Headquarters since May and engaging in training on topics such as communicating through a crisis, critical thinking, leading people, managing organizations, overcoming adversity, emotional intelligence, and servant leadership. The Executive Leadership Seminar is an educational opportunity for the upper management leadership of Florida criminal justice organizations.

The Florida Criminal Justice Executive Institute, established within the Florida Department of Law Enforcement and affiliated with the State University System, was established in 1990 by the Florida Legislature to address the need for an innovative and multi-faceted approach to the education and training of criminal justice professionals.

# Commission Adopts Community Safety Report

ne of the biggest challenges in law enforcement today involves strengthening the relationship between law enforcement officers the communities they serve. and **Representatives from the Criminal Justice** Standards and Training Commission, Florida Sheriffs Association, the Florida Police Chiefs Association, the State Law Enforcement Chiefs' Association, the Police Benevolent Association, the Fraternal Order of Police, training academy directors, citizens, and law enforcement executives all joined together in a series of meetings to develop the report: Strengthening the Bonds of Trust between Law Enforcement and the Public.

The findings in this report focus on taking a proactive approach for developing longterm, practical solutions. The intent is to find ways to develop solid partnerships between law enforcement and the public. Recommendations in the report are made to all stakeholders including the Commission, local law enforcement agencies, the Florida Criminal Justice Executive Institute, and the public.

In May, the Commission adopted the report and approved recommendations to enhance the Commission's basic and post-basic training programs. The report does not obligate an agency or its officers to perform any of the recommendations, but provides a resource for all members of the community to begin improving relationships. The inductees were nominated by the Florida Sheriffs Association, Florida Police Chiefs Association, Police Benevolent Association, Fraternal Order of Police and the State Law Enforcement Chiefs' Association and then were selected by a committee. The inductees were approved by Governor Rick Scott and Florida's Cabinet at their January 24, 2017meeting.

**Richard M. Beary**, University of Central Florida Chief of Police Nominated by the Florida Police Chiefs Association

Chief Bearv has served more than 39 years in state and local law enforcement agencies. He began his career in 1977 with the Altamonte Springs Police Department, and in 1992 was named chief of police for Lake Mary Police Department, where he remained until he retired in June 2007. Immediately following his retirement, he was named chief of police for the University of Central Florida, where he is still actively serving. He has served as president for the Florida Police Chiefs Association and the International Association of Chiefs of Police (IACP). He has provided testimony before Congress, the Florida Legislature, and the President's Task Force on 21st Century Policing.

Hall of Fame continued

His tenure as IACP (2014-2015) president was among the most challenging in the history of the organization enforcement as law faced immense scrutiny from federal and state governments, as well as the public, for a number of high profile use of force incidents. As IACP president, he passionately defended the profession and brought attention law enforcement's to successes and complex challenges.

William B. Berger, former chief of police for North Miami Beach and Palm Bay Police Departments, current U.S. Marshal for the Middle District of

Florida Nominated by the Florida Police Chiefs Association.

Marshal Berger has dedicated 42 years to public service and public safety. His career began in 1974 with the Miami Police Department, where he was instrumental in significantly increasing the number of robbery, homicide, and sexual battery cases solved during the turbulent 1980s. From 1989 to 2004, he served as chief of police for North Miami Beach Police Department. Under his leadership, North Miami Beach was recognized as one of the most technologically advanced police departments in the country. In 2004, he was named chief of police for Palm Bay Police Department, where he continued to create and implement new programs and use technology to enhance policing. He has served as president for the Florida Police Chiefs Association (FPCA) and the International Association of Chiefs of Police. On December 19, 2010, he was appointed by President Barack Obama as U.S. Marshal for the Middle District of Florida. He is a four time recipient of the prestigious FPCA Director's Award, now referred to as the Law Enforcement Executive of the Year Award.

James T. Moore, former Commissioner of the Florida Department of Law Enforcement Nominated by the State Law Enforcement Chiefs' Association.

Commissioner Moore began his career with the Florida Department of Law Enforcement in 1973. He started in an entry-level position and worked his way through the ranks to ultimately be appointed as Commissioner in 1988 by Governor Bob Martinez and the Florida Cabinet. He served as Commissioner under two more governors until his retirement in 2003. During his tenure as Commissioner, his focus provided more effective service to local law enforcement agencies, brought technology enhancements to the departments forensic and information services divisions, and involved the public in the recovery of missing children and the identification of sexual offenders and predators. His concentration on executive development led to the establishment of the Florida Criminal Justice Executive Institute. Following the tragedy of September 11, 2001, his leadership led to the establishment of Florida's domestic infrastructure, security which continues to provide a framework for managing and reducing potential threats to national and state security.

**Neil J. Perry**, former St. Johns County Sheriff Nominated by the Florida Sheriffs Association.

Sheriff Perry began his career as a reserve patrol officer with St. Augustine Police Department in 1968 prior to becoming a deputy sheriff with St. Johns County Sheriff's Office in 1974. He was elected St. Johns County Sheriff in 1984 and re-elected for five additional terms until his retirement on December 31, 2004. He displayed commitment and devotion to the profession by serving as president of the Florida Sheriffs Association, chairman of the Florida Youth Ranches, chairman of the Commission on Florida Law Enforcement Accreditation, and chairman and co-founder of the Florida Criminal Justice Executive Institute. His commitment to create an accreditation program for Florida led to the establishment of an award named after him. In addition to his distinguished law enforcement career, he also served his country with the Florida National Guard, retiring as a colonel. Sheriff Perry, who died in 2012, will be remembered for his visionary leadership and civic involvement.

**J.M. "Buddy" Phillips**, former Suwannee County Sheriff Nominated by the Florida Sheriffs Association.

Sheriff Phillips served 45 years in law enforcement in Florida, beginning his career as a deputy sheriff with Suwannee County Sheriff's Office in 1963. He was elected sheriff of Suwannee County in 1968, where he served one term before joining the Florida Department of Law Enforcement in 1973. At the Florida Department of Law Enforcement, he became the director of mutual aid, which is vital to Florida's law enforcement community allowing sheriffs and chiefs to share resources and manpower across jurisdictions during emergency situations. In 1988, he was selected to be the executive director of the Florida Sheriffs Association, where he served through his retirement in March 2002. Due in part to his ability to bring stability to an agency, he was appointed by three different governors to serve as sheriff in Flagler, Glades, Columbia, Pasco, Charlotte, and Lake counties between 1983 and 2004, and was the only person to serve as sheriff in seven different Florida counties. Sheriff Phillips died in 2008 and will be remembered as "Florida's Sheriff".

The Florida Law Enforcement Officers' Hall of Fame was created by the 2014 Florida Legislature to recognize and honor law enforcement officers who put their lives on the line for the safety and protection of Florida's citizens and visitors through their works, service and exemplary accomplishments.
