# Distance Learning:

### Criminal Justice Community Discusses Officer Training

or a number of years, several of the Commission-certified training schools directors have consistently voiced a desire to incorporate the use of technology, i.e., distance learning, into their criminal justice training programs. During the May 2012 Florida Criminal Justice Training Center Directors Association meeting, questions regarding the expansion of distance/eLearning to Basic Recruit and Advanced training were revisited as part of the discussion regarding changes to Rule 11B-35.001(12)(d) 11B-35.007(8), F.A.C., which were approved and finalized in March 2012. These rule changes allowed for eLearning for Specialized training programs. FDLE Professionalism Program staff, as part of their duties in support of the Criminal Justice Standards and Training Commission (CJSTC), were asked to prepare a set of draft rules for the training center directors' review and comment at their August 2012 meeting.

Any change in the structure of the Basic Recruit or Advanced training program is normally proffered by administrative code rule changes. The draft rule changes presented to the training schools in August 2012 were intended to continue the discussion on distance learning. There is no intent by FDLE to proffer a rule to the Commission until discussion on this topic is complete. The rule as drafted would allow, but not mandate, the expansion of eLearning to Basic and Advanced training courses. The draft rule in discussion indicates all eLearning/distance learning programs must be instructor led and meet current minimum course standards in order to utilize CJST Trust Fund monies. CJSTC funding cannot be utilized for Basic Recruit programs.

A workshop is being scheduled for the October CJSTC meeting to provide additional information about how eLearning/distance learning is being used by current training centers, academic institutions, and the military. To clarify: this workshop is not for vendors nor are any vendors being invited. The intent of the workshop is to demonstrate various uses of distance learning by criminal justice entities, training schools, and the military. Additional workshops may be held in the future.

The following Questions and Answers are being provided to ensure that consistent information is being shared with criminal justice professionals statewide, all of whom have a stake in the training of our basic recruits, as well as our currently certified officers.

### What is distance learning?

There are many facets to distance learning, sometimes called eLearning. The type of program that is under discussion is not a CD ROM or video presentation alone, where a student sits and reads, listens to dialogue, or watches a video before taking a quiz. In fact, the current in-service online training offerings by FDLE will not meet the requirements spelled out in the initial rule draft. FDLE is promoting instructor-led distance learning, where students and instructors alike can take advantage of tools such as discussion forums, interactive quizzes, and one-on-one communication. Unlike student-led distance learning, which typically focuses on pre-recorded videos or lectures, FDLE is proposing instructor-led interactive learning methodologies.

### Are training schools required to use eLearning in their delivery of CJSTC courses?

No. Distance learning is just one method of delivering training to officers.

### What is FDLE's role in distance learning?

FDLE's commitment to developing effective, relevant, and quality training for all basic recruits and criminal justice officers has not changed. Training officers to perform their job duties safely is the top priority and will not be compromised. FDLE assists Commission staff and helps guide discussion and draft rules that allow the training centers to take advantage of the latest trends in technology, instruction, and education. The rules should not limit the abilities of centers to conduct training they feel is appropriate given their resources and demographics. As long as minimum standards and approved curriculum guide the training and certification process, and therefore the "readiness" of students to serve as officers anywhere in Florida, training centers have the latitude to administer Basic Recruit, Advanced and Specialized programs according to their needs.

### What rule revisions will be necessary to implement distance learning in the Basic Recruit training programs?

Rule revisions similar to those done to implement eLearning and Specialized training programs will be necessary to extend distance learning to courses in the Advanced training program and the Basic Recruit training programs. Currently, the CJSTC rules allow courses in the Specialized training program, including courses created from the Commission's Specialized Goals and Objectives Notebook, to be delivered in an eLearning format. The oversight of delivery for Specialized programs is the same regardless of the delivery mechanism. Conformity with minimum standards shall be documented on the eLearning Course Minimum Standards, Form CJSTC-18, created December 16, 2010, (effective 5/2012), prior to delivery of the course and shall be maintained in the course file. An electronic copy of the corresponding course shall be maintained for a minimum of five years, and upon request shall be made available for review by Commission staff. ### Will distance learning be mandated for all of the Basic Recruit training programs?

No. There is not a proposal in discussion that would mandate distance learning for any portion of Basic Recruit training. The discussion is to allow training schools the option of including distance learning for the Basic Recruit training program.

### What is meant by "blended learning"?

Not all courses may be suitable for full delivery through distance learning. Some parts of a course could be delivered via eLearning and others in the traditional classroom setting. Distance learning is particularly fitting for cognitive learning versus hands-on learning. A blended learning approach can be very effective and allows instructors to concentrate on skill development and application training during classroom hours. Hybrid classes also can save classroom space.

There is a fear that the use of distance learning in the Basic Recruit training programs will produce a recruit without the ability to interact with the public or respond appropriately in threat situations. How would FDLE respond to this concern?

Training centers will, as always, remain in control of mentoring recruits and preparing them to meet the professional expectations of criminal justice agencies. Whether this consists of traditional physical team building exercises, marching in formation, uniform inspections or new processes is entirely up to the training center.

In the current Basic Recruit program, even without distance learning, interpersonal skills, defensive tactics, and report writing are all major concerns, which the training school directors and Commission staff are always looking for ways to improve. The type of distance learning program that is being discussed may have the potential to enhance training in some of these areas. It would be left up to the schools to use this technology where they find it is most effective in training recruits or veteran officers. It is hoped that during the discussions those associated with officer training will consider ways to use distance learning to enhance training as is done effectively within the military, federal law enforcement programs and many college programs.

# Will officers who take an Advanced training course in an eLearning format be eligible for salary incentive dollars?

Yes. If an officer's employing agency has approved the course for salary incentive, the officer will be eligible to receive salary incentive dollars, regardless of the delivery method that was used for the course.

# How will the training hours be counted for eLearning courses? For example, if a course is 40 hours and an officer completes the training in 30 hours, how much credit will he receive?

Under current rules officers will receive full credit for completion of a Specialized training course. This means that if the required seat hours for a course is 40 hours, then the officer taking that same course through distance learning would receive the same 40 hour credit. This is referred to in rule as "officer training units." How the hours will be applied to Basic Recruit training is something that is still under discussion; FDLE will work with training center directors to determine the best solution.

### Who will develop distance learning courses?

Within the current rule, training centers may create distance learning courses using the goals and objectives from any current CJSTC-approved course already in the Specialized training program. Training centers may also create eLearning courses from the Specialized Goals and Objectives Notebook. Any eLearning course must be developed under the criteria specified in CJSTC rules. Distance learning courses would be governed by the CJSTC-approved curriculum if eLearning is expanded to Basic Recruit and Advanced training programs.

# If the Commission approves distance learning for Basic Recruit training, will all of the Basic Recruit courses be converted to eLearning format?

It is up to training schools to determine which courses or portions of courses they will offer via distance learning. Distance learning would not replace classroom instruction—it will just become another option for delivering the training. Distance learning will not change any requirements regarding the demonstration of proficiency in particular areas of the Basic Recruit curriculum (or Advanced or Specialized programs).

# May the Basic High Liability and Instructor courses which require demonstration of proficiency skills be delivered in an eLearning format?

Under the current rules, the High Liability courses cannot be given through distance learning because they are part of the Basic Recruit training program. However, because the Instructor courses are part of the Specialized training program, they may be delivered through eLearning. It will be up to the training centers to determine the efficacy of that delivery method for those courses. A blended approach for these courses may be ideal. Cognitive portions could be taught through distance learning, leaving more time in the classroom for skill proficiencies, role-playing and scenarios.

### Will training schools be able to use trust fund monies for courses delivered through eLearning?

The current rule allows for the use of trust fund monies for Specialized courses delivered through eLearning so long as they meet all rule requirements. If the rule is expanded based on current discussion, trust fund dollars would be authorized for Advanced courses. Trust fund monies will not be authorized for use in Basic Recruit programs.

# If a CJSTC course is taught through distance learning, will a school be required to use a CJSTC-certified instructor?

Yes. The rules requiring certified instructors have not changed.

# Is it FDLE's intention to eventually run all Basic Recruit classes by distance learning through FDLE and use the training schools only for High Liability training?

No, FDLE has no intention of delivering Basic Recruit training. Distance learning will be offered only as an alternative delivery method. The decision to use or not use this method of delivery will rest solely with the training center director.

### How will distance learning training be monitored for compliance?

The training center director will allow Commission staff online access to monitor and assess training and interaction between students and instructors in real time. In addition, Commission staff shall be able to monitor and assess the activities of the instructor on-site while training is being conducted. Course file requirements will be maintained in accordance with current rules pertaining to trust fund audits.

### Commission Approves Revised Post-Basic Courses



t its August 2012 meeting, the Criminal Justice Standards and Training Commission approved several Post-Basic courses that were recently revised by the Curriculum Development Section within the Bureau of Training. The following updated courses will become effective on October 1, 2012:

- Special Populations, Specialized Course 1149 (32 hours), was revised to clearly instruct the differences between mental illness, developmental disabilities, and physical disabilities. New training now instructs officers about interacting with persons with autism.
- Crimes Against the Elderly, Advanced Course 100 (40 hours), was revised to provide understanding of
  Florida laws to protect elderly adult populations. The course includes trends and statistics related to the
  elderly in Florida and real-life examples of their abuse, neglect, and exploitation. The course also updates
  medical and mental issues and provides suggested resources available to enhance law enforcement's
  response for assisting elders.
- Elder Abuse Investigations, Specialized Course 1185 (4 hours), instructs officers how to respond to an elder in crisis and investigate a crime against an elderly person. Current trends and statistics related to the elderly in Florida are included in this course. Officers will also gain some experience with elder abuse investigations through role-play scenarios.
- Gangs and Security Threat Groups, Advanced 1163 (40 hours), was revised to provide an overview of investigating gangs and security threat groups for the officer and investigator with limited experience in this area. It provides a framework for a collaborative response among agencies. The revision also includes updated national, regional, state, and local gang trends and criminal activity.
- Advanced Investigative Techniques of Human Trafficking Offenses, Advanced Course 1166 (40 hours), was revised to include the latest human trafficking crime trends. New information included in this revised version of the course includes the following topics: coercion; runaways and domestic minor sex trafficking; 2011 updates to the federal Trafficking Victims Protection Reauthorization Act (TVPRA); updates to the Florida Statutes and Florida's Safe Harbor Act; new local, state, and federal resources; basic awareness of the crimes, members, characteristics, and cultures of gangs and casinos involved in sex trafficking; U-Visas, Special Immigrant Juvenile Status (SIJS)-Visas, and the Unaccompanied Refugee Minor (URM) Program.
- Investigation and Supervision of Officer-Involved Deadly Force Incidents, Advanced Course 1152 (40 hours), was rewritten to provide a broader application of laws common to all judicial circuits in the state, while giving the instructor latitude in addressing the specific needs and requirements of each circuit. Nearly half the course hours are devoted to providing practice and application through scenarios. The name of the course was changed to apply to the investigation of all deadly force incidents, not only shootings. Unlike the previous courses, this course became effective on August 9, 2012.

# State Officer Certification Examination Statistics Fourth Quarter, FY 2011-12

t each quarterly meeting of the Criminal Justice Standards and Training Commission, results for the State Officer Certification Examination (SOCE) are reported as part of the informational agenda. The SOCE was administered 11 times in the months of April through June, 2012. The following represents the overall results for the period:

During this time period, students from St. Petersburg and Withlacoochee Technical Institute achieved a 100% pass rate on the Law Enforcement SOCE on their first attempt.

On the Corrections SOCE, Brevard Community College and Polk State College achieved a 100% pass rate for students taking the SOCE for the first time.

### SECURITY REQUIREMENTS

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures have been implemented. Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number. If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.



### MANDATORY RETRAINING FOR 2013

**22,972** officers are required to complete mandatory retraining by June 30, 2013. As of September 5, 2012, 4,753 officers (21 percent) have met the required training for Fiscal Year 2012-2013.



Officers who do not complete the required mandatory retraining on or before June 30, 2013 will be ineligible to perform the duties of a criminal justice officer until the requirements are met.

The officer will be separated in ATMS effective July 1, 2013.

### Florida Accreditation Summer Conference Recognizes Awards Winners

The Florida Accreditation conference was held June 25-29, 2012 at the Hyatt Regency Coconut Point in Bonita Springs.

The Florida Corrections Accreditation Commission (FCAC) met on June 26, 2012. The first order of business was to grant excelsior reaccreditation to the Jacksonville Corrections Department and the Marion County Sheriff's Office Jail. This is the first time in FCAC history that any agency has been granted excelsior status, which means the agency has successfully completed five reaccreditations without conditions. Other facilities receiving reaccreditation in Bonita Springs included the Clay County Corrections Bureau, Suwannee County Sheriff's Office Jail, Osceola County Corrections Department, Sumter County Sheriff's Office Detention Facility, and the Lee County Pretrial Services Department.

## Penalty Guidelines Task Force to Meet in 2013

Section 943.1395(7)(a)-(e), Florida Statutes, authorizes the Criminal Justice Standards and Training Commission to impose disciplinary action against an officer's certification ranging from the issuance of a reprimand to revocation of certification. The Commission has established general and specific penalty guidelines under Rule 11B-27.005(5), Florida Administrative Code, for felony offenses, specific enumerated misdemeanor offenses, non-criminal offenses, and violations involving the unlawful use of controlled substances. The Commission uses these penalty guidelines in determining appropriate disciplinary recommendations regarding the certification of sworn officers in the state of Florida. Additionally, Section 943.1395(8)(b)2 states:

On or before July 1 of each odd-numbered year, the commission shall conduct a workshop to receive public comment and evaluate disciplinary guidelines and penalties. The commission chair shall appoint a 12-member advisory panel, composed of six officers and six representatives of criminal justice management positions, to make recommendations to the commission concerning disciplinary guidelines.

The Commission plans to conduct this workshop as a Penalty Guidelines Task Force meeting during the first quarter of calendar year 2013.
