Commission Welcomes Recent Appointees, Elects A New Chairperson

On July 24, 2013, Governor Rick Scott appointed five new members and reappointed one member to the Criminal Justice Standards and Training Commission. The newly appointed members were welcomed to their first meeting of the Commission on Thursday, August 8, in Ponte Vedra Beach. The new appointees are:

- *Chief Van Toth* with the Hialeah Gardens Police Department, who is appointed for a term beginning July 24, 2013, and ending August 1, 2014;
- Sergeant Steve Bolger with the Hollywood Police Department, is appointed for a term beginning August 2, 2013, and ending August 1, 2017;
- **Detective Nicholas Marolda, Jr.** with the Lakeland Police Department, who is appointed for a tem beginning August 2, 2013, and ending August 1, 2017;
- *Correctional Officer Benito Arzon* with the Orange County Department of Corrections, is appointed for a term beginning July 24, 2013, and ending August 1, 2014; and
- *Mr. William Harriss*, former city manager of St. Augustine, who fills the citizen position on the Commission; he is appointed for a term beginning August 2, 2013, and ending August 1, 2017.

Reappointed for a second term is *Sheriff John Rutherford* of Jacksonville. His reappointment begins August 2, 2013, and ends August 1, 2017.

At the Commission's quarterly meeting on August 8, *Sheriff Susan Benton* was elected to chair the body for one year, and *Training Center Director Greg S*. *Hutching* was re-elected for a second term as vice chair. Subsection 943.11(2), Florida Statutes, requires that the Commission annually elect its chair and other officers.

Two additional appointments were made by Governor Scott on September 4:

- *Major Susan Jeter*, jail administrator with the Brevard County Sheriff's Office, is appointed for a term beginning September 4, 2013, and ending August 1, 2015; and
- Sergeant Matthew Williams with the Clay County Sheriff's Office, whose initial appointment expired August 1, is reappointed for a term beginning September 4, 2013, and ending August 1, 2017.

The next quarterly meeting of the Commission is scheduled for November 7, 2013 in Destin, Florida.

ARRIVALS and PROMOTIONS



Over the past six months, the Alcohol Testing Program (ATP) has experienced a period of transition, but is stronger. A Quality Assurance Manager position was created to ensure the quality of activities within ATP, and align the program with internationally recognized accreditation standards.

In June 2013, Patrick Murphy, Ph.D., M.Div., M.S., was appointed to the position of ATP program manager. Prior to joining FDLE, Dr. Murphy was the primary metrologist for NASA at the Ames Research Center Standards Laboratory, a Navy Primary Laboratory metrologist, a Naval Standards Laboratory supervisor electronics technician, and a Naval Calibration Laboratory electronic technician for the U.S. Navy. Dr. Murphy joined FDLE in 2006 in the Professional Compliance section within Professionalism. In 2008, he became a department inspector in ATP. In that role, his primary responsibility was to ensure the scientific accuracy and reliability of the qualitative and quantitative determinations of alcohol in the human body as they relate to subject breath tests occurring in various counties in Florida.

In July 2013, **Brett Kirkland, Ph.D.**, was appointed as ATP quality assurance manager. Dr. Kirkland's doctorate is in microbiology and cell science, with a strong foundation in chemistry and biochemistry. His experience includes more than 10 years of research in a broad range of fields. Most recently, Dr. Kirkland was a postdoctoral associate with Florida State University in the department of chemical and biomedical engineering. He was also a graduate research assistant at the University of Florida (2004-10).

Additional new staff for the program includes two new department inspectors, a customer service specialist and part-time administrative support. In July and August 2013, **Stuart Nincehelser** and **Michael Simmons** became the newest department inspectors for ATP. Over the next year they will receive in-depth training on the Intoxilyzer instruments and the scientific theory regarding alcohol and its physiological effects on the body.

Raven Davis joined ATP in May 2013 as a criminal justice customer service specialist. In this role, she will assist with the operational activities of ATP to include scheduling annual inspections of Intoxilyzer instruments, processing certification records for breath test courses, processing blood proficiency test results, and maintaining ATP's web page.

Also in May, **Brittany Christie** joined ATP as an OPS senior clerk while she completes her Masters in Communication at Florida State University. She provides administrative support to the unit through filing, scanning documents, answering the phone, and other administrative activities.

During this time period, students from Hillsborough Community College, Northeast Florida Criminal Justice Training and Education Center, and Santa Fe College achieved a 100 percent pass rate on the Law Enforcement SOCE on their first attempt.

On the Corrections SOCE, **Santa Fe College** achieved a 100 percent pass rate for students taking the SOCE for the first time.

Training schools may access the SOCE results for their students via ATMS. The report contains the name, examination information, type of training completed and results for each student from that school for the selected time frame. To run the report after logging in to ATMS, select the **Administration** button from the choices on the left side of the screen. Then select **Reports** and scroll down to **Training Center Reports**. The report is titled **Student Results by School**.

Commission Approves Criminal Justice Diving Course

The FDLE Bureau of Training recently revised Advanced Course 077, Underwater Police Science and Technology, to incorporate the latest technology and procedures in criminal justice underwater diving. This is the first revision of the course since 1986. The subject matter experts who developed this course are active criminal justice divers employed by Florida agencies.

The Criminal Justice Standards and Training Commission approved a field test of the revised course in August 2012. Two training schools, the Northeast Florida Criminal Justice Training and Education Center in conjunction with the Jacksonville Sheriff's Office and the Florida Keys Community College Institute for Public Safety, conducted field tests to validate the course content, hours and proficiency exercises.

In May 2013, the Commission approved the final version of the 80-hour course, effective May 9, 2013. Major revisions focus on course prerequisites, mandatory diver skills assessment, a new instructor certification, and course delivery requirements.

Course Prerequisites

To take this advanced course, officers must meet certain entry requirements. First, they must be assigned to a dive team in a criminal justice agency or have special approval from their agency and the training school to attend the course. Second, they must possess current certifications in First Aid, CPR, AED, O2 Provider and Advanced Open Water Scuba Diver.

Diver Skills Assessment

Because of the high liability nature of this course and the need for safety, it is imperative that officers prove basic skills at the beginning of the course. Instructors will evaluate students' swimming skills, their basic scuba skills, and their level of confidence in high-stress situations or when navigating dark, confined, obstructed or dangerous water environments. These assessments are recorded on a new form, CJSTC-19 Criminal Justice Performance Evaluation.

New Instructor Certification

To instruct the Underwater Police Science and Technology course, an instructor must possess a General Instructor Certification and a Criminal Justice Diving Instructor Certification. To become certified with a diving certification, an applicant must possess and maintain a current Scuba Instructor Certification or a Dive Master Certification, with specific experience and other qualifications as specified in rule. There is no instructor course; instead, a Diving Instructor Certification is obtained based on qualifications. This instructor certification requirement will take effect upon the final adoption of CJSTC rules.

Delivery Requirements

The revised course requires an instructor-to-student ratio, recommends a class size limit, and provides dismissal guidelines to ensure the safety of all participants and minimize liability for training schools and criminal justice agencies.

New Rules

With the development of this new course, new CJSTC rules will be required. The new rules are in the development phase now with an expected final adoption date of mid-2014. At that time, FDLE will issue a technical memorandum explaining the specific rules affecting the Underwater Police Science and Technology course.

Computer Based Testing Makes Progress Toward Full Implementation

In February of 2013, the Florida Department of Law Enforcement (FDLE) entered into a contract with Pearson VUE for the computer-based administration of the State Officer Certification Exam (SOCE). Since then, FDLE and Pearson VUE have worked behind the scenes to establish procedures to automatically and securely transmit and process exam related data. This work is scheduled to conclude in October, 2013.

The official rollout of computer-based testing will occur in three phases. The first phase, beginning November 1, 2013, will include test sites that, by that date, are ready to schedule the SOCE for administration. The second phase will include test sites that are ready by February 1, 2014. The remainder of test sites will be included in the third phase. FDLE will not administer any paper-and-pencil exams after June 30, 2014.

Along with the behind-the-scenes work at FDLE and Pearson VUE, prospective test sites need to be set up and authorized. In order to administer the SOCE, a test site must meet requirements outlined by both FDLE and Pearson VUE. Approved test sites will then enter into contractual

agreements with FDLE (for regulatory purposes), and Pearson VUE (for operational purposes).

Once computer-based testing is implemented, FDLE will provide Pearson VUE with a list of all individuals eligible to take the SOCE. An automated process will then use ATMS data to update the list of eligible individuals each night. Only eligible individuals will be able to schedule their SOCE. For this reason, it is important that criminal justice training centers promptly enter recruits' final grades in ATMS. A recruit will be able to create an account and schedule the SOCE as soon as the eligibility record is transmitted to Pearson VUE. Exams must be scheduled at least 24 hours in advance to allow for the transmission of exam data to the test site.

Another change to the certification process for criminal justice officers involves the availability of exam results. Hiring agencies should retrieve applicants' exam results from ATMS rather than relying on printed score reports; ATMS will be the sole official source for exam results. Applicants' results will be available in ATMS the day after their exam.

2013 Criminal Justice Training School Customer Satisfaction Survey

s a part of the recertification process for Commission-approved training centers, a survey of all criminal justice agencies is conducted to receive feedback regarding the service being provided by the training centers to the agencies. The survey must be conducted twice during each five-year certification period. Beginning on September 3, 2013, the **2013 Criminal Justice Training School Customer Satisfaction Survey** will be available for criminal justice agencies to evaluate the training centers they utilize. The survey will be conducted online, and can be accessed through a link on the FDLE website or a link in ATMS. Agencies will have until October 11, 2013 to complete their surveys.

Once the survey time ends, the results for each training center will be compiled and provided to the training center director for review and then presented to the Commission at its quarterly meeting to be held on February 6, 2014. Additionally, the survey results will be included as a part of the training school recertification for 2015. Agency heads should evaluate each training center they utilize in order to ensure both the training center director and the Commission are aware of any training concerns they may have.

MANDATORY RETRAINING FOR 2014

By June 30, 2014, 19,197 officers are required to complete mandatory retraining. As of August 2, 2013, 2,931 officers (15.3 percent) have met the required training for Fiscal Year 2013–2014.

Officers who do not complete the required mandatory retraining on or before June 30, 2014, will be ineligible to perform the duties of a criminal justice officer until the requirements are met. The officer will be separated in ATMS effective July 1, 2014.

SECURITY REQUIREMENTS

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures are in force:

- Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number.
- If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.
