# **New Automated Training Management System**

The culmination of two years of programming work is drawing near. The new and improved version of the Automated Training Management System (ATMS) is scheduled to go live on June 19, 2017. In addition to the functionality of the current version of ATMS, the new version will incorporate a number of new features. The highlights include the incorporation of a document management system that will allow documents to be uploaded and stored in an officer's record, the incorporation of the canine team certification process, the ability to electronically sign and notarize Commission forms and the creation of a method for officers to obtain Global Profile Sheets automatically. The new version of ATMS will be compatible with all major browsers, making access much

As with any new software program, there will be changes from the way the existing program functions. To help minimize any disruption or delay in agencies and training schools entering officer, instructor, or student information, the program developers will host several on-line training opportunities in May and June for ATMS users. The dates and times for these training opportunities will be announced as soon as they are scheduled. Please monitor the New Information and Notifications sections in the cur-

rent ATMS for details. Additionally, an ATMS User Guide will be produced and will be available for review prior to June 19, 2017. The Field Services and Officer Records staff will be available to assist agency and training school ATMS users with the transition as well.

The existing ATMS has served our needs well for the past 20 years. The new version of ATMS will be a more user-friendly and powerful tool and should provide many years of excellent service for all of Florida's criminal justice partners.

# Training Center Directors, staff learn and network at 2017 workshop

The 19<sup>th</sup> Training Center Directors Workshop was held February 28 - March 3, 2017.

In attendance were 10 new training center directors and 17 members of their staff. Participants received instruction on the rules and requirements related to training center certification, staffing and facilities, along with information about officer training, instructor certification, and requirements related to the Standards and Training Trust Fund. Additionally, it provided a valuable op-

portunity for new directors to network with each other and to meet members of the Commission staff. The 28 hours of training may be applied to the instructor retraining requirements.

The content of the workshop has and continues to evolve based on feedback from the participants. The 20<sup>th</sup> Training Center Directors Workshop is tentatively scheduled for May 2018. More information will be available at the August 2017 Quarterly Commission Meeting.

# **New Law Enforcement Auxiliary Training Program will launch July 1**

In August 2015, Criminal Justice Standard and Training Commission staff completed the first full-scale job task analysis (JTA) of the Law Enforcement Auxiliary Officer position. Staff used focus groups, statistical analysis of survey data, and subject matter expert (SME) input at every stage. The output was a list of core duties required for entry-level service.

Building on that foundation, staff was able to draw learning objectives and content from the current law enforcement curriculum to create a new auxiliary-focused textbook, approved by the Commission in the January 2017 business meeting.

The corresponding Law Enforcement Auxiliary Officer Basic Recruit Training Program #3006 was developed with the help of auxiliary officers, supervisors, and instructors from around the

As advised by SMEs, the content is rooted in the current law enforcement curriculum for sworn officers and is

The revised training program will require 364 hours, an increase from the 319 hours in the program retiring June 30.

based on the statutory definition that auxiliary officers perform under the direct supervision of a fully sworn officer. Effective July 1, 2017, the revised training program will require 364 hours, an increase from the 319 hours currently in the program retiring on June 30, 2017.

Also effective July 1, 2017, the State Officer Certification Examination will be required for law enforcement auxiliary recruits who begin a training class on or after that date. Test questions for the Law Enforcement Auxiliary State Officer Certification Examination are specific to the auxiliary program; therefore, auxiliary officers are not required to take the same exam as recruits completing the full basic recruit training program.

# **New Adult Sex Crimes Investigation** Course now available in ATMS

In September 2016, Advanced Course #033 Sex Crimes Investigations was retired. Two separate courses, Adult Sex Crimes Investigations and Child Sex Crimes Investigations, were developed to replace the retired course. During the January 2017 Commission meeting, course #1170 Adult Sex Crimes Investigations was adopted by the Commission for the Advanced Training Program with an effective date of January 26, 2017.

This new 40-hour course was developed with the help of subject matter experts from various criminal justice agencies who have experience conducting sex crimes investigations, and with the guidance of the Training Center Directors Association Advanced/Specialized Training Committee. It reflects a traumainformed and victim-centered approach to sex crimes investigations. The course is meant to meet the training needs of patrol officers and investigators. Some of the topics covered include best practices for initial response, trauma in sex crimes, interviewing techniques for victims and suspects, and investigation techniques for known and unknown sex crime suspects.

# BPD, U.S. Attorney's Office Host Tactical Medical Training

The Bureau of Professional Development recently partnered with the U.S. Attorney's Office to host multiple sessions of the "Tactical Medical for First Responders" course. The Department of Homeland Security's Federal Law Enforcement Training Center presented these eight-hour courses in mid-February at FDLE Headquarters.

The Tactical Medical for First Responders program is designed to teach students how to create a medical threat assessment plan for tactical operations. Students learned how to apply techniques to control life-threatening bleeding during "Care Under Fire."

Additionally, they performed techniques to treat life-threatening as well as injuries that are not life-threatening during "Tactical Field Care." Throughout the program, students demonstrated lifting, moving, and extracting victims from a tactical or hostile environment during "Tactical Evacuation Care."



Participants learned to create a medical threat assessment plan for tactical operations and did hands-on training throughout the course.

Approximately 90 officers from around the state, as well as Georgia, Alabama, and Mississippi, attended the training.



# High Liability Committee teams up with FDLE to update DT courses

Commission staff and the Training Center Directors Association's High Liability Committee are working to update the Basic Recruit Training (BRT) Defensive Tactics (DT) program and develop an Advanced DT course.

The process began last year with a survey that identified which DT techniques law enforcement, corrections, and correctional probation officers currently use on-the-job; what officers think about the number of techniques taught in BRT; and how frequently officers train in DT after BRT. Results of the survey were presented to the High Liability Committee in January 2017.

Survey results suggest that tactics taught in BRT should be evaluated for their usefulness in a real-world setting. Techniques need to be easy for novices to learn and remember. The ideal techniques to teach rely on gross motor skills and can apply to multiple situations.

The High Liability Committee formed a workgroup of selected subject matter experts (SME) to review current



Subject matter experts and curriculum developers met in April to revise the defensive tactics courses. More sessions are planned for the coming months.

DT instruction and make recommendations for both basic and post-basic training. SMEs in the DT workgroup represent all disciplines (law enforcement, corrections, and correctional probation) and a range of skill sets, including

experienced DT instructors, officers with decades of experience, and officers fairly new to the job. The workgroup met for three days in April and plans to meet several more times in the coming months.

# **Class 5 of Executive Leadership Seminar launches**

On May 8, the Florida Criminal Justice Executive Institute (FCJEI) kicked off Class 5 of the Executive Leadership Seminar (ELS). This program is a vital part of the FCJEI and was created to meet the need for formal leadership training designed for upper level managers within Florida's criminal justice community. Participants will be engaging in training on topics such as communicating through a crisis, critical thinking, leading people, managing organizations, overcoming adversity, and the importance of emotional intelligence and servant leadership.

To date, 72 leaders have graduated from four classes of ELS. This program is delivered annually at FDLE Headquarters at the rate of one week per month for three successive months. The FCJEI is housed within the Bureau of Professional Development. Through the FCJEI, FDLE delivers educational programs for Florida criminal justice executives that prepare them to deal with the complex

issues facing the state.

# **AUTOMATED TRAINING MANAGEMENT SYSTEM (ATMS)**

# MANDATORY RETRAINING STATISTICS

As of March 10, 2017, the following mandatory retraining statistics were reported:

The total number of officers who are due for mandatory retraining by June 30, 2017 is 19,219.

The total number of officers who have met the mandatory training requirement is 10,503.

The percentage of officers who have met the mandatory retraining requirement is 54.65.

### FIREARMS MANDATORY TRAINING FOR 2018

All officers who hold an active law enforcement certification are required to qualify on the Commission-approved 40-round course of fire at least once every two years, with the results documented on Form CJSTC-86A.

The 2016–2018 cycle of qualifications is due by June 30, 2018. A total of 50,701 officers are required to complete firearms mandatory retraining by June 30, 2018.

As of March 10, 2017, the number of officers who have completed

the required training for the 2016–2018 cycle is 16,006, or 31.57 percent.

Any officer who does not complete the required training by the deadline will be separated in ATMS effective July 1, 2018.

Please also note that officers who do not complete the required firearms mandatory retraining on or before June 30, 2018, are ineligible to perform the duties of a criminal justice officer until the requirement is met.

## **SECURITY REQUIREMENTS FOR ATMS**

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures are in force:

- Passwords are to be changed every 90 days.
- If the ATMS user does not access the database within 90 days, the system will automatically disable the user.
- The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.
