## Governor Scott appoints Brooksville Police Chief George Turner to Commission

On January 14, 2015, Governor Rick Scott announced the appointment of Chief George Turner to the Criminal Justice Standards and Training Commission.

Chief Turner, 58, is the police chief of the City of Brooksville.

He fills a seat made vacant by the departure of Chief Gary Calhoun and is appointed for a term that began January 14, 2015.

Chief Turner started his law enforcement career in the state of New York in 1976. He served with the Ulster County (NY) Sheriff's Department, Ulster (NY) Police Department, and the Longboat Key (FL) Police

Chief Turner is a member of the Florida Police Chiefs Association, F.B.I. National Academy Associates, Tampa Bay Area Police Chiefs Association, and Ulster County Police Chiefs Association.

## FDLE conducts regional meetings to assess curriculum

On July 1, 2012, the Criminal Justice Standards and Training Commission implemented the new CMS Basic Recruit Training Program for Corrections. Almost three years have passed since implementation, and the staff in the FDLE Bureau of Training, in keeping with past practice, will evaluate the training and study what aspects need improvement. Staff will be

conducting regional meetings across the state during the months of April and May to talk with agency heads, agency instructors, Commission-certified directors, coordinators and instructors, field training officers, correction officer supervisors, and corrections officers who graduated from academies that started on or after July 1, 2012.

It is expected that there

will be at least one workshop in every region. Training schools are hosting the workshops and will contact each of the agencies in their region with a date and time. At the conclusion of the workshops, there will be a follow up survey to address some of the discussion. Changes will be made to the Corrections Basic Recruit Training Program based on findings from the regional workshops and surveys.

## Florida D.A.R.E. Training Program certifies new officers

The Florida D.A.R.E. Training Program held the first D.A.R.E. officer training of the year from January 5 through 16, 2015. Once again, the training was held at the FDLE Fort Myers Regional Operations Center. A total of 19 police officers and deputy sheriffs from Florida, Georgia, Indiana, California and Illinois attended the training; 17 became certified and two were recertified to teach the D.A.R.E. curriculum in their respective jurisdictions.

Students attended 80 hours of intensive training during which

they learned not only the D.A.R.E. elementary and middle school curriculum but also effective communication skills, and practiced learning styles and abilities with differing personalities, as well as problem solving. Recertification students attended 40 hours of training. Each officer’s proficiency in training is tested by their ability to teach an assigned 45-minute lesson to their peers

with a mentor providing their final grade. On the last day before graduation, the students visited local schools, interacting and delivering lessons.

At the graduation ceremony on January 16, students were presented with a certificate of achievement as well as individual team awards for outstanding team members.

## Florida Leadership Academy to graduate 32 criminal justice leaders

The graduates serve in leadership roles within criminal justice agencies throughout the state.

Participants learned skills necessary to support the needs of their agencies and communities in preparation for future challenges.

The goal of the Florida Leadership Academy is to prepare first-line supervisors in criminal justice

organizations to exemplify the character and integrity expected of criminal justice professionals, while examining the various components necessary to becoming efficient leaders.

The Florida Criminal Justice Executive Institute, established within the Florida Department of Law

Enforcement and affiliated with the State University System, was established in 1990 by the Florida Legislature to address the need for an innovative and multi-faceted approach to the education and training of criminal justice professionals.

## Bureau of Professional Development offers training for criminal justice professionals

The Florida Criminal Justice Executive Institute (FCJEI) is housed within the Bureau of Professional Development. Through the FCJEI, FDLE delivers educational programs for Florida criminal justice executives that prepare them to deal with the

complex issues facing the state. FCJEI provides external training for high-level criminal justice executives, as well as law enforcement officers and officials.

Three of the major programs offered by the FCJEI are the Chief

Executive Seminar (CES), meeting for three separate sessions, each one emphasizing the role of a leader; the Senior Leadership Program (SLP), an in-depth seven-month leadership and management program; and the Florida Leadership Academy

(FLA), created to meet the need for formal training at the entry level of supervision. The FCJEI also offers a series of short courses for Continuing Executive Development, which are presented in various locations throughout the State.

*Penalty Guidelines Task Force Recommends Rule Changes*

The Criminal Justice Standards and Training Commission is required by Section 943.1395(8)(b)2, Florida Statutes, to conduct a workshop to receive public comment and evaluate disciplinary guidelines and penalties. A workshop was held on Wednesday, January 21, 2015, at the Seminole State College, Center for Public Safety.

Florida Statutes require that the panel be made up of twelve members, six in management positions and six in officer positions. The panel is made up of the following members:

The results of the Task Force were presented to the Commission at the quarterly business meeting held on February 5, 2015. The Commission voted to accept the Task Force’s recommended rule changes and to include them in the next rule change package. The issues discussed by the Task Force and their recommendations are as follows.

[Note: Deleted language is shown in red; language that is added is shown underlined in blue.]

**ISSUE NUMBER 1:**

*In 2012, a statutory change was made to the charge of Video Voyeurism. This change made the charge a misdemeanor for anyone under 19 years old, and a felony for anyone 19 years old or older. Since the Commission requires an individual to be 19 years old in order to become certified, the charge of misdemeanor Video Voyeurism and associated penalty guideline should be removed from rule.*

**Amended Rule 11B-27.0011(4) F.A.C. Moral Character-Misdemeanor Violations**

(b) Except as otherwise provided in Section 943.13(4), F.S., a plea of guilty or a verdict of guilty after a criminal trial for any of the following misdemeanor or criminal offenses, notwithstanding any suspension of sentence or withholding of adjudication, or the perpetration by an officer of an act that would constitute any of the following misdemeanor or criminal offenses whether criminally prosecuted or not:

1. **Amended Rule 11B-27.005(5) F.A.C. Range of Penalties-Misdemeanor Violations**

(b) For the perpetration by the officer of an act that would constitute any of the misdemeanor offenses, pursuant to paragraph 11B-27.0011(4)(b), F.A.C., but where there was not a violation of Section 943.13(4),F.S., the action of the Commission shall be to impose a penalty ranging from probation of certification to suspension of certification. Specific violations and penalties that shall be imposed, absent aggravating or mitigating circumstances, include the following:

	Violation	Recommended Penalty Range
8.	Prostitution or lewdness; voyeurism, <b>video voyeurism</b> (796.07, 810.14, <b>810.145</b> , F.S.)	Prospective suspension, and probation with counseling to revocation

**ISSUE NUMBER 2:**

*Amend current rule language to add an enumerated penalty guideline for the felony charge of Video Voyeurism. This rule language will apply the same penalty guideline for the current misdemeanor charge of Voyeurism. Any aggravators or mitigating circumstances as outlined in Rule 11B-27.005(6)(a)(b), F.A.C. may be considered when determining the appropriate final disciplinary action by the Commission.*

**Amended Rule 11B-27.005(5) F.A.C. Range of Penalties-Felony Violations**

(a) For the perpetration by the officer of an act that would constitute any felony offense, pursuant to paragraph 11B-27.0011(4)(a), F.A.C., but where there was not a violation of Section 943.13(4), F.S., the action of the Commission shall be to impose a penalty ranging from suspension of certification to revocation. Specific violations and penalties that shall be imposed, absent mitigating circumstances, include the following:

<u>18.</u>	<u>Video Voyeurism</u>	<u>Prospective suspension and probation with counseling to revocation</u>

**ISSUE NUMBER 3:**

*In numerous cases, officers with a sustained charge of Sexual Harassment have been suspended by their agency, qualifying them to receive a Letter of Acknowledgement (LOA) from the Commission since the agency’s discipline met the Commission’s penalty guideline. The current penalty guideline for this charge is probation with training to suspension. An officer receiving at least a one day suspension, regardless of training, is eligible for an LOA. A change to rule will ensure that the officer will receive the necessary training from the agency or through the Commission’s discipline process*

**Amended Rule 11B-27.005(5) F.A.C. Range of Penalties-Non-Criminal Violations**

(c) For the perpetration by the officer of an act or conduct, as described in paragraph 11B-27.0011(4)(c), F.A.C., if such act or conduct does not constitute a crime described in paragraphs (5)(a)-(b) of this rule section, the action of the Commission shall be to impose the following penalties, absent aggravating or mitigating circumstances:

**ISSUE NUMBER 4:**

*Amend rule to specify that the charge of Falsification of a Use of Force Report (Section 944.35(4)(b) F.S.) is included in the penalty guideline for misdemeanors involving false reports and statements. The current penalty guideline rule includes the entire section 944.35 F.S. Both Falsification of a Use of Force Report (Section 944.35(4)(b) F.S.) and Failure to Report Use of Force (Section 944.35(4)(a) F.S.) are included within the statute. However, only Section 944.35 (4)(b) involves a false statement. The charge of Failure to Report Use of Force (Section 944.35(4)(a) F.S.), is also a moral character violation but does not involve a false statement. The charge of Failure to Report Use of Force will remain within the generic penalty guideline of probation to suspension for misdemeanor moral character violations.*

**Amended Rule 11B-27.005(5) F.A.C. Range of Penalties-Misdemeanor Violations**

(b) For the perpetration by the officer of an act that would constitute any of the misdemeanor offenses, pursuant to paragraph 11B-27.0011(4)(b), F.A.C., but where there was not a violation of Section 943.13(4),F.S., the action of the Commission shall be to impose a penalty ranging from probation of certification to suspension of certification. Specific violations and penalties that shall be imposed, absent aggravating or mitigating circumstances, include the following:

**ISSUE NUMBER 5:**

*Amend rule to include a timeframe during which an officer can recant a false statement.*

**Amended Rule 11B-27.0011 F.A.C. Moral Character**

(5) A certified officer’s failure to maintain good moral character as defined in subsection (4) of this rule section by committing a violation involving perjury or false statement in a court proceeding, shall not include a statement which was recanted. If the violation involving perjury or false statement is alleged to have occurred in the performance of regularly required work duties or the course of an administrative or disciplinary investigation, a certified officer’s failure to maintain good moral character as defined in subsection (4) of this rule section shall not include a statement in which the officer making the statement conceded such statement to be false prior to the employing agency’s conclusion of the internal affairs investigation in which the false statement related to a material fact [or within 10 working days of making the false statement, whichever occurs first.](#) For purposes of this subsection, the employing agency’s internal affairs investigation shall be deemed to be at a conclusion upon the investigator’s execution of the statement required by Section 112.533(1)(a)2.,F.S.

*Penalty Guidelines (Continued from page 9)***ISSUE NUMBER 6:**

*Amend rule to restore the Commission's ability to discipline or revoke an officer's certification, notwithstanding a decision in an arbitration, civil service board or other administrative review to overturn the employing agency's dismissal or discipline and reinstate the officer to employment.*

*Note: In Newberry v. Florida Dept. of Law Enforcement, Criminal Justice Standards & Training Com., 585 So.2d 500 (Fla. 3rd DCA 1991), the 3rd DCA upheld the Commission's order revoking an officer's certification for testing positive for cocaine, notwithstanding the fact that the officer had been reinstated to her job by a civil service board that overturned her dismissal from employment on the same violation. The Commission was not legally bound by the civil service board's decision to reject the officer's drug test results and return the officer to duty. In 2003, the Commission approved the recommendation of the Penalty Guidelines Task Force to adopt the current rule which forbids Commission staff to present a case if the officer had prevailed in arbitration or a civil service hearing on the same misconduct - thereby choosing not to exercise the Commission authority that the court had recognized in the Newberry case.*

**Amended Rule 11B-27.004(11) F.A.C. Probable Cause Determination**

(b) In cases [subject to review by the Commission](#) in which **administrative or judicial review results in a final reversal of discipline imposed by the employing agency relating to the alleged misconduct that is subject to review by the Commission, or criminal proceedings that result in the respondent's acquittal on all charges [on the merits of the case subject to review by the Commission](#)** after a trial, Commission staff shall take no further action, provided that Commission staff may present the case to a Probable Cause Panel upon Commission staff's specific showing that the findings of fact in the collateral proceedings were based upon inclusion or exclusion of evidence or **that the** testimony that was a departure from the essential requirements of law, the findings of fact in the collateral proceedings were not supported by competent and substantial evidence, or were clearly contrary to the evidence presented.

**ISSUE NUMBER 7:**

*Discussion concerning agencies that fail to properly report moral character violations to the Commission.*


The Task Force voted to accept the recommendations for Items 1-4 as they were presented. Issue 5 was amended by the Task Force to state that a recantation had to occur within 10 calendar days instead of 10 working days. For Issue 6, a discussion was held, and it was moved and seconded for the Task Force not to change Rule 11B-27.004(11)(b), F.A.C., at this time; however, it was recommended that Commission staff craft alternative rule language regarding diversionary programs for presentation at the next Task Force Meeting.

## SECURITY REQUIREMENTS

In keeping with FDLE’s policy on maintaining the integrity of the ATMS database, the following security procedures are in force:

- Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number.
- If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency’s Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.

## MANDATORY RETRAINING FOR 2015

By June 30, 2015, 18,395 officers are required to complete mandatory retraining. As of February 9, 2015, 8,658 officers (47 percent) have met the required training for Fiscal Year 2014–2015.

Officers who do not complete the required mandatory retraining on or before June 30, 2015, are not eligible to perform the duties of a criminal justice officer until the requirements are met. Any officer who fails to complete the required mandatory retraining by the deadline will be separated in ATMS effective July 1, 2015.

## FIREARMS MANDATORY TRAINING FOR 2016

All officers who hold an active law enforcement certification are required to qualify on the Commission-approved 40-round course of fire at least once every two years, with the results documented on Form CJSTC-86A. The 2014-2016 cycle of qualifications is due by June 30, 2016. A total of 50,252 officers are required to complete firearms mandatory retraining by June 30, 2016. As of February 9, 2015, the number of officers who have completed the required training for the 2014-2016 cycle is 14,656.

Officers who do not complete the required firearms mandatory retraining on or before June 30, 2016, are ineligible to perform the duties of a criminal justice officer until the requirement is met. Any officer who does not complete the required training by the deadline will be separated in ATMS effective July 1, 2016.
