### Commission Approves 2013 - 2014 Operating Budgets

ection 11B-18.0052, Florida Administrative Code (F.A.C.) requires Criminal Justice Professionalism to notify regional training councils of the projected allocation of funds for officer training by July 1 each year. Each criminal justice training school certified by the Criminal Justice Standards and Training Commission (CJSTC) submits a budget request to their regional training council (RTC) for approval, and the RTC chairpersons forward the budgets to CJSTC staff for review and recommendation.

At its May 9, 2013 meeting, the CJSTC adopted staff's recommendation and approved operating budgets for the training schools. A total of \$3,036,240 from the Criminal Justice Standards and Training Trust Fund was allocated based on a total regional officer count of 75,906, at the rate of \$40 per officer.

All budgets must comply with the following expenditure formula:

- Administrative no more than five percent
- Training no less than 80 percent
- Operating Capital Outlay no more than 15 percent

Also at the May meeting, the CJSTC recognized the following training schools for achieving a perfect audit recommendation for Fiscal Year 2011 - 2012:

- Broward College
- Broward County Sheriff's Office
- Florida Department of Corrections
- Indian River State College
- College of Central Florida

Rule 11B-18.010, F.A.C. requires that the CJSTC audit any training facility or program and fiscal agent's accounting records and procedures for compliance with laws, rules, budget provisions and contractual agreements. Trust fund amounts are allocated for use in delivering courses that are a part of Commission-approved advanced and specialized training programs.

### Bills of Interest Passed by the 2013 Legislature

SB 50 Relating to Public Meetings [Presented to Governor for action by 6/29]

Requires that a member of the public be given a reasonable opportunity to be heard by a board or a commission before it takes official action on a proposition., etc. *Effective October 1, 2013*.

SB 454 Relating to Florida College System Institution Police Officers
[Approved by Governor; Ch. No. 2013-171]

Revises provisions relating to the jurisdictional authority of FCS institution police offices; provides for mutual aid agreements and enforcement of traffic laws in certain areas, etc. *Effective July 1, 2013*.

**HB 489** Relating to Railroad Police Officers [Approved by Governor; Ch. No. 2013-114]

Authorizes temporary appointment of special officers who meet certain qualifications; requires special officers employed by railroad or other common carrier have specified qualifications and meet specified continuing training or education requirements; requires Class I, II, or III railroad pay costs associated with continuing training and education, etc. *Effective July 1, 2013.* 

**HB 571** Relating to Marshal of Supreme Court [Approved by Governor; Ch. No. 2013-086]

Requires marshal and deputies to comply with specified requirements for law enforcement officers; specifies that marshal and deputies have full powers to bear arms and make arrests under certain conditions; limits use of powers to performance of official duties for Supreme Court, etc. *Effective upon becoming law*.

**HB 875** Relating to Licensed Security Officers [Presented to Governor for action by 6/25]

Provides penalties for unlicensed person who engages in activity for which Ch. 493, F.S. requires a license (with exceptions); provides penalties if person commits felony while impersonating a security officer, private investigator or other person required to have a license under Ch. 493, F.S.; authorizes licensed security officer or agency manager to detain person on premises of critical infrastructure facility in certain circumstances, etc. *Effective July 1, 2013*.

## State Officer Certification Examination Statistics Third Quarter, Fiscal Year 2012–13

t each quarterly meeting of the Criminal Justice Standards and Training Commission, results for the State Officer Certification Examination (SOCE) are reported as part of the informational agenda. The SOCE was administered 10 times during the third quarter. The following represents the overall results for the period:

During this time period, students from **Northeast Florida Criminal Justice Training Center, St. Petersburg College and Valencia College** achieved a 100 percent pass rate on the Law Enforcement SOCE on their first attempt.

On the Corrections SOCE, Daytona State College, Polk State College, Santa Fe College, St. Petersburg College and Washington-Holmes Technical Center achieved a 100 percent pass rate\* for students taking the SOCE for the first time.

\*This statistic is based on less than 20 cases at each of the named training schools and should be considered less reliable than statistics reflecting a higher number of cases.

### **SOCE Monthly School Reports**

Training schools may access the SOCE results for their students via ATMS. The report contains the name, examination information, type of training completed and results for each student from that school for the selected time frame. To run the report after logging in to ATMS, select the **Administration** button from the choices on the left side of the screen. Then select **Reports** and scroll down to **Training Center Reports**. The report is titled **Student Results by School**.

### **Bureau of Training Initiatives Show Progress**

A

t the May committee meetings held in conjunction with the quarterly meeting of the Criminal Justice Standards and Training Commission (CJSTC), training center directors were updated on the following training initiatives.

### **Post-Basic Needs Assessment**

FDLE has conducted an extensive survey of training needs for correctional, correctional probation and law enforcement officers, and is currently asking Commission-certified training schools to provide additional feedback. Volunteers from the training schools will meet with FDLE staff in July to review survey findings as well as Automated Training Management System (ATMS) and Criminal Justice Standards and Training Trust Fund reporting data. The volunteers will be asked to identify which post-basic courses to maintain, create or retire, and make a recommendation to the Training Center Directors Association at a workshop in August.



### **Computer Based Testing**

Computer based testing for the State Officer Certification Exam (SOCE) is closer to implementation as FDLE continues to work with Pearson VUE to develop the system. Once fully implemented, the SOCE will no longer be administered on paper. A pre-pilot of the system is anticipated for late July. The pre-pilot will verify core functionality of the system using actual examinees.

### **Physical Fitness Standard**

In an extensive review of statewide physical fitness standards for criminal justice officers outside of Florida, FDLE focused on current practices, academic research and a legal analysis of relevant civil litigation. Now, FDLE is in the process of developing a "best practice" model for implementing pre-employment physical fitness standards. Current work on this project is focused on identifying job performance criteria that can be used for validation of physical fitness tests and standards. Following the establishment of appropriate performance criteria, FDLE will develop a comprehensive risk management strategy for implementing and maintaining physical fitness standards.



Because FDLE will be responsible for any risk associated with the implementation of a physical fitness standard, the department, along with the Criminal Justice Standards and Training Commission, is required to approve any proposed physical fitness standard before it can be implemented.

### **Other Curriculum News**

- In July, FDLE will host a defensive tactics workshop to review the effectiveness of current training. This will
  not be a rewrite of the current program, but rather a chance to see what is working and what could be
  improved with revisions.
- A revision of the Florida CMS Law Enforcement Basic Recruit Training Program is in the last stage. The
  objective is to increase the effectiveness of the training and, ultimately, the performance of recruits. Courses
  in the revised program, which is scheduled to take effect on July 1, 2014, have been developed, revised or
  combined, thus requiring new common course numbers. It is the intent that the program hours remain at
  770.

### Security Requirements

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures have been implemented. Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number. If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.



### Mandatory Retraining for 2013

21,826 officers are required to complete mandatory retraining by June 30, 2013. As of June 5, 2013, 19,407 officers (88.92 percent) have met the required training for Fiscal Year 2012 - 2013.

Officers who do not complete the required mandatory retraining on or before June 30, 2013, will be ineligible to perform the duties of a criminal justice officer until the requirements are met.

The officer will be separated in ATMS effective July 1, 2013.
