Commission Welcomes New Member, Recognizes Training Center Directors

At the November 7, 2013, quarterly meeting of the Criminal Justice Standards and Training Commission, Chairman Susan Benton welcomed its newest member to the Commission — **Major Susan M. Jeter**, jail administrator for the Brevard County Sheriff's Office. Commissioner Jeter was appointed by Governor Rick Scott for a four year term, beginning September 4, 2013, and ending August 1, 2017.

Brock of the St. Petersburg College; Director Ian Moffett of the Miami Police Training Center; Director Joe Cowan of the Northeast Florida Criminal Justice Training and Education Center; Director Hector Garcia of the Miami Dade College School of Justice; Director Gary Killam of the St. Johns River State College; Director Larry Lawson of the Indian River State College; and Director Daryl Johnston of the Santa Fe College.*

The Commission also approved the appointment of **Chief David Perry** to the Florida Criminal Justice Executive Institute Policy Board. Chief Perry, who leads the Florida State University Police Department, was recommended by the Florida Police Chiefs Association. Chief Perry was appointed for a two-year term that began November 7, 2013, and ends November 7, 2015.

The next quarterly meeting of the Commission is scheduled for February 6, 2014, in Lake Mary, Florida.

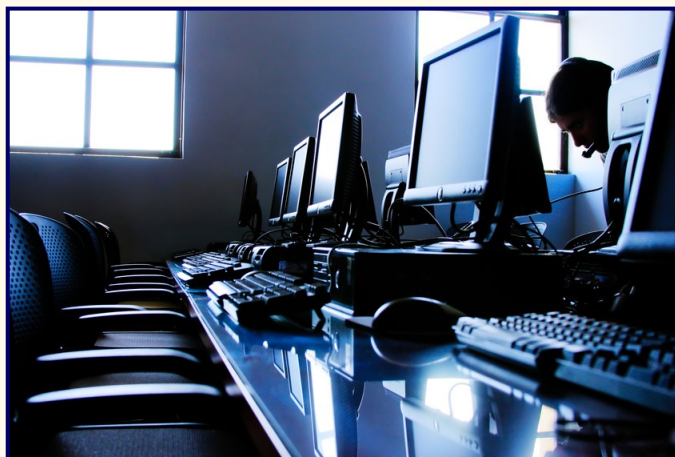
Rollout of Computer-Based Testing Begins

On November 1, 2013, Commission staff launched the first phase of computer-based testing (CBT) administration of the State Officer Certification Exam (SOCE). Twelve criminal justice training centers are now able to offer their recruits on-demand administration of the SOCE — College of Central Florida, Daytona State College, Florida Gateway College, Florida Keys Community College, Lake Technical Center, Northeast Florida State College, Northwest Florida State College, Sarasota County Technical Institute, Seminole State College, South Florida State College, Washington-Holmes Technical Center, and Citrus County Public Safety Training Center.

The initial rollout was largely successful, and the majority of exam registrations and administrations were carried out without any problems. Unfortunately, some candidates experienced delays in the registration process. While there were different causes of the delays, most of them were attributed to one of the following: incorrect demographic data in the Automated Training Management System (ATMS); incorrect system configuration; incorrect setup of payment vouchers; and cases where candidates began their training with a paper-and-pencil designated class but finished with a CBT designated class. In most cases, Commission staff and Pearson VUE were able to address issues on the same day they were discovered.

Of particular importance to the CBT process is the timely and accurate entry of information into ATMS. While system configuration issues need only be addressed once, data entry errors are likely to persist. Besides the prompt entry of passing grades into ATMS, training centers may prevent delays by verifying names and correctly entering date of birth into ATMS. Often, this information is created months or even years prior to entry into a training program, and not verified until a problem arises.

Commission staff will continue the rollout of CBT during the first half of 2014, and plan on discontinuing the paper-and-pencil exam entirely by July, 2014.



State Officer Certification Examination Statistics First Quarter, Fiscal Year 2013–14

At each quarterly meeting of the Criminal Justice Standards and Training Commission, results for the State Officer Certification Examination (SOCE) are reported as part of the informational agenda. During this time period, students from **St. Petersburg College** and **Citrus County Public Safety Training Center** achieved a 100 percent pass rate on the Law Enforcement SOCE on their first attempt.*

On the Corrections SOCE, **Daytona State College**, **Hillsborough Community College** and **Indian River State College** achieved a 100 percent pass rate for students taking the SOCE for the first time.*

**These statistics are based on less than 20 cases, and should be considered less reliable than statistics reflecting a higher number of cases.*

The report contains the name, examination information, type of training completed and results for each student from that school for the selected time frame. To run the report after logging in to ATMS, select the **Administration** button from the choices on the left side of the screen. Then select **Reports** and scroll down to **Training Center Reports**. The report is titled **Student Results by School**.

Thirty-Seven Supervisors Complete Leadership Training

The Florida Criminal Justice Executive Institute announced the graduation of 37 first-line supervisors from the Florida Leadership Academy on December 13, 2013. The graduates represent criminal justice agencies from across the state, and serve in a leadership role within their agency.

The goal of the Florida Leadership Academy is to prepare first-line supervisors in criminal justice organizations to exemplify the character and integrity expected of criminal justice professionals, and to examine the various components necessary to being an efficient leader. Seminar participants met for four weeks at the Orange County Sheriff's Office in Orlando, Florida, where they learned skills necessary to support the needs of their agency and the community in preparation for future challenges.

The Florida Criminal Justice Executive Institute (FCJEI), established within the Florida Department of Law Enforcement and affiliated with the State University System, was created in 1990 by the Florida Legislature to address the need for an innovative and multi-faceted approach to the education and training of criminal justice professionals.

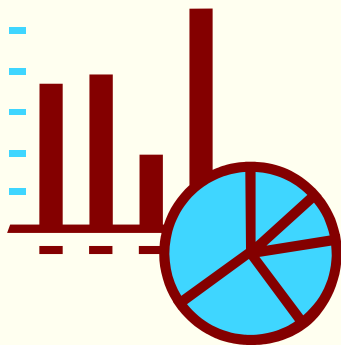

SECURITY REQUIREMENTS

In keeping with FDLE's policy on maintaining the integrity of the ATMS database, the following security procedures are in force:

- Passwords are to be changed every 90 days and must have at least 8 characters, with at least one capital letter, some lower case letters and a number.
- If the ATMS user does not access the database within 90 days, the system will automatically disable the user. The user may contact the agency's Criminal Justice Customer Service Specialist for assistance by calling 850-410-8600.



MANDATORY RETRAINING FOR 2014

By June 30, 2014, 18,904 officers are required to complete mandatory retraining. As of December 13, 2013, 6,908 officers (36.5 percent) have met the required training for Fiscal Year 2013–2014.

Officers who do not complete the required mandatory retraining on or before June 30, 2014, will not be eligible to perform the duties of a criminal justice officer until the requirements are met. The officer will be separated in ATMS effective July 1, 2014.
