SUBJECT: Changes to Post-Basic Courses Effective September 4, 2016

Effective September 4, 2016, changes were made to the Florida Administrative Code (F.A.C.) Rule Chapters promulgated by the Criminal Justice Standards and Training Commission that directly impact Advanced and Specialized Training Programs. The full rule language can be accessed at <http://www.fdle.state.fl.us/cms/CJSTC/Publications/CJSTC-FAC-Rules.aspx>.

In 2013, Criminal Justice Standards and Training Commission staff conducted the Post-Basic Training Needs Assessment. In May 2014, the Commission approved recommended changes to courses in the Advanced and Specialized programs, which included decisions to keep, retire, reclassify, and add courses. In January 2015, the Post-Basic Training Committee prioritized these recommendations, and the Commission approved these recommended changes.

Upon Commission approval, staff began a phased implementation, revising Florida Administrative Code as needed. Those revisions were presented to the Commission in a Rules Workshop on November 4, 2015 and approved in the next day's Business Meeting. Changes went into effect September 4, 2016.

Training centers and criminal justice agencies should be aware of the changes below, noting especially that some Advanced Training Program courses have been retired or reclassified as Specialized Training Program courses. As such, they are no longer approved for salary incentive training.
