SUBJECT: New Commission-approved Training Program:

Law Enforcement Auxiliary Officer Basic Recruit Training Program #3006

In 2015, Criminal Justice Standards and Training Commission staff conducted a job task analysis (JTA) of the law enforcement auxiliary officer's job. The staff worked with subject matter experts to develop a new curriculum based on the 2015 JTA.

The Law Enforcement Auxiliary Officer Basic Recruit Training Program #3006 was developed with the help of law enforcement auxiliary officers and instructors from around the state. Developed with the input of subject matter experts, the content is comprehensive and covers a wide range of duties that vary throughout the state. The curriculum source material is still firmly rooted in the law enforcement curriculum for fully sworn officers, but it is based on the statutory definition that auxiliary officers perform under the direct supervision of a fully sworn officer.

\*The noted courses shall be taught by a Commission-certified high-liability instructor at a training school or agency. See Rule 11B-35.003, Florida Administrative Code (F.A.C.).

\*\*CMS Law Enforcement Vehicle Operations is optional and is based on employing agency requirements. If required, the course shall be taught by a Commission-certified high-liability instructor at a training school or agency (Rule 11B-35.003, F.A.C.). If CMS Criminal Justice Vehicle Operations is not taught, the total program hours will be reduced to 316 hours.

The new Law Enforcement Auxiliary Officer Training Program, effective **July 1, 2017**, will be **364 hours**, an increase from the 319 hours required in the current program retiring on June 30, 2017. The accompanying Instructor Guide will be available in May 2017, pending approval by the Commission.

Florida statute requires the applicant pass the State Officer Certification Examination to be eligible for certification as a law enforcement officer. This exam is required for all auxiliary law enforcement officer recruits who begin their training on or after July 1, 2017. The exam will be specific to the content covered in the Florida Law Enforcement Auxiliary Academy textbook.
