Five Law Enforcement Officers Inducted Into Hall of Fame

Current and former law enforcement officers from throughout Florida were honored Saturday, May 19, 2018, at the Law Enforcement Officers' Hall of Fame induction ceremony. FDLE Assistant Commissioner Jennifer Pritt presided over the ceremony held inside Florida's Capitol.

The inductees were nominated by the Florida Sheriffs Association, Florida Police Chiefs Association, Police Benevolent Association, Fraternal Order of Police and the State Law Enforcement Chiefs' Association and then were selected by a committee. The inductees were approved by Governor Rick Scott and Florida's Cabinet on January 18, 2018.

Robert E. Blackburn, Hillsborough County Sheriff's Office Nominated by the Florida Sheriffs Association

Robert Blackburn began his career in 1941 as a deputy with the Florida Highway Patrol before being elected Hillsborough County Sheriff in 1952, where he served 12 years. He was a member of the Florida Sheriffs Association serving as president from 1964-1965. Blackburn successfully lobbied for legislation creating the Florida Law Enforcement Academy, established professional standards for law enforcement and standardized the sheriff's badge and vehicles. He was instrumental in the creation of the Florida Sheriffs Youth Ranches. From 1968 to 1978, he was a member of the Florida House of Representatives, where he was considered "the

voice of law enforcement." In 1979, he was appointed interim commissioner of FDLE where he showed strong leadership, even though his tenure only lasted only a few months. He died in 1997, and will be remembered as a pioneer in modern Florida law enforcement.

Donald F. Eslinger, Seminole County Sheriff's Office Nominated by the Florida Sheriffs Association

Donald Eslinger began his career as a radio dispatcher in 1978 before advancing through the ranks as a patrol deputy, investigator, watch commander and special weapons and tactics team leader with the Seminole County Sheriff's Office. He was appointed Seminole County Sheriff on January 1, 1991, and elected in 1992. He was subsequently reelected until his retirement in 2017. He served 38 years with the Seminole County Sheriff's Office and is the longest serving sheriff in Seminole County history. His tenure as sheriff was marked with drastic reductions in crime, along with advocacy for mental health and youth programs. Contributions to youth include founding Kids House, starting the annual "Shop with the Sheriff" and "Christmas Village" events, assuming responsibility for child protective services from the state and creating a successful civil citation diversion program. Under his leadership, the agency grew from 539 positions with a \$25.8 million budget to 1,343 positions with a \$123.5 million budget.

Ernest W. George, West Palm Beach Police Department Nominated by the Police Benevolent Association

Ernest George served his entire career with the West Palm Beach Police Department from 1975 to 2005. He was a D.A.R.E. officer educating elementary school children on the dangers of drugs in the late 1980s and was promoted to sergeant in January 1996. He also served as president of the Palm Beach County Police Benevolent Association (PBA) from 1987 to 2006 and president of the Florida PBA from 1996 to 2006. As PBA president, he achieved numerous legislative enhancements creating uniform guidelines for the use of dart-firing stun guns, creating the FRS Deferred Retirement Option Program and enhancing law enforcement officer death benefits. His passion to raise the standards for law enforcement led him to be appointed to the Criminal Justice and Standards Training Commission in 2001, serving as Commission chairman from 2010 to 2013.

Frederick A. Maas, Sunny Isles Beach Police Department Nominated by the Police Benevolent Association

Frederick Maas is a 43-year veteran of law enforcement, who continues to serve his community today. He began his career

with the Miami-Dade Police Department in 1975 and served in multiple roles until he retired in 1998. Later that year, he was hired by Sunny Isles Beach Police Department and promoted to chief



in October 1999. He was appointed by Governor Jeb Bush to the Violent Crime and Drug Control

Council in 2000. After years of receiving the "Outstanding Law Enforcement Leadership Award" from the Dade County Police Benevolent Association, they named the award in his honor. "The Fred Maas Law Enforcement Leadership Award" honors individuals who embody leadership, inspire those around them and make a difference in the lives of those they serve. In 2008, he received the highest law enforcement award from the Vatican being named a Knight of St. Sylvester by Pope Benedict XVI.

James W. Smith, Miami Beach Police Department Nominated by the Fraternal Order of Police

James Smith began his career in 1964 as the first African-American police officer at the Miami Beach Police Department. At the age of 34, he was one of the oldest rookies in his class. He earned the reputation of being professional, sincere and empathetic towards others. He was promoted to sergeant in 1971 and rose through the ranks. In 1989, he was promoted to Major, the position he held until he retired in September 1990. He worked in or supervised every major unit at the department throughout his career and helped create a youth group for at-risk boys in the Liberty City area. In his honor, the Miami Beach Police Department named their community room the Major James W. Smith Community Room. Smith, who died in 2017, overcame the racial divide in America to inspire others with his fair but firm leadership.

The Florida Law Enforcement Officers' Hall of Fame was created by the 2014 Florida Legislature to recognize and honor law enforcement officers who put their lives on the line for the safety and protection of Florida's citizens and visitors through their works, service and exemplary accomplishments.

The Alcohol Testing Program Receives ANAB Accreditation

The mission of the Alcohol Testing Program (ATP) is to enhance public safety by ensuring the accuracy and scientific reliability of evidentiary blood and breath alcohol tests, facilitating enforcement of Florida's Implied Consent laws and promoting the qualifications and professionalism of persons responsible for blood and breath alcohol analyses in the State of Florida. In furtherance of this goal, ATP recently achieved accreditation through the ANSI-ASQ National Accreditation Board (ANAB) as a Breath Alcohol Calibration Laboratory.

The ANAB Breath Alcohol Calibration program accredits

laboratories who calibrate breath alcohol measuring instruments based on the international standard ISO/IEC 17025:2005 and ANAB AR3029 standards. These instruments are used to calculate the amount of alcohol (ethanol) in a subject's breath. Accreditation provides formal recognition of the program's competence and a testament to the continued high quality of work performed by the ATP. It also increases the level of confidence for

He began his law enforcement career with the Florida Department of Law Enforcement from 1992 to 2009, serving in many positions, including special agent and resident agent in charge (FDLE Panama City Field Office). From 2009-2016, Sheriff Ford served as chief deputy with the Bay County Sheriff's Office and in 2016, he was elected Sheriff of Bay County.

He is reappointed for a term beginning April 13, 2018, and ending August 1, 2021; 2) Commission Vice Chairman Nick Marolda, Jr. is a police detective with the Lakeland Police Department. He is reappointed for a term beginning April 13, 2018 and ending January 1, 2021; 3) Commissioner Jennifer Sandman is a sergeant patrol officer with the Town of Palm Beach. She is reappointed for a term beginning April 13, 2018, and ending August 1, 2021; 4) Commissioner William Weiss is the deputy sheriff of the Martin County Sheriff's Office. He is reappointed for a term beginning April 13, 2018, and ending August 25, 2020; and 5) Commissioner Matthew Williams is a master sergeant with the Clay County Sheriff's Office. He is reappointed for a term beginning April 13, 2018, and ending August 1, 2021.

Executive Leadership Seminar Will Graduate 25 Criminal Justice Executives

The Florida Criminal Justice Executive Institute will be graduating twenty-five criminal justice executives from the Executive Leadership Seminar on July 27, 2018. Seminar participants have been meeting at FDLE Headquarters since May and engaging in training on topics such as communicating through a crisis, critical thinking, leading people, managing organizations, overcoming adversity and the burden of command. The Executive Leadership Seminar is an educational opportunity for the upper management leadership of Florida Criminal Justice organizations.

The Florida Criminal Justice Executive Institute, established within the Florida Department of Law Enforcement and affiliated with the State University System, was established in 1990 by the Florida Legislature to address the need for an innovative and multi-faceted approach to the education and training of criminal justice professionals.



Leadership for Reducing Organizational Stress in Law Enforcement

The Florida Criminal Justice Executive Institute is excited to announce an upcoming two-day seminar for executives, managers and supervisors on reducing staff stress and increasing compliance with department standards. Leaders will address stressors encountered by their staff which influence the balance between professional and personal relationships.

Emphasis will be placed on executives, managers and supervisors developing leadership practices and policies that recognize and encourage accomplishment of organizational goals while also taking better care of themselves and the people who serve under their leadership.

Supervisors and managers will leave the class with an understanding of a variety of best practices in addressing organizational stress. A theme of personal leadership will run throughout this seminar and attendees will have ample opportunities to share their views, develop decision-making models and reflect on better ways to make decisions for themselves and those they lead.

The instructor, Kent Williams, is the owner of Breach Point Consulting and has been a police officer for more than 32 years. He recently retired as Chief of Police for a Chicago area police department.

Officer Discipline Training

Officer Discipline is a 28-hour course designed to provide a comprehensive understanding of the management issues related to officer misconduct, internal affairs investigations and the discipline process. Using a combination of lecture and case studies, Officer Discipline delivers information for evaluating agency policies and procedures and for defining the role of the agency chief executive, the internal affairs investigator, police unions and the Criminal Justice Standards and Training Commission (CJSTC) in the discipline process.

The class addresses topics such as officer misconduct, complaint acceptance, model policies, the administration of positive (corrective rather than punitive) discipline, the Law Enforcement Officer/Correctional Officer Bill of Rights, the role of police unions, Garrity Rights, the management of internal affairs investigations, reporting requirements of the CJSTC and trending issues. In addition, class participants will attend a probable cause hearing and the CJSTC meeting and disciplinary hearing.

Participants have called the class "One of the best presentations of the officer discipline process I have ever attended," and stated "It really helps to 'open the eyes' of people that are not familiar with this process."

The instructors, Jay Romine and Rick Lober, have more than 70 years of combined experience and have served in a number of roles in the law enforcement community. Officer Discipline training will be offered October 29 – November 1 in Destin.

Florida Leadership Academy **Class 42 Graduates**

The Florida Criminal Justice Executive Institute is proud to announce the graduation of the 42nd Florida Leadership Academy Class hosted by the Pinellas County Sheriff's Office on August 17, 2018. The 40 class participants serve in leadership roles representing 30 criminal justice agencies throughout the state including police departments, sheriff's offices, corrections and state law enforcement.

The Academy consists of four week-long sessions where participants learn skills necessary to support the needs of their agencies and communities in preparation for future challenges. The goal of the Academy is to prepare firstline supervisors in criminal justice organizations to exemplify the character and integrity expected of criminal justice professionals, while examining the various components necessary to become efficient leaders.

We are currently getting ready to launch the 43rd Florida Leadership Academy Class to be hosted by St. Johns River State College from September to December of 2018.

The Florida Law Enforcement Analyst Academy Class 28

The Florida Law Enforcement Analyst Academy kicked off the 28th class on July 9, 2018, in Tampa. The curriculum for this academy was recently updated in an effort to keep up with the ever-changing world of technology and resources that provide analysts the tools needed to predict and prevent criminal activity. Analysts attending this academy will meet one week a month for five months. The analysts will be challenged with weekly assignments and quizzes, individual projects and a comprehensive final exam. Successful graduates receive a state certification as a Law Enforcement Analyst. The first deployment of the updated curriculum was delivered earlier this year with 25 analysts graduating and attaining certification.

Upcoming Senior Leadership Program

The Florida Criminal Justice Executive Institute is preparing to advertise for the next Senior Leadership Program (SLP) class. The selected participants will meet for seven weeks over a 10-month period. Participants will be exposed to topics such as demographics, budgeting and futures forecasting as it relates to criminal justice and strategic planning.

The goal of the SLP is to prepare Florida's criminal justice leadership for the challenging and changing demands of the future. Class participants study the trends and events that criminal justice professionals and the state will face and examine the leadership skills necessary to create and lead the changes that lie ahead.

Staff agreed that creating a series of exercises tailored to the corrections curriculum and addressing the unique needs of corrections officers would be beneficial to recruits completing the Corrections BRT program. Staff held two workshops in April 2018 with DOC and corrections officers from jails to develop corrections-specific exercises to help recruits develop good communication skills. These exercises will be placed throughout the corrections basic recruit training program and will increase in difficulty as the academy progresses.

The Commission approved the addition of the Communication Exercises to the corrections Instructor Guide as a field-test for the 2018.07 version. The Commission also approved making the exercises a permanent part of the corrections curriculum in 2019. The revised Instructor Guide will be ready for implementation in July 2018. Academies will not be required to field-test the exercises, but may do so on a voluntary basis.

The Commission previously approved the addition of 50 Communication Exercises that have been added to the law enforcement basic recruit training program. For both the corrections and law enforcement exercises, there will be no hours added to basic recruit training programs, and the exercises will not be audited by FDLE field representatives.





2018 Training Center Directors Workshop







The 20th Annual Training Center Directors Workshop was held at the FDLE Headquarters from May 15 through May 18, 2018. A total of 24 people attended the full workshop with others coming in for specific topic areas. The workshop provided a valuable opportunity for new directors to network and to learn some best practices. The attendees received 28 hours of training that may be used toward their instructor retraining requirements.

The workshop was started in 2002 to provide new training center directors and their staff with training on the rules and requirements related to training center certification, staffing and facilities. Information about officer training, instructor certification and requirements related to the Standards and Training Trust Fund was also provided. To date, a total of 390 directors, coordinators and fiscal agents representing all 40 training schools have attended a workshop. Over the years, the workshop has continued to evolve based on feedback from the participants to provide the most current and relevant information possible.

Planning for the 21st Annual Training Center Directors Workshop has already begun. It is tentatively scheduled for late winter in 2019. Be on the lookout for further information later in the year.
