PURPOSE

The Florida Leadership Academy is specifically designed to provide current first-line supervisors with the knowledge and skills necessary to become effective, first-rate leaders in today's criminal justice environment. The Florida Leadership Academy Application Package is designed to assess the applicant's qualifications through professional accomplishments, academic skills, and leadership abilities. Information provided here will be used as the basis for acceptance into the Florida Leadership Academy.

QUALIFICATIONS

Applicants to the Florida Leadership Academy must:

- Occupy a criminal justice position that includes full-time, permanent responsibility for the supervision of others.
- Currently hold the rank or position of a first-line supervisor that does not oversee other supervisors.
- Show an employment history of increasing leadership responsibilities.
- Have the intent to remain in criminal justice for at least five years following completion of the Leadership Academy.
- Have the written nomination of his/her immediate supervisor indicating the applicant's potential for advancement in criminal justice.
- Have the written endorsement of the agency chief executive pledging their support for the applicant's participation in the program.
- Ability to complete class reading and writing assignments.
- Be able and willing to attend each session, with no more than 12 hours of absences. Each absence will require make-up work to demonstrate an understanding of the missed subject matter.

INSTRUCTIONS FOR COMPLETING THE APPLICATION PACKAGE

*****ALL SECTIONS OF THE APPLICATION MUST BE FULLY COMPLETED TO BE CONSIDERED.**

A completed Florida Leadership Academy application package provides a written assessment of the applicant's current and potential leadership skills, abilities, and accomplishments. It also provides an endorsement of the applicant by his/her supervisor and agency chief executive illustrating their commitment to the program. All sections should be typed or legibly printed. The following is a brief description of each portion of the application package. Please read and follow these instructions carefully.

PART I: NOMINATION

A nominator must provide written support for the applicant to attend the Florida Leadership Academy and sign the nominator statement of commitment. Nominator statements of commitment signed by anyone other than the applicant's immediate supervisor will not be considered. Endorsement statements signed by anyone other than the agency chief executive will not be considered.

PART II: APPLICATION

The applicant must provide information that is relevant to the Florida Leadership Academy. This includes personal information, educational background, training information, skill assessment and professional experience. The applicant must carefully read, and then sign the applicant statement of commitment. Email addresses must be included where requested, as most correspondence prior to and during class will be via email. It is the applicant's responsibility to check their email for class information and updates, failure to do so may result in dismissal from the program.

PART III: LEADERSHIP ESSAYS

This section allows the applicant to elaborate in the form of essays on various aspects of leadership. The leadership essays will be evaluated based on responsiveness to the topic, quality of ideas, and quality of written expression. These essays will be utilized in various units throughout the Florida Leadership Academy.

Your information will not be used for any purpose other than selection into and administration of the Florida Leadership Academy. This material is not, however, exempt from those sections of the Florida Statutes governing disclosure of public documents, and therefore should not be considered confidential.
