### **PURPOSE**

### **QUALIFICATIONS**

## Applicants to the Senior Leadership Program must:

- Occupy a criminal justice management position which includes full-time, permanent supervision of others;
- Currently holds the rank or position of mid-level management; a supervisor of other supervisors (example: Lieutenant, Captain, Major or non-sworn Bureau Commander).
- Occupy a position which influences agency policy or impacts operations of the organization;
- Have the written endorsement of the agency chief executive indicating the applicant's potential for an executive position in criminal justice.

The completed Senior Leadership Program nomination and application package provides a written assessment of the nominee's current and potential executive skills, abilities, and accomplishments. All sections should be typed or printed legibly. The following is a brief description of each portion of the nomination and application package:

### **PART I: NOMINATION**

The nominator must provide written support for the nominee to attend the Senior Leadership Program and sign the nominator statement of commitment. Only nominator statements of commitment signed by the agency chief executive will be considered.

### **PART II: BIOGRAPHY**

The applicant must provide biographical information including educational background, professional experience and personal demographics. The applicant must carefully read and sign the applicant statement of commitment.

## **PART III: LEADERSHIP ESSAYS**

This section allows the nominee to elaborate on various aspects of leadership in the form of brief essays. The leadership essays will be evaluated based on response to the topic, quality of ideas, and quality of written expression.
