Florida Contraband Forfeiture Act Annual Report

Fiscal Year 2022-2023 Reporting Cycle

Pursuant to section 932.7061, Florida Statutes (F.S.), every law enforcement agency shall submit an annual report to the Florida Department of Law Enforcement (FDLE) by December 1, indicating whether the agency has seized or forfeited property under the Florida Contraband Forfeiture Act documenting the receipts and expenditures. The FDLE shall submit an annual report to the Office of Program Policy Analysis and Government Accountability (OPPAGA) compiling the information and data in the annual reports submitted by the law enforcement agencies.

Law Enforcement Agencies:

The FDLE Criminal Justice Professionalism Division, Officer Records Section identified a total of **400** active law enforcement agencies as of October 27, 2023. Of the 400 agencies, 4 agencies were not required to comply with the reporting requirement as they did not exist until after June 2023. A total of **396** agencies were required to comply with section 932.7061, F.S.

One hundred and seventy-seven law enforcement agencies did not submit the agency annual report by the prescribed December 1st deadline.

As required per statute, the 60-day grace period for law enforcement agencies to submit their report expired on February 15, 2024.

Chief Financial Officer Notification:

On February 20, 2024, the FDLE notified the office of the Chief Financial Officer at the Department of Financial Services (DFS) of **thirty-two** law enforcement agencies that failed to submit an annual report by the prescribed deadline in accordance with section 932.7062, F.S. The 2022-2023 reporting cycle was officially closed in the Civil Asset Forfeiture web application on June 25, 2024. As of this date, the following law enforcement agency failed to submit the annual report:

On May 1, 2024, DFS provided a summary of action taken to solicit agency compliance with statute. A summary of action taken against non-compliant agencies was not provided.

Florida Contraband Forfeiture Act Annual Reports

The FDLE received a total of **397** annual reports:

- 249 Police Departments
- 66 Sheriff's Offices
- 38 State Agencies
- 42 Schools and Ports¹
- 2 Correctional

The annual reports received included reports from two agencies not identified in the CJP October 2023 list of active agencies report. The agency is identified below:

- Metropolitan Bureau of Investigation (Agency Type: State Agency) is a multi-agency task force, empowered to conduct narcotics, vice and organized crime investigations across jurisdictional boundaries throughout the Ninth Judicial Circuit (Orange and Osceola Counties). (This is not a law enforcement employing agency; the officers who are part of this task force are certified under Chapter 943, F.S., under their employing law enforcement agency.)
- Florida State Hospital/Agency For Persons With Disabilities – (Agency Type: Correctional) with no sworn personnel.

The FDLE compiled the data² extracted from the law enforcement agencies annual reports. This information is identified in the appendixes by category types.

¹ Schools and Ports: Includes Universities and Colleges; County District School Police Departments; and Airport Police Departments.
