From the Chairman of the Medical Examiners Commission

On behalf of the Medical Examiners Commission, as its Chairman, I am pleased to submit this annual report to Governor Bush and to the Florida Legislature, "*...setting forth the activities and findings of the several district medical examiners*" as required by law. A copy of this annual report is also made available to each Board of County Commissioners, as it is county government that is the sole source of funding for Florida's 24 medical examiner districts.

The Medical Examiners Commission welcomed Polk County Sheriff Grady Judd to the Commission in 2005. Sheriff Judd represents law enforcement concerns on the Commission as provided for by Statute. Sheriff Judd replaces Hamilton County Sheriff J. Harrell Reid who served with distinction since his appointment in 1997.

The Report of Drugs Identified in Deceased Persons continues to be one of the most important and useful tools that our local, state, and federal agencies utilize in the fight against illegal drugs and illegally used prescription drugs. Various groups, from government, law enforcement, and public health to private pharmaceutical manufacturers and drug recovery agencies continue to rely on the analysis and profiles of drug use enumerated in this report to allocate increasingly scarce resources toward prevention, education, treatment, and even new legislation.

Perhaps the most unheralded successes that Florida's Medical Examiners can claim again for 2005 are their accomplishments in concert with the state's four (4) federally-mandated Organ Procurement Organizations. There have been no denials by medical examiners for permission to proceed with the wishes of the decedent's next-of-kin in organ procurement from appropriate donors whose deaths fall under medical examiner jurisdiction. The close coordination between these two professional groups has allowed for maximum procurements and transplantations to occur while the medical examiner fulfills his or her Statutorily-mandated duties. With the ever-increasing demand for organ transplants, Florida's medical examiners can be proud of their national leadership in this timely issue of importance to those in desperate need of these life saving gifts.

INTRODUCTION

The Medical Examiners Act, Chapter 406 Part I, Florida Statutes, was enacted by the 1970 Legislature in order to establish minimum and uniform standards of excellence in statewide medical examiner services. Section 406.02(4)(a), Florida Statutes, requires a report to the Governor and to the Legislature correlating and setting forth the activities and findings of the district medical examiners. This report is submitted in compliance with the requirement cited above and illustrates the direction taken by the Medical Examiners Commission during 2005 to assure the maintenance of an effective and viable program of medical examiner services throughout Florida.

SUMMARY

Medical examiners in Florida continue to have at least some level of oversight over approximately two-thirds of the deaths in Florida (See Charts 1a and 1b). Of the approximately 172,000 deaths in the State of Florida in 2005, 108,918 Florida deaths came under medical examiner jurisdiction. While most of these (86,323 deaths or approximately 79%) were for the review of cremation requests, medical examiners accepted jurisdiction pursuant to Florida Statutes of 22,595 deaths. Forensic autopsies were performed on 16,864 individuals before the death certificate was signed by the medical examiner.

The manner of death (See Table 1A) is a very important determination that is made by the medical examiner. Natural deaths accounted for 39% of the caseload of medical examiners, followed by 26% for non-motor vehicular accidents and 17% for motor vehicular accidents. Suicides, homicides, and undetermined/pending accounted for the remainder at 10%, 5%, and 3% respectively of the cases accepted by medical examiners.

The workload of medical examiner offices continues its increase in Florida in recent years as can be seen in Chart V. Increasingly, cremation has become a more frequent means of final disposition for bodies in Florida and, accordingly, their review and approval by medical examiners have increased. Although the percentage of medical examiner jurisdiction cases accepted has decreased in relation to Florida's increasing population, the actual numbers have increased, leading to an ever increasing number of autopsies and cremation approvals in recent years.

COMMISSION APPOINTMENTS AND REAPPOINTMENTS

Mr. Bob Dillinger was reappointed in 2005 to a second four-year term to his position on the Commission as the representative for the Public Defenders of Florida. In 1996, Mr. Dillinger was elected as Public Defender for the Sixth Judicial Circuit and he was reelected in 2000 and 2004. Mr. Dillinger has thirty years of experience in practicing law.

Sheriff Grady C. Judd of Polk County was newly appointed to the Commission in August of 2005 to represent the law enforcement concerns in the State of Florida. Sheriff Judd has been with the Polk County Sheriff's Office since 1972 and was elected as Sheriff in 2004. Sheriff Judd replaced former representative, Sheriff J. Harrell Reid, who completed two full terms on the Commission in July of 2005.

DISTRICT MEDICAL EXAMINER APPOINTMENTS AND REAPPOINTMENTS

In 2005, the District Medical Examiners from Districts 16, 17, 18, 19, 20, 21, 22 and 23, were reappointed by the Governor for additional three-year terms:

DISTRICT 15

Dr. Michael D. Bell was chosen as the District 15 Medical Examiner as of March 1, 2005. The vacancy occurred as the result of Dr. Lisa M. Flannagan's resignation in February of 2005 and her relocation to join Dr. David T. Stewart in Tallahassee. Palm Beach County exercised Home Rule authority for its appointment, thus they did not seek a gubernatorial appointment.

PROBABLE CAUSE PANEL

A complaint was submitted to the Commission against Dr. Jesse C. Giles, AME from District 4, for not gathering enough medical history to make an informed decision as to whether or not to accept jurisdiction in a case. The Panel found Probable Cause and recommended to the Commission a written reprimand be issued. The Commission agreed and Dr. Giles accepted the written reprimand.

VIOLENT CRIME AND DRUG CONTROL COUNCIL (VCDCC)

The Violent Crime and Drug Control Council is composed of fourteen members, one of whom is the medical examiner representative, Dr. Margarita Arruza (District 4). The Council is routinely briefed on the annual and semi-annual Medical Examiners reports regarding drug-related deaths.

In 2005, the funding provided by the VCDCC was especially important to the investigative efforts of three (3) high-profile cases – 1) the Sarah Lunde abduction/homicide; 2) the Jessica Lunsford abduction/homicide; and 3) the Marianna Quadruple Homicide wherein Danielle Baker and her three children were brutally murdered. Without funds granted by the Council, local agencies would be fiscally overburdened when engaged in these types of investigations. During the past 12 years, the Council has provided either partial or full funding for investigations or trials of many high profile cases. The funds for this came from the Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account. From January 1, 2005 to December 31, 2005, the Council funded 22 violent crime cases to 14 agencies totaling \$524,829. It also funded 25 matching drug control and illicit money laundering investigations to 20 lead agencies and nearly 44 participating agencies totaling \$2,143,214. These cases resulted in the dismantling of over a dozen major drug trafficking organizations, hundreds of arrests, significant seizures of weapons and drugs including cocaine, marijuana, heroin, MDMA, methamphetamine, and prescription drugs. The Council also funded 32 victim/witness protection cases to nine (9) agencies totaling \$141,500.

STATE CHILD ABUSE DEATH REVIEW TEAM

Associate Medical Examiner Dr. Barbara Wolf from District 21 is the Commission's representative on the Florida Child Abuse Death Review Team. This Committee is administered by the Florida Department of Health and utilizes state and local multidisciplinary teams to conduct detailed reviews of the facts and circumstances surrounding child abuse and neglect deaths. Due to a statute change, in 2005 the committee began to review all cases of child abuse or neglect related deaths verified by the Department of Children and Families, regardless of whether there had been a prior report to DCF. This expanded mission necessitated a greater involvement of local review teams. The State Team conducted numerous training sessions and sanctioned 12 new local teams in 2005, for a total of 20 local teams around the state. Three additional local teams are expected to be sanctioned early in 2006. This effort was assisted by the Florida Legislature's reinstatement of the statute that provided confidentiality protection, enabling the teams to review sensitive materials related to a child's death.

In 2005, the State Team performed case reviews on the 108 deaths, out of a total of 2,722 child deaths in Florida during 2004. In 48 of these cases (44%) there had been at least one prior report of abuse or neglect filed with DCF. Neglect deaths comprised 56% of the cases, while 44% were due to abuse. Systemic issues were identified in specific cases and in Florida's child protection system. Ninety-four (87%) of the 108 deaths reviewed were determined to have been preventable.

The majority of abuse related deaths were due to direct physical trauma. Of the neglect related deaths, 22 were due to drowning, 10 were due to hyperthermia when children were left in cars and 10 were related to unsafe sleeping environments. The State Team recommended prevention education to increase public awareness of these issues, and will spearhead training efforts.

The State Team additionally recommended that Florida statutes be amended to provide for review of all child deaths throughout the state.

ORGAN AND TISSUE PROCUREMENT AND TRANSPLANTATION ADVISORY BOARD

Dr. Bruce Hyma (District 11) was the Commission's representative on the Organ and Tissue Procurement and Transplantation Advisory Board which is housed in Florida's Agency for Health Care Administration (AHCA). This board did not meet in 2005.

ANNUAL EDUCATIONAL CONFERENCE

The 32nd Annual Educational Conference was held on Biscayne Bay at the Sonesta Key Resort. The conference was hosted by Dr. Bruce Hyma, the staff of the District 11 Medical Examiner's Office, and Dr. Bruce Goldberger of The William R. Maples Center for Forensic Medicine. The theme for the conference was *21st Century CSI Technology and Death Investigation*. The program consisted of a wide variety of very interesting and informative lectures ranging from new technology in death investigations to mass fatality response, and some fresh insights into motor vehicle and scuba fatality investigations.

METHODOLOGY

Death numbers in Florida reflect the total number of Certificates of Death recorded in 2005 by local county registrars of Vital Statistics. These include both resident and non-resident deaths. This data was obtained from the Office of Vital Statistics in the Department of Health. Rates related to deaths in this report are medical examiner cases per every one thousand recorded deaths.

Population estimates (as of April 1, 2005) for the State of Florida were provided by the Finance & Economic Analysis Section of the Executive Office of the Governor. Unless otherwise noted, rates related to population in this report are deaths for every one thousand residents.

Information concerning autopsy numbers and other workload distribution figures are supplied by the twenty-four medical examiner districts in their Annual Report Workload Data Forms. These forms are filed annually with the Medical Examiners Commission staff in April or May of each year. (See Tables I and I-A).



Total Deaths Reviewed: 122,572



Total Florida Deaths 172,251



Total Violent Deaths - 13,829










Workload by Depth of Examinations - Homicide




Chart IVb
Workload by Depth of Examinations - Suicide



Workload by Depth of Examinations - Undetermined



Workload by Depth of Examinations - Accident: Motor Vehicle



Workload by Depth of Examinations - Accident: Non-Motor Vehicle



Workload by Depth of Examinations - Natural





