
From the Chairman of the Medical Examiners Commission

On behalf of the Medical Examiners Commission, as its Chairman, I am pleased to submit this annual report to each of our district medical examiners. While the Medical Examiners Commission is no longer required to submit an Annual Workload Report to the Governor and Legislature, it was decided that we would continue to submit this report to the districts as it provides valuable information.

The Medical Examiners Commission welcomed the Honorable Robert Peryam, Monroe County Sheriff, and the Honorable Jerry Hill, State Attorney, 10th Judicial Circuit, to the Commission. Sheriff Peryam replaces Polk County Sheriff Grady Judd, while Mr. Hill completes the term for Mark Kohl, former State Attorney for the 16th Judicial Circuit.

The Report of Drugs Identified in Deceased Persons continues to include highly sought after information. This unique report continues to display the unfortunate yet increasing abuse of both prescription and illicit drugs. Furthermore, the report assists Florida's state and local agencies in allocating and focusing its resources. We are now in the second year of electronic submission of data for the Annual Drug Report, and this has streamlined the reporting process considerably.

The Medical Examiners Commission continued in a joint initiative to identify unidentified deceased cases in Florida. The Florida Department of Law Enforcement and the 24 medical examiner districts are working together to resolve more than 700 unidentified deceased cases reported in our state. With new technology and advances in forensic science, the initiative is constantly evolving. This Commission will continue to encourage participation and provide access to resources to reduce the backlog of cases.

INTRODUCTION

The Medical Examiners Act, Chapter 406, Part I, Florida Statutes, was enacted by the 1970 Legislature in order to establish minimum and uniform standards of excellence in statewide medical examiner services. This report is submitted in order to illustrate the direction taken by the Medical Examiners Commission during 2010 to ensure the maintenance of an effective and viable program of medical examiner services throughout Florida.

SUMMARY

Medical examiners in Florida continue to have oversight over approximately two-thirds of the deaths in Florida (See Charts Ia and Ib). Of the 175,161 deaths in the state of Florida in 2010, 124,897 deaths came under medical examiner jurisdiction. While most of these (102,751 deaths or approximately 82 percent) were for the review of cremation requests, medical examiners accepted jurisdiction of 22,146 (17.7 percent) deaths, pursuant to Florida Statutes. Forensic autopsies were performed on 15,607 individuals before the death certificate was signed by the medical examiner.

The manner of death (See Table Ia) is a very important determination that is made by the medical examiner. Natural deaths accounted for 36 percent of the caseload of medical examiners, followed by 31 percent for non-motor vehicular accidents and 13 percent for motor vehicular accidents. Suicides, homicides, and undetermined/pending accounted for the remainder at 13 percent, five percent, and two percent respectively of the cases accepted by medical examiners.

The workload of medical examiner offices in Florida slightly increased when compared with 2009 (See Chart V). Cremation has become a frequent means of final disposition for bodies in Florida and, accordingly, their review and approval by medical examiners have increased.

COMMISSION APPOINTMENTS AND VACANCIES

Monroe County Sheriff Robert Peryam was appointed to the Commission by Governor Crist in August 2010. Sheriff Peryam represents the law enforcement concerns in the state of Florida.

Jerry Hill, J.D., was appointed by Governor Crist to the Commission in October 2010. Mr. Hill represents State Attorneys' concerns in the state of Florida.

MEDICAL EXAMINER DISTRICTS 8-14

In 2010, the Commission recommended that the District Medical Examiners from Districts 8, 9, 10, 12 and 14 be reappointed by the Governor for additional three-year terms. The following districts were awaiting reappointment by the Governor's Office at the end of 2010:

District 8:	William F. Hamilton, M.D.

Surveys were sent to the constituents of Districts 11 and 13 for information only as those districts fall under a Home Rule Charter. Bruce A. Hyma, M.D., of District 11 (Miami-Dade County) and Vernard I. Adams, M.D., District 13, continued as the District Medical Examiner for their districts.

Surveys were also sent to the constituents of District 3 for information only as that district is cross-covered by Districts 2, 4, and 8.

IN MEMORIUM

Wallace Morris Graves, M.D., passed away on January 12, 2010. He is survived by his wife, four children and nine grandchildren.

Dr. Graves began his forensic pathology career as an associate medical examiner for District 20 in 1972. In 1973, he became the District 21 Medical Examiner, where he remained until 1996. Dr. Graves began his 20 year tenure on the Medical Examiners Commission in 1974 and was elected Chairman of the Commission in 1979.

Thomas Hegert, M.D., died on August 29, 2010. Dr. Hegert was the District 9 Medical Examiner from 1972 through 1995. He was also a member of the pathology faculty at the Orange County Regional Medical Center, where he taught autopsy pathology to the anatomic pathology residents.

STATE ADMINISTRATIVE CODE, RULE 11G

In 2010, the Commission recommended major revisions to Rule 11G, in part to delete redundancies between the Rule and Chapter 406, F.S. These recommended revisions have been forwarded for promulgation.

DISCIPLINARY ACTIONS

In 2010, Commission staff received 12 formal written complaints against district medical examiners or their associate medical examiners. Most of these complaints alleged misconduct regarding the findings of cause and/or manner of death, with one alleging failure to provide “reasonable care.” Eleven of these cases were found by staff to be not legally sufficient, while one case was found to be not legally sufficient by a Probable Cause Panel.

VIOLENT CRIME AND DRUG CONTROL COUNCIL

Through existing partnerships with federal, state, and local law enforcement, the Violent Crime and Drug Control Council (VCDCC) continues to play an integral role in supporting initiatives to protect Florida’s citizens, visitors, property and communities. Since the Council’s inception in 1993, it has maintained a reputation for initiating and supporting legislation to improve the overall quality of life for the state of Florida and its citizens. The Council is composed of 14 members, including a medical examiner representative, which has been vacant awaiting gubernatorial appointment since 2007. The Council is routinely briefed on the Medical Examiners’ semi-annual and annual reports regarding drug-related deaths.

STATE CHILD FATALITY REVIEW COMMITTEE

The State Child Fatality Review Committee reviewed 192 cases in 2010, representing deaths that occurred in 2009 of infants and children less than 18 years of age that had been verified by the Department of Children and Families (DCF) as being related to child abuse or neglect. Children five years old and younger comprised 84 percent of the cases reviewed. In 69 cases (36 percent), the child had previous involvement with DCF, and 14 (17 percent) of the child death cases had an open report at the time of the child’s death.

Florida’s data continues to parallel national statistics that indicate a prevalence of neglect-related deaths. Out of 192 deaths, 27 percent were abuse-related, while 73 percent were neglect related. There were 112 deaths classified as accidental. Drowning continued to be a major cause of accidental child deaths in Florida with 31 percent of accidental deaths caused by drowning. There was an increase in the recognition of infant deaths related to the child’s sleep environment, with 42 deaths attributed to unsafe sleeping conditions.

Three children died in motor vehicle crashes. Nine children died of hyperthermia after having been left unattended in a vehicle. This was a significant increase from the three deaths of children left in vehicles in 2008; however it is believed the media attention given to these deaths and to related criminal prosecutions continues to work towards

reducing this type of death. Ten of the deaths were classified as homicides. Of these homicides, 93 percent were children under the age of five years old.

The Committee's 2010 key recommendations were:

#1 Review All Child Deaths - Amend §383.402 (1), F. S to expand the State Child Abuse Death Review Committee's authority related to the review of child deaths in Florida to have a better understanding of why children die in Florida.

#2 Fully Fund Healthy Families Florida - Support the Department of Children and Families, 2011-12 Legislative Budget Request to restore Healthy Families Florida funding to the 2009-10 funding Level.

#3 Prioritize Assessment of Substance Abuse in Child Abuse and Neglect Cases - Substance abuse and the illegal or excessive use of alcohol or drugs should be strongly considered when evaluating and investigating all cases of child abuse and neglect. The presence of substance abuse should also be given a higher priority in the risk assessment activities of child protection organizations that come into contact with children and their families.

The Committee also recommended the continuation of training professionals and parents in unsafe sleeping environments, drowning prevention and investigations, coping with crying, the role of substance abuse, and death scene investigations.

Barbara C. Wolf, M.D., Interim District 5 Medical Examiner represents the Medical Examiners Commission on this committee.

ANNUAL EDUCATIONAL CONFERENCE

The 37th Annual Educational Conference was held in Orlando at the Ritz-Carlton. The conference was hosted by the District 9 (Orange and Osceola Counties) Medical Examiners Office and the University of Florida William R. Maples Center for Forensic Medicine.

METHODOLOGY

Death statistics in Florida reflect the total number of Certificates of Death recorded in 2010 by local county registrars of Vital Statistics. These include both resident and non-resident deaths. This data was obtained from the Office of Vital Statistics of the Department of Health. Rates related to deaths in this report are medical examiner cases per every 1,000 recorded deaths.

Population estimates (as of April 1, 2010) for the state of Florida were provided by the Finance & Economic Analysis Section of the Executive Office of the Governor. Unless

otherwise noted, rates related to population in this report are deaths for every 100,000 residents.

Information concerning autopsy numbers and other workload distribution figures are supplied by the 24 medical examiner districts in their Annual Report Workload Data Forms. These forms are filed annually with the Medical Examiners Commission staff in July of the next year. (See Tables I and Ia.)



Total Deaths Reviewed: 141,178



Total Florida Deaths: 175,161













Chart V


